



#### **Site Location and Description**

The site is located in Coomie Lane off Main Street in Arklow Town Centre. The subject unit forms part of a retail/office terrace with a parking area to the rear (north).

#### Question

The applicants have applied to see whether or not the following is or is not development and is or is not exempted development:

- The provision of an art mural at the Arklow Youth Centre, Coomie Lane, Arklow, Co. Wicklow.

#### **Planning History**

09610051 – **PERMISSION GRANTED** for change of use from office use (ref 07/149) to Youth Training Office. The unit will comprise office space for admin., youth workers & counselling staff, open plan meeting area, training and leisure activities and seating area with kitchen. The Youth Centre will be managed by Wicklow VEC in conjunction with Youth Service Providers

00610169 – **PERMISSION GRANTED** for full planning permission requested for the erection of 2 No. two storey apartments including parking spaces and connection to services

#### **Relevant Legislation**

**Section 2(1)** of the Act states the following in respect of the following:

"structure" means any building, structure, excavation, or other thing constructed or made on, in or under any land, or any part of a structure so defined, and—

(a) where the context so admits, includes the land on, in or under which the structure is situate, and

"works" includes Any act or operation of construction, excavation, demolition, extension, alteration, repair or renewal..."

#### Section 3(1) of the Act states the following in respect of 'development':

"In this Act, 'development' means, except where the context otherwise requires, the carrying out of any works on, in, over or under land or the making of any material change in the use of any structures or other land."

**Section 4** sets out the types of works that while considered 'development', can be considered 'exempted development' for the purposes of the Act.

#### **Section 4 (1) (h)** is relevant for the purposes of this declaration:

"development consisting of the carrying out of works for the maintenance, improvement or other alteration of any structure, being works which affect only the interior of the structure or which do not materially affect the external appearance of the structure so as to render the appearance inconsistent with the character of the structure or of neighbouring structures."

**Section 4(2)** makes provision for ministerial regulations to set out further exemptions. The 2001 Planning Regulations as amended derive from this section and designate further works as being exempted development for the purposes of the act.

# <u>Planning and Development Regulations 2001(as amended)</u> Article 6 (1):

Subject to Article 9, development of a class specified in column 1 of Part 1 of Schedule 2 shall be exempted development for the purposes of the Act, provided that such development complies with the conditions and limitations specified in column 2 of the said Part 1 opposite the mention of that class in the said column 1.

#### Article 9 (1):

Development to which article 6 relates shall not be exempted development for the purposes of the Act—

- (a) If the carrying out of such development would -
- (i) Contravene a condition attached to a permission under Act or be inconsistent with any use specified in a permission under the Act,
- (ii) consist of or comprise the formation, laying out or material widening of a means of access to a public road the surfaced carriageway of which exceeds 4 metres in width,

(iii) Endanger public safety by reason of traffic hazard or obstruction of road users,

#### Schedule 2: Part 1

Class 12

The painting of any external part of any building or other structure.

#### **Limitations**

Such painting may not, except in the case of a hoarding or other temporary structure bounding land on which development consisting of works is being or will be carried out in pursuance of a permission granted under Part III of the Act or as exempted development, be for the purposes of creating a mural.

#### Conclusion

Class 12 does not include murals as exempted development. No other class is applicable.

#### Other Legislation

#### Public Art Mural (Exempted Development) Bill 2023

Bill entitled an Act to amend Planning and Development Regulations, 2001 (S.I. No. 600 of 2001) to provide for exemptions from planning permission for certain categories of public art murals where such work has artistic or cultural merit, has the permission of the owner of the building or structure on which it is displayed, is not a commercial advertisement and does not conflict with the Equal Status Acts.

#### Conclusion

This Public Art Mural (Exempted Development) Bill has not been enacted.

#### **Assessment**

The declaration queries whether the installation of an art mural at the Arklow Youth Centre is or is not exempted development.

<u>"works"</u> includes any act or operation of construction, excavation, demolition, extension, alteration, repair or renewal and, in relation to a protected structure or proposed protected structure, includes any act or operation involving the <u>application or removal of plaster</u>, paint, wallpaper, tiles or other <u>material to or from the surfaces of the interior or exterior of a structure</u>.

The Planning Authority is satisfied that the proposal would involve <u>works</u> and therefore the proposal does constitute development.

Class 12 under Part 1: Schedule 2 of the Planning and Development Regulations 2001 (as amended) <u>excludes</u> art murals as exempted development and therefore, the proposed development **does not constitute exempted development**.

Having regard to Article 9(1)(a) of the Planning and Development Regulations 2001 (as amended), I note that the carrying out of the development as described would not contravene a condition attached to any relevant planning permissions on the subject property or fall within any of the other restrictions within this article.

#### Recommendation:

With respect to the query under Section 5 of the Planning and Development Act 2000 (as amended), as to whether

the provision of an installation of an art mural at the Arklow Youth Centre is or is not exempted development within the meaning of the Planning and Development Act, 2000 (as amended).

The provision of an art mural at the Arklow Youth Centre, Arklow, Co. Wicklow is Development and is Not Exempted Development.

#### B. Land Reclamation -

Note in addition to confirmation of exemption status under the Planning and Development Act 2000( as amended) there is a certification process with respect to land reclamation works as set out under the European Communities (Environmental Impact Assessment) (Agriculture) Regulations 2011 S.I. 456 of 2011. 
