Request for Suspension of Standing Orders:- The Meetings Administrator advised that a request for suspension of standing orders had been submitted in advance of the meeting. In accordance with the protocol adopted the request was read to the meeting as proposed and seconded:-

Cllr. M. Kavanagh, seconded by Cllr. P. Leonard and supported by Cllr. T. Fortune and Cllr. J. Behan, requested a suspension of standing orders to discuss the following:

"That the Members of Wicklow County Council object strenuously to the Coillte decision to partner with a UK based Investment Fund, Gresham House, in the purchase by this Fund of thousands of hectares of Irish forestry lands depriving the Irish people of the profits accruing and at the same time driving up the price of agricultural land which could be bought by Irish farmers. Furthermore, this Council calls on the Government to halt this arrangement immediately and ensure that the future ownership of Irish Forestry assets remains in the hands of the Irish People."

It was agreed by all to have a discussion on the topic at 4.30 p.m.

The Committee will continue to monitor and review the Risk Registers as they are updated following quarterly review by directorates and senior management team. It was noted by the Audit Committee of their responsibility to ensure that the Council has a robust process is in place for maintaining updated risk registers.

At the conclusion of the presentation, the Chief Executive joined with the Cathaoirleach in thanking the Audit Committee for the work that they carry out for the council describing their work as extremely important and thorough.

To enter into a Section 85 Agreement for the provision of Social Housing via a Public Private Partnership – Bundle 5 of the National Social Housing PPP Programme.

Prior to discussing Item 6, Cllr. A. Flynn-Kennedy advised she worked for an approved housing body and excused herself from the meeting.

Cllr. J. Behan proposed an amendment, seconded by Cllr. P. Leonard 'That Wicklow County Council designs, builds, finances, maintains and operates social and affordable housing schemes in the Burnaby in Greystones and Rehills Land in Bray in fulfilment of its usual role as the Housing Authority for the County of Wicklow.

Furthermore, that Wicklow County Council rejects the Section 85 Agreement proposed by the Chief Executive to hand over the above housing functions on the above two sites to a Public Private Partnership Company facilitated by Dublin City Council'.

Ms. L. Gallagher, Director of Services, and Ms. H. Purcell, Senior Executive Officer advised, in accordance with Standing Orders, item 18 (d) 'An amendment shall not be in order if it is

equivalent to a direct negative or if it is not in fact an amendment if the motion it purports to amend'

Mr. J. Lane, Director of Services updated the Elected Members in relation to the Section 85.

Following a broad discussion relating to the provision of housing, allocation of houses, ownership of properties and units, a vote was taken to enter into a Section 85 Agreement for the provision of Social Housing via a Public Private Partnership – Bundle 5 of the National Social Housing PPP Programme and following a roll call was passed by a margin of 24 for, 4 against and 4 not present viz:-

Cllr. Flynn-Kennedy was invited to rejoin the meeting which she duly did.

ITEM NO. 7

To consider and adopt Speed Limit Byelaws for County Wicklow.

Ms. L. Earls, Director of Services gave a presentation outlining the background and context to the speed limit bye-laws as follows:

- Local authorities required to review speed limit byelaws on a 5 yearly basis.
- Reasons- Safety, Traffic Management, Education, Enforcement.
- Speed limits are set by default and can only be changed on a permanent basis, by the making of speed bye-laws. Limits can be fixed, variable or periodic.
- Default speed limits are specified in the Road Traffic Act 2004.
- Special Speed Limit Bye-Laws- Road Traffic Act 2004 & Local Govt Act 2001 (as amended) ? Reserved function of Members.

Default speed limits apply to the following:-

- Built up areas -50km, Regional & local roads 2 80km.
- 2 National roads 2 100km, Motorways 2 120km

Special speed limits are specified in accordance with the guidelines 'Setting & Managing speed limits in Ireland'.

set out in guidelines.

- 50km for built up areas, 60km, 80km for motorway, national road or built up area, 100km for motorway/no urban or regional/local road/built up area and 120km dual carriageway.
- Predraft consultation undertaken during 2021/2022 with Members, An Garda Siochana, District Engineers, adjoining LAs and TII.
- A schedule of proposed amendments issued to all Members in early 2022 for their review and consideration, with presentations made to all districts.
- Public consultation undertaken in Oct/Nov 2022.
- 257 submissions received.
- Further engagement with Members in relation to the submissions in December 2022.
- Briefing session with Members in January.
- Individual engagement in recent days.
- Draft Bye-Laws circulated provided for 13 schedules:-
- 1st schedule Default Built up Areas speed limit -50km.
- 2nd schedule- special speed limit 20km no roads.
- 3rd schedule- special speed limit 30km.
- 4th schedule- special speed limit 40km 2 no roads.
- 5th schedule- special speed limit 50km.
- 6th schedule- special speed limit.
- 7th schedule-special speed limit -80km.
- 8th schedule- special speed limit 100km.
- 9th schedule- special speed limit 120km.
- 10th schedule- special periodic speed limit 20km- no roads.
- 11th schedule- special periodic speed limit 30km.
- 12th schedule- special periodic speed limit 40km- no roads.
- 13th schedule 2 special periodic speed limit 50km 2 no roads.
- Consider the adoption of the draft bye-law, with or without amendment.
- If adopted there will be two dates for them coming into operation:-
- 1st June all speed limits with exception of periodic speed limits at school.
- 1st August periodic speed limits at schools.
- Appeal process now in place.
- Draft Speed Limit Review Special Speed Limit Bye-Laws.
- Questions and Answers.
- Consider adoption of Bye-Laws.

There followed a broad discussion in which the Elected Members raised questions which were responded to by Ms. L. Earls and Mr. B. O'Sullivan.

It was proposed by Cllr. S. Cullen, seconded by Cllr. A. Flynn-Kennedy and following a roll call it was agreed to adopt Speed Limit Byelaws for County Wicklow to include Councillor Amendments as circulated plus amendment cc Kilmacanogue National School by a margin of 26 votes for and 6 not present viz:-

ITEM NO. 11

To note Circulars LG01/2023 Annual Declarations and Public Registers and FO1 – 2023 31st January 2023 deadline for the reporting of political donations b Elected Members.

Ms. H. Purcell advised the Elected Members of the following:

- Reporting requirements due for 2023 are unchanged from those that applied in 2022.
- Ensure that Elected Members complies with circular.
- In relation to LG01/2023 Annual Declarations and Public Register, Minister for Housing, Local Government & Heritage wishes to remind local authorities of the requirement, the ethical framework for Local Government as set out under Part 15 of the Local Government Act 2001.
- Employees and Elected Members are required to fill out annual declaration forms and the return period for submitting completed annual declaration to the Ethics Registrar is the last day of February each year.
- It should also be noted that the prescribed annual declaration form, includes a section for a person signing off to declare that they have read and understood the Code of Conduct for councillors as well as undertaking to have regard to it and be guided by the relevant Code of Conduct in his or her exercise of their functions.
