Section 10 of the Local Government (No. 2) Act, 1960, as substituted as aforesaid, shall, on the 27th May, 2021 vest in the local authority in fee NOW THEREFORE the local authority in exercise of the powers conferred upon them by section 81 of the Housing Act, 1966, as applied by simple free from encumbrances and all estates, rights, titles and interests of whatsoever kind (other than any public right of way).
