
# Swan River Greenway

#### **Oldcourt Area**

- Well established residential area close to Bray Town Centre
- Close to local amenities; schools, shops, businesses, sports clubs
- Rich in biodiversity
- Rich in heritage



### Why Consider the Project?

- The woodlands and open space along the Swan River provides a valuable natural resource for the Oldcourt Area. The area is rich in biodiversity, heritage and amenity value.
- Much of this area is difficult to access and lacks safe linkage into the surrounding housing developments.
- Bray suffers from traffic congestion particularly during school drop-off and collection times.
- Opportunity to develop a scheme that benefits the residents of Oldcourt and surrounding areas.










#### Why Consider the Project?

#### Why Consider the Project?

• NTA's Greater Dublin Area Cycle Network Plan identified a possible greenway route along Swan River.





#### What is the Aim of the Project?

- Design a scheme that significantly enhances pedestrian and cycle connectivity to schools, employment, shops and public transport.
- Provide high quality pedestrian and cycle facilities which will encourage and facilitate a modal shift away from car usage to more sustainable modes of transport such as walking and cycling.
- Design a scheme that has a positive impact on the public realm and helps to promote social integration and community development.
- Design a scheme that is sensitive to the biodiversity and cultural heritage in the area.
- Promote a shift towards a low-carbon, climate resilient and environmentally sustainable economy.

- Stage 4 Statutory Approval Process
- Stage 5 Detail Design & Procurement of Contractor

- Stage 7 Project Close-Out





#### How will the Project be Funded?

- Wicklow County Council applied for funding through the National Transport Authority's Sustainable Transport Measures Grant Scheme.
- The NTA have approved funding for Concept Development and Option Selection Stage.
- Wicklow County Council will continue to work with the NTA to progress the project through all stages.
