# Arklow's Strategic Importance

The expanding economic growth and unfolding opportunities position Arklow as the most strategically significant town on Ireland's East Coast. This point in time offers a prime opportunity to harness this potential. The plan must encompass a vision for the forthcoming decades, adeptly managing expected growth while ensuring inclusivity and benefits for all sectors of society.

## **Arklow's Economic Evolution**

#### **Historical Roots**

Arklow, a town steeped in industrial and maritime heritage, owes its significance to its strategic location along the Avoca River. The town played a vital role in trade and fishing, with copper ore from Wicklow mines being shipped during the summer season. Notably, Arklow shipbuilders, John Tyrrell & Sons, pioneered the construction of the first motor fisherboat in the British Isles, exporting pre-packed fishing vessels to distant shores.

In 1895, Kynoch Ltd acquired Arklow Chemical Works, spanning over 300 acres along North Beach. During World War I, this facility employed a staggering 4,000 people. Additionally, Arklow Pottery, established in 1934, remained an economic pillar for six decades. Meanwhile, Nitrigin Éireann Teoranta (N.E.T.) took root in Shelton during the early 1960s.

## Present Landscape and Potential

Arklow's industrial landscape is diverse, housing enterprises of varying sizes across sectors such as Pharmaceuticals, Maritime, Administration, Extractive, and Manufacturing. Recent years have witnessed remarkable growth, both in emerging and established industries. Companies like LMH Engineering and NUA Manufacturing have spearheaded this industrial success.

The renewable energy sector is also on the rise, with SSE Renewables' Arklow Bank Wind Park leading the charge. This ambitious project aims to develop an 800MW offshore wind farm known as Arklow Bank Wind Park II, driving the transition toward sustainability.

Furthermore, Echelon Data Centres provide essential data infrastructure while maintaining an environmentally conscious approach. Their imminent major announcement sets a new standard for zero carbon emissions for the industry, positioning Arklow as a preferred location for global tech giants.

Cumulatively, these industries are projected to inject over €8 billion into the local economy. During the development phase, approximately 2,500/3,000 construction jobs will be created, followed by over a 1,000 permanent positions upon project completion. This economic upswing reflects not only job growth but also a commitment to sustainable innovation within the region.

# **Future Potential**

Arklow is poised to enter a transformative era, fuelled by significant government policy reviews that beckon a broader vision to seize emerging opportunities.

The Department of Transport's review of the 2013 National Ports Policy if opens the door to enhancing Arklow's strategic importance through the establishment of a deep-water port. This alignment gains further weight from the Dublin Port Post 2040 Dialogue<sup>iii</sup>, which identifies Arklow as a potential port location. Stakeholders have also submitted a detailed proposal to support this vision.

Simultaneously, the *Commission for Regulation of Utilities (CRU)* is reevaluating its policy on connections for Large Energy Users. This includes a forward-thinking approach advocating placing these users near zones rich in renewable energy sources and storage capabilities. Arklow has a substantial strategic advantage in meeting to these requirements.

Arklow's imminent tourism transformation owes much to the upcoming wastewater treatment plant and flood defences. These enhancements will harness its maritime heritage and pristine river, offering unique experiences.

The revival of the river Avoca will illuminate Arklow's seafaring history. Clean waters will facilitate kayaking, fishing, and birdwatching, attracting nature enthusiasts and adventure seekers, enriching the tourist experience. The river's transformation will also give rise to riverside dining and accommodation, creating a vibrant hub for both locals and visitors.

Backed by purposeful economic growth, Arklow's revitalisation can serve as a beacon of optimism for a brighter future. It exemplifies how targeted funding and strategic planning can uplift every facet of the community, setting a benchmark for others to emulate. As Arklow advances, it must embrace the commitment to foster a wealthier, fairer, and greener society for generations to come, guided by a far-sighted vision.
