#### **Active Travel Investment Grants**

Wicklow County Council welcomes €9 million in Active Travel Investment Grants for our County.

This 2022 allocation provides for approximately 58 projects throughout the county - making walking and cycling in our villages and towns safe and sustainable. The Active Travel Scheme promotes awareness and uptake of travelling with a purpose, using your own energy by means of walking or cycling. Wicklow County Council are committed to investing in these projects and connecting our communities.

Wicklow County Council will continue to liaise with our NTA partners to deliver on this ambitious programme throughout 2022.

#### **Grant Allocations for National Roads**

Transport Infrastructure Ireland (TII) has issued details of 2022 grant allocations for national roads to Wicklow County Council. The total allocated funding for 2022 maintenance and improvement works on national roads in County Wicklow amounts to €2,958,526.

The N11M11 Junction 4 to Junction 14 Improvement Scheme concluded Phase 2 Options Selection in 2021 and was due to proceed with Phase 3 Design and Environmental Evaluation in 2022. Progress to Phase 4 Statutory Processes was anticipated in early 2023. A grant allocation in the region of €3m has been spent on N11M11 Junction 4 to Junction 14 Main Improvement Scheme to date.

In addition, Transport Infrastructure Ireland became the Approving Authority for Greenways as of 20 September 2021, a role previously performed by the Department of Transport. Accordingly, a separate allocation is being provided by TII for funding of Greenways in 2022 in the amount €5.35m specifically for Blessington and Greystones to Wicklow Greenways projects.

#### €1 million in funding for Blessington

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF), which will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway.

This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance the Blessington as a place to visit.

Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills, and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

It is likely that 3 Part V units and 4 Turnkey units will be delivered early in 2022

#### **Potential units**

Wicklow County Council currently has agreements in place for 43 units in Delgany, Bray, Rathnew, Wicklow, Baltinglass, Dunlavin and Enniskerry with delivery ranging from 2021-2023. This includes the 25 units listed above. WCC is in negotiations in respect of over 90 further units with delivery dates yet to be confirmed.

Wicklow County Council is currently holding discussions with a number of developers at preplanning and planning stage. There are over 100 potential Part V units with planning permission but it's difficult to determine whether they will all proceed or even on what timescale.

 Negotiations are ongoing with a number of Developers and AHB's in relation to acquiring further Turnkey units.



- Approval was been received from the Department in respect of 2 Turnkey units in Baltinglass. Units have not commenced construction and the Developer now wishes to discuss further.
- Approval has recently been received from the Department in respect of 3 Turnkey units in Roundwood. Expected delivery is 2022.
- Approval recently been received from the Department for 13 turnkey units in Rathdrum.

#### Capital Advance Leasing Facility (CALF)

The Approved Housing Bodies are actively pursuing a number of potential CALF projects and are liaising closely with the Council on a regular basis. The members will be kept updated.

- Construction completed on 40 units (including 4 Part V) via CALF Turnkey in Dunlavin and the units have now been allocated
- 15 units in Arklow acquired by AHB in November 2021 construction ongoing on remaining 13 units due for delivery in Q2 2021.
- Acquisition by AHB of 16 Turnkey units via CALF in Baltinglass with a further 48 units (including 4 Part V units and 8 CAS units) completed in 2021 units have been allocated.
- Construction ongoing on 28 units in Wicklow (including 3 Part V) due for delivery in 2022.

**Capital Assistance Scheme (CAS)** Wicklow County Council is continuing to support acquisitions under the Capital Assistance Scheme with Dublin Simon, Circle Housing, Ark Housing and Peter McVerry Trust.

Expressions of Interest - Social Housing on Council lands - A preferred proposal has been identified.

#### HOME IMPROVEMENT/ADAPTATION

#### Mobility Aid Grants / Housing Adaption Grants / Housing Aid for Older People

- > Grant funding for private house €1,952,700 (€1,722,620.38 spent to date)
- > Grant funding for social house €1,168.200 (€729,396.01 spent to date)

Many of the approved applicants are experiencing delays in having the works carried out due to Covid and the inevitable back logs it has caused for contractors.

#### Co. Wicklow Strategic Plan for Housing People with a Disability

The Housing and Disability Steering Group has prepared the new draft Co. Wicklow Strategic Plan for Housing People with Disability 2022-2027. The National Housing Strategy for Disable People 2022 – 2027 will be launched in mid January 2022

#### Housing for Older People - Age Friendly Schemes

During recent works on Casual Vacancies/Relets, the Council fenced large sections of existing social housing gardens this resulted in three infill sites to develop Age Friendly schemes in Greystones. It is proposed to build small A rated units, specifically designed for the older tenant, which will be offered to eligible tenants in the local area, who wish to downsize. The larger property will return to the council for



reletting to a family, and the tenant will benefit from being able to remain in their community, in an age friendly designed home with high comfort and low utility costs.

#### **Vacant Homes Scheme**

There are now 10 CPOs underway on long term vacant houses around the county.

#### Oral Hearings

- 108 Charnwood, Bray Determination by An Bord Pleanála was due on 30<sup>th</sup> November following oral hearing on 17<sup>th</sup> August 2021. ABP subsequently informed the Council that a decision would be further delayed and as of 13<sup>th</sup> Jan 2022 no decision had been reached.
- 6 Ashleigh, Ashford objection submitted to An Bord Pleanála this will result in an Oral Hearing by remote means on 8<sup>th</sup> of February 2022.

Negotiations are also ongoing to purchase some of the houses currently under CPO, by agreement. Purchases of 3 further vacant houses should close within the first 2 months of 2022.

Further long term vacant properties have been identified for future batches of CPOs.

There were 2 reports relating to Co Wicklow on <a href="www.vacanthomes.ie">www.vacanthomes.ie</a> in Dec 2021 and 8 already in Jan 2022 - most of which were already known to us and are being investigated.

#### **Infill Sites**

Two 3 bed semi-detected properties are currently being constructed at Blackhills.

#### Housing Maintenance - Heating Upgrade Programme

Gas & Oil heating offer letters for 2022 will be sent out to tenants shortly. The adopted budget for 2022 is €236,000. Gas & oil boiler maintenance contracts are due for renewal and will be procured through www.Supplygov.ie in the coming weeks.

#### **COVID 19**

The Homeless Team continues to provide key support by phone and email - Bed and Breakfast properties currently retained by Wicklow County Council are continuing to provide emergency accommodation for homeless clients –All Covid 19 protocals are in place in these facilities

#### **Homeless HAP**

The Homeless HAP Place finder provides assistance in:



- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- > supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- ➤ To date, 372 households (277 families & 95 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1<sup>st</sup> October, 2018 to 31<sup>st</sup> December, 2021. (164 homeless cases, 201 prevention cases to date and 7 direct provision). 116 properties were sourced by WCC.

#### Addressing Homelessness in partnership with Approved Housing Bodies

#### Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

There are 11 clients supported in the Kilmantin Hill facility, operated by Dublin Simon, with continuing transition by the clients to suitable, alternative accommodation.

#### Homeless Family Service - Fitzwilliam Road, Wicklow

Dublin Simon have been engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of  $3 \times 1$  bed units  $2 \times 2$  bed units and  $2 \times 3$  bed units - Refurbishment works and snagging are now complete. Assessments are underway for the first number of families who will be accommodated in the hub and it is hoped move in's will happen in the next 10 days

It is envisaged that families will avail of the service for circa 6 month STA (Supported Temporary Accommodation) with key working support to enable family's transition from homelessness into Homeless HAP or alternative longer term accommodation.

#### Homeless Supported Temporary Accommodation - San Remo, Bray

A key focus of Wicklow County Council in addressing homelessness was to identify and provide a high supported, temporary accommodation unit in Bray/North Wicklow to address the accommodation and support needs of a particular homeless cohort. This cohort was identified from the presenting population and those currently known to and accessing homeless services in Bray/North Wicklow.

San Remo opened to clients in October 2020. The facility, operated by Dublin Simon, incorporates a service model where there are a number of emergency/cold weather Beds (restricted during Covid) and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

The Neighbourhood Liaison Committee is now operational and meets monthly.

#### Homeless Supported Accommodation - Carraig Eden, Greystones

The Department of Housing, Planning, Community and Local Government (DHPCLG) approved funding to upgrade the building to provide 35 ensuite bedrooms within the existing building, with associated kitchens and common areas, as well as the upgrade of Fire Protection.



The facility is fully operational. Wicklow County Council are making arrangements with the AHB to run an in-reach service with the clients in the service to support them as they continue their journey into more permanent accommodation.

#### **Other Homeless Supported Accommodation**

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients. There continues to be a number of move ons from these properties, signalling the success of this model.

#### **Housing First**

Housing First recognises that a stable home provides the basis for recovery in other areas.

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid East Region and Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the programme.

Wicklow County Council has, to date, successfully accommodated 9 clients under Housing First. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation.

Fire safety on Halting sites were completed by members of the Housing section in October 2021 and further inspections will be carried out in 2022.

#### **Covid 19 Update**

Wicklow County Council has put a number of arrangements in place to provide, among other things, services to previously un-serviced sites which will facilitate better sanitation and social distancing.

Welfare facilities were provided at a number of unauthorised sites.

Three families from unauthorised sites were provided with housing units.

Hygiene packs were distributed to all authorised sites and further facilities provided in March.



### 8. Energy Efficiency

**Solar Panel Carport** – Solar carpark complete and commissioning underway.

#### **Energy Efficiency Fabric Upgrade Phase 1**

This phase includes units in Bray, Greystones Arklow, Wicklow and West Wicklow – delays in completing works due to construction inflation during COVID.

#### **Energy Efficiency Fabric Upgrade Phase 2**

Works nearly complete on 57 properties in West Wicklow and Rathdrum

Additional BERs and suitability inspections being carried out on properties listed as being down for fabric upgrades in 2022. Framework for fabric upgrade works is underway.




New strategy being prepared, at consultation phase with Alliance and OPC and going out to general public for consultation including online surveys – new national template for strategy coming down the line early next year, strategy will be finalised towards last quarter of 2022

Rathcoran Estate, Baltinglass - First Age Friendly Lifetime Community – 4 stage process for this has started with an implementation steering committee to be established after a resident's association is formed.

Avondale House, Rathdrum - First Age Friendly Tourist Destination - process to start shortly.

#### **Blessington eGreenway**



Under Section 177 AE of the Planning & Development Act 2000 (as amended); a planning submission for this project was lodged to An Bord Pleanála on the 14<sup>th</sup> January 2022. The planning documents for this planning submission will go on public display from 20<sup>th</sup> January 2022 to 4<sup>th</sup> March 2022. Submissions or observations with respect to the proposed development may be made to An Bord Pleanála not later than 4<sup>th</sup> March 2022 at 5.30 pm. The Proposed Development will cover approximately 33 km and involve the provision and upgrading of a greenway mostly through forest and woodlands adjacent to the shoreline of the Blessington Lake/Poulaphouca Reservoir SPA. With the construction phase of the project taking approximately eighteen months, the proposed completion date is in quarter four of 2023.





The Comhairle na nÓg, through the Coordinator, launched A Mental Health Campaign - this came out of their training course with Lust for Life during Mid Term. They'll be producing their own Podcast called "it's not taboo to talk' which will focus on youth mental health and they'll have a website to go with it.

The Youth Attitudes towards Drugs Online Survey was promoted far and wide throughout the County. From this survey a report is to be produced to inform works happening in drugs prevention and education in County Wicklow.



#### Community Activities Fund (CAF) under the Community Enhancement Programme (CEP)

The Community Activities Fund is funded by the Department of Rural and Community Development. Funding is available for capital projects that comply with the objectives of County Wicklow's Local Economic and Community Plan (LECP) for the development of community facilities such as community centres, men's and women's sheds, parish halls and youth centres, with small grants for running costs such as utility or insurance bills, as well as with improvements to their facilities, to carry out necessary repairs and to purchase equipment such as tables and chairs, tools and signage, laptops and printers, lawnmowers, canopies and training equipment.

Applications are invited from community and voluntary groups and not-for-profit organisations for small scale capital projects that will support community groups impacted by COVID-19, particularly those in disadvantaged areas.

The closing date for submission of applications for funding is 4.00 p.m. on Monday 31<sup>st</sup> January 2022. Wicklow County Council's libraries have despite restrictions continued to punch above its weight nationally in 2021.

Stats for both unique items borrowed and inclusion of renewals shows Wicklow at 4.3% of the national stats, despite Wicklow having only 3% of the national population.

#### **School Avoidance Talk for Parents**

Bray Library began the New Year with a well-attended zoom talk on Addressing School Avoidance with Tara Kelly, of New Authority Parenting. Twenty nine families logged in on a Wednesday evening, as Tara used her years of experience and research to help guide families through the process of de-escalation. Children with strong bonds to their families and communities are most likely to return to school, and this is the goal emphasised in Tara's approach. Feedback was effusive, with half an hour of question and answer at the end of the presentation. Those attending indicated a real need for further talks, and our next talk with Tara on addressing anxiety in children is currently being planned.

#### Rathdrum gets ready for opening of new Library

Having served their final customers of 2021 at the library at 11 Gilbert Row in December, Rathdrum is now on the cusp of opening its brand new library.

The new library, at the Market Square development will be Wicklow County Council's flagship small library, although at 160 sq. metres, it will be 4 times the size of the Gilbert's Row building.

Installation of furniture and shelving of stock is now taking place, the new sign is up and the plan is to officially open towards the end of January 2022.

#### 2<sup>nd</sup> Round of First5 Little Library Bags



This significant initiative was launched in June with the first rollout of "First5 Little Library Bags" to all local authority library services. The aim of this project is to develop an ongoing link between early learning and care service and their local library to encourage a love of books and reading among young children.

The second tranche of First5 library bags each contain five story books and other reading resources for children. All items have been selected by the LGMA. Pre-schools, after school services and

registered childminders all over the county will be contacted to call to their local library to collect their Library Bags.

#### **Tips for Lowering Cholesterol**



The Cholesterol Lowering Top 10 took place online on the 2nd December. This Zoom talk looked at what people can do to lower cholesterol – the foods to reduce and also the foods to add into the diet. High blood pressure and general heart health also featured with plenty of tips on diet and exercise to ensure optimum cardiac health.

#### Junior Explorer Nature Walk in Lord's Wood, Baltinglass



Junior and Senior Infant classes and their teachers from Stratford Lodge School joined library staff and Environmentalist, Patrick Hunt for a very pleasant walk in Lord's Wood, Baltinglass recently. The beautiful day meant that the children had plenty of time to explore the interesting wildlife and flora which included a flock of goldcrest and amazing leaves and unusual fungi.

#### STEM Family Activity at Wicklow and Ballywaltrim Libraries

Science, Technology, Engineering and Mathematics STEM are now part of the library offer in **Wicklow** and **Ballywaltrim** libraries. Family pods with children aged 3+ may ask at the desk for access to a set of magformers and then sit and play together. Parents or guardians are encouraged to engage with their children and also enjoy the experience. These magnetic shapes lend themselves really well to creative play and encourages engineering skills as children build houses, towers and much more as they explore science, technology, engineering and maths.

#### Parents Plus Special Needs Programme, Blessington

This 6 week course commenced in Blessington Library last November. This course is facilitated by Tusla and is specifically for those parenting an adolescent with an intellectual disability, providing support and an opportunity to meet other parents. Three sessions have taken place and were well attended, the final three sessions have been postponed until 2022 due to Pandemic restrictions.

#### Climate S.O.S. with Wicklow County Council Library Service and SEAI

In May 2021, Wicklow County Council Library Service received 90 English copies of Climate S.O.S. This book, published by the SEAI, is an enlightening fiction story, aimed at primary school aged children. The books are also available in the Irish language.

Every primary school in Co. Wicklow was offered a classroom set of the book, for a 3 week loan period. The response was phenomenal, and a database of schools has been set up.

To date, (November 2021), 12 schools have had the classroom set of books. The books are picked up by the teacher at their local branch.



When schools were finished with the book, they were asked if they were interested in completing a survey which had been compiled by Wicklow County Council Library Service. This survey was very well received and is now used by the SEAI in order to measure the reach of the books.

More books are set to be delivered shortly, so libraries are looking forward to reaching more schools in 2022.

#### **Cool Dudes Programme**

The cool dude programme was developed to educate children the importance of a healthy diet and to help improve the nutritional knowledge, attitudes and behaviour of young people. The programme takes place over 5 weeks and targets 5th/6th class students. St Joseph's National School are starting their 5 week



Programme on 14<sup>th</sup> January 2022, Kilbride National School commencing on 20<sup>th</sup> January 2022 and Lacken National School starting on 17<sup>th</sup> January 2022.

#### **Winter Wellness Walks**

Due to the success of the series of Winter Wellness Walks in Rathdrum in December, two further walks will be taking place on 24<sup>th</sup> and 31<sup>st</sup> January in Tomnafinogue Wood, Tinahely. Each walk will be 3km – 5km in duration and are physically, socially and mentally beneficial. The experience will be inclusive to help people relax in the outdoors and experience an activity in a group. Each walk will be led by poet Jane Clarke and musician James Mahon.

#### **Playful Activity Pack Rathdrum**

#### **Active Kids Programme**

#### **LECP Update**

Goal 1: Develop community capacity in disadvantaged communities and engage in urban and rural regeneration

#### Town & Village Funding Scheme to Revitalise Towns and Villages 2021

The Town and Village Scheme objectives are being refocused to align with commitments within 'Our Rural Future – Rural Development Policy 2021-2025'. The 2021 Scheme will prioritise the objectives of this policy such as tackling vacancy in towns and villages, remote working and supporting town centre living. Other projects which will be welcomed include regeneration projects that support active and vibrant town or village centres, upgrading shopfronts and street facades, and green spaces and parks, etc.

#### **Grant Levels:**

For the 2021 Scheme, the minimum grant which is available is €20,000. The maximum level of grant funding available is being raised to €500,000 in respect of one application from each Local Authority. A maximum of €250,000 will apply in respect of 2 applications and €100,000 in respect of 4 applications. **2 applications must** be in respect of Towns/Villages that have not previously received funding under the Standard Town & Village Renewal Scheme

#### Announcement of the Rural Regeneration Development Fund Category 2

The Minister for Rural and Community Development, Heather Humphreys TD, on May 12<sup>th</sup>, announced the third call for Category 2 applications to the €1 billion Rural Regeneration and Development Fund. This fund is for projects that will drive economic growth and footfall, combat dereliction, regenerate town centre and heritage buildings develop pedestrian zones and outdoor spaces and make rural towns more attractive places to live, work and raise a family.

The €1 billion Fund is also part of the Department's Rural Development Investment Programme, which is funded under Project Ireland 2040. Projects that will be funded under Category 2 are those that require significant development before they reach the stage of being shovel ready.

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects.

It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway.

This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance the Blessington as a place to visit.

Blessington also received €100,000 for development a Masterplan. Combined, these projects will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

Goal 3: Strategic Direction – Develop high quality integrated services, available to all communities, in particular, disadvantaged communities and vulnerable groups

#### 1. Healthy Wicklow Strategy

Round 3 of Programme are underway but implementation has slowed down because of COVID-19. An extension to 31st December 2021 has been granted.

Planning has begun for Round 4 of the programme for Q2 2022

#### 2. Slaintecare Healthy Communities Programme

The Slaintecare Healthy Communities Programme is a new initiative led by Slaintecare and Healthy Ireland in partnership with Wicklow Local Community Development Committee and other local stakeholders. The goal of the programme is to improve the long term health and wellbeing of people living in the most disadvantaged communities in Ireland. The programme is based in the Bray are of Wicklow. This is a holistic approach to health and wellbeing incorporating the physical and social determinants of health, that is, the conditions in which people are born, grow, work, live and age, and the wider set of forces and systems that shape the conditions of daily life. The programme will implement targeted initiatives to tackle these



challenges from within these communities. This will be achieved through the provision of dedicated services to build sustainable improvements in the health and wellbeing of all those living in those communities.

A local implementation team will be formed in each area led by a SHCP Local Development Officer to be employed by Wicklow County Council.

#### 3. County Wicklow Food & Beverage Strategy - Food Poverty and Sustainability

The County Wicklow Food & Beverage Strategy contains aims and objectives to tackle food poverty and food sustainability in the county. This is a long term issue but was highlighted through the work of the Community Response Forum during the COVID-19 pandemic.

A subgroup has been formed to work on this issue. Research has already been undertaken to establish the extent and nature of food poverty and the responses to this. Further research is now ongoing with a view to the development of a working plan going forward.

#### **LECP**

Guidelines for the preparation of the new Local Economic and Community Plan (LECP) were launched recently. The new revised guidelines build on the lessons learned from the current LECP cycle, as well as reflecting the needs of communities as we emerge from the Pandemic. The new approach to the process, with a Framework LECP coupled with Implementation Plans covering a shorter period, will ensure LECPs are more agile and allow for emerging needs.

The LCDC and Wicklow County Council are beginning the process of developing the new LECP based on three elements: evidence, national policies and strategies and consultation.



#### **Economic Development, Planning and Infrastructure**

#### 1. Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP).

New guidelines have been launched for the preparation of LECPs. LECPs detail how Local Authorities will support economic and community development in their areas over the next six years. The new guidelines will assist with the development of the plans for local areas, with a key focus on sustainability, consultation and engagement with local communities and business.

The guidelines will require the Council to consider housing needs when formulating both the economic and community elements of the LECPs. The guidelines are timely as the current LECP finishes in 2022. The new plan will take account of lessons learned and the changing needs of communities, claimate action and sustainability among other things. The guidelines reinforce the important role of communities in determining the needs and priorities of their local area.

#### Retail

#### **Bray Central**

All the main construction work associated with the Shell and Core are near completion. Form work within the basement area is complete. Small elements of snag works are ongoing. Some additional from work relating to bases for ticket machines and plant items have been poured. All the line painting within the basement car park has now been fully complete. The reinstatement of the public paving on the Main Street is 90% complete and all the scaffolding on the Main Street has been removed.

The design associated to the main super structure above ground has been completed. Preparation for practical completion is ongoing. All members of the design team are involved in regular meetings to ensure that practical completion is achieved at the end of January.

The last few elements of the façade works on Main Street are underway and are expected to be completed by January 14<sup>th</sup>. Stone cladding has been completed on site on Block 2 and Block 3 and is scheduled to be completed in the coming weeks on Block 1. All roofing works are near completion. The last remaining items of work relate to small areas sections of roof areas on Block 1 and 2. These works are ongoing and relate to small snag items.



Hard landscaping works are approximately 95% complete. These works are ongoing and are scheduled to be completed by January 21<sup>st</sup>.

#### **Bray Outdoor Performance Space**

A presentation of this project was made to the Elected Members of Bray Municipal District in December 2021. A grant of €250,000 has been awarded to Wicklow County Council. The tender for design architect services for this scheme was advertised in January 2022. The Council will now undertake consultation with relevant stakeholders.

#### **Town Teams**

Town Teams in Arklow, Blessington, Bray, Greystones and Wicklow continue to meet virtually where possible to progress various projects. Activity, particularly engagement with stakeholder groups has been curtailed due to Covid restrictions.

Under the Government Policy, Town Centres First, the establishment of town teams is encouraged and we are likely to see more town teams in situ over the coming years.

Most Town Teams in Wicklow have been operating since 2018. It is considered timely to carry out a review of the town teams and with this in mind, Wicklow County Council has appointed Mr Allen McAdam of MCA Consulting to conduct the review. It is proposed to present the results of the review at a plenary meeting of all the town teams to be held in early 2022.

#### Masterplans for Town Centres under 10,000 population

Blessington has been awarded funding of €100,000 to develop a Master Plan for the town. This will also allow plans for projects identified as part of the drive to become e-greenway ready to be advanced.

Wicklow County Council had nominated three towns for the scheme: Blessington, Rathdrum and Newtownmountkennedy. Eligible towns are those with a maximum population of 10,000. The towns nominated had to be in a position to immediately engage with the Town Centre First process and act as demonstrators for other areas. Nominated towns were also required to have a Town Team or similar group in place and have already completed a background analysis phase such as a town centre health check and to be in a position to proceed to develop a Masterplan.



This initiative is a key part of Our Rural Future – the Government's ambitious five-year strategy designed to reimagine and revitalise Rural Ireland. It is also linked to the Government's 'Housing for All' strategy and the forthcoming 'Town Centre First Policy' which will be announced in the coming weeks.

Wicklow County Council will now work closely with local community groups, retailers and members of the Town Team in devising and delivering on the objectives of the Masterplan building on the very comprehensive Health Check carried out by Future Analytics.

#### **Arklow Town Team**

Arklow leads the way with the first "Pride" Crossing in the Republic of Ireland. Following a successful application under the Streetscape Enhancement Scheme the crossing was installed. Arklow Town Team and Arklow Municipal District are very proud to show their support for the members of the LGBTQ+ community through the installation of a "Pride" crossing on Arklow Main Street. We hope that this project will highlight to those passing through the Main Street area that the community in Arklow and its environs is an inclusive one where everyone is treated equally.

The Arklow Town Team is working on a new exciting Arklow Pottery project. The project aims to collate the stories of Arklow Pottery and to create an immersive and interactive website which brings the history and heritage associated with the Pottery to life again. This resource is intended to complement the Arklow Pottery Museum and Heritage Centre when it is up and running in the future.

#### Elements of the Project:

- Responsive website to include a catalogue of Arklow Pottery pieces from each era, where people could interact with each other and upload their own collections.
- Video production including interviews with surviving Pottery workers, via an experienced facilitator/interviewer, who will tell stories of their experiences and the social history of Arklow at the time.
- Professional Photographer to take new images of speciality pieces of Arklow Pottery and to enhance old photos.
- Coordinator to manage the project including running social media pages, maintaining the website
  and running some periodic offline events such as an Annual Arklow Pottery Fair and reviving the
  Arklow Pottery Festival.
- Shop element on the site where local potters could sell a selection of their products and could showcase and sell an item of 'new' Arklow pottery

Other projects that are also progressing well are Harbour to Headwaters River Tourism Project and the Glenart College Community Garden project.

The Town Team are also considering potential future projects to benefit the town.

Terms of reference were issued to the Bray MD Members in 2021. The Cathaoirleach is reviewing these and will be examining the best way forward.

#### **Blessington Town Team**

Blessington Town Team welcomes the news of the most recent funding announcement of just over €1m under the Rural Regeneration Development Fund (RRDF). Combined with the €100,000 funding for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

#### **Greystones Town Team**

Greystones Town Team is working to maximise the benefit to Greystones of winning the LivCom award for most liveable community. The Town Team will be holding its AGM in February and the official launch of Greystones town teamwill take place shortly.

#### **Wicklow Town Team**

Stage 1 funding of €350,000 towards the Greystones to Wicklow Greenway from Transport Infrastructure Ireland was announced in December. The coastal route is approximately 20km long, through a Special Area of Conservation and due to the sensitivity of the environment and the unique biodiversity of the area great care will need to be taken to ensure that there is no disturbance to habitats, bird species and other features of wildlife interest. The key element of the Coastal Route will be recognition, protection and appreciation. It will be expected that the tendering process to procure Consultants to progress the project will commence early in 2022.

To mark International Day for Persons with Disabilities the Wicklow Town Team Backlighting project allowed the Billy Byrne Monument on Market Square and St. Patrick's Church to be lit up in purple in support of this campaign.

#### Streetscapes

Wicklow County Council has been allocated €320,000 in Streetscape funding under the Department of Rural and Community Development Town and Village Streetscape Scheme.



Six towns/villages in the County have been selected to participate in the Streetscape and Shopfront Enhancement scheme. The areas selected are Arklow, Baltinglass, Blessington, Enniskerry, Kilcoole and Wicklow Town.

The Streetscape Enhancement Initiative is a key part of the Government's 'Our Rural Future' and is designed to make our rural towns and villages more attractive colourful and vibrant places to live, work and visit.

Types of projects funded include: refurbishment of traditional shop fronts, artwork, murals, lighting, planting etc. 99 applications were received and approved under this measure the date for completion of works has been extended to 11<sup>th</sup> February. The initial application and promotion and development of the scheme was handled by Enterprise and Corporate Services. The awarding of grants and drawdown of funds is handled by Community Cultural and Social Development.

#### **Tourism**

#### **Tourism Strategy and Marketing Plan 2018-2022**

The strategy sets out a number of challenging but achievable priorities along with a series of detailed gactions to be implemented over the next 5 years

#### The Key Priorities are:

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

#### **Tourism Work-Group:**

A hybrid meeting was held at Powerscourt Distillery with the Tourism-Work Group which comprised of some of the largest tourism businesses in the County (Hotels, large attractions, etc). Objectives of the meeting; to get some feedback on the season and assess the current situation and to present the various activities Wicklow Tourism and County Council are working on and planning. Those included: website and social media activities, Wicklow Passport updates, Failte Ireland support to attract influencers and organise itineraries, Wicklow Outdoor opportunities especially around EcoTrail and Golf, Wicklow Naturally, Celtic Routes Project, Tourism Information Points, Film Tourism and Sustainable Tourism.



#### **Wicklow Passport:**

There are now five display units branded Wicklow Passport. Those small units are being displayed around the County and hopefully beyond, to help promote the Wicklow Passport. The display units will rotate around the County and be displayed at various locations at key attractions and accommodations providers. A view to bringing these display units to trade shows such as the Holiday World Shows in Belfast, Cork and Dublin are being considered.

#### **EcoTrail Wicklow:**

The third edition of EcoTrail Wicklow will take place on Saturday September 24<sup>th</sup>, 2022. Registrations for the event are now open, and the video of the 2021 race was widely featured online along with a dedicated Press Release. #### **Accessible Glendalough Blog:**

Late last summer, a trip to Glendalough was organised to experience how accessible Glendalough was. From that experience a blog entry showcasing how our tour went has been created. The participants their feedback, relevant to their level of disability. The blog can be found at: https://visitwicklow.ie/accessible-day-visit-glendalough/.

The feedback from this initiative was very well received, and their are plans to schedule further 'Accessibility themed' experience over the next few months.

**Destination Town Funding:** An application to Failte Ireland on behalf of Wicklow Town was made in respect of Destination Town Funding and funding has been awarded to develop visitor amenities in the Abbey Grounds with Mosart consultant's appointed to lead the design process. A planning application to enhance and redevelop the Abbey Grounds, Wicklow, into the Abbey Gardens and event space was passed unanimously by the members of Wicklow Municipal District at their meeting held on Monday 20<sup>th</sup> December 2021. The procurement process for detailed design and construction has begun.

#### Glendalough Masterplan and Wicklow Visitor Orientation Study

This is a Fáilte Ireland funded project led by FI with strategic partners NPWS, OPW, Coillte and WCC. The Plan covers visitor attractions and activities available in the area and the first stage of stakeholder engagement has been completed. .



The consultants team are now engaging with some of the key landowners to assess the feasibility of developing additional off road trails between Laragh and Glendalough and provision of additional parking. The process has identified a number of issues: congestion at key sites, concerns over security, capacity and quality of car parking and visitor services, issues with local access, and erosion and degradation of the environment.

Visitor Experience Hubs have been identified around the county where there is a particular focus of visitor attractions. Development of these hubs will build capacity, help disperse visitors across the county, encouraging longer stays and greater investment in the area. The team is developing detailed plans for walking, mountain biking, off road family cycling.

Measures have been taken this year to introduce additional temporary parking and to use traffic counters to improve parking management and signage. Toilet facilities have been upgraded.

The consultants have prepared the draft masterplan and this was presented to members of the Laragh/Glendalough Community on the 27th October 2021 and to the members of at the Ordinary Meeting of Wicklow County Council on the 6<sup>th</sup> December 2021.

Next Steps: Further Consultation, Strategic Environmental Assessment and Economic Appraisal.

#### **Outdoor Dining**

Fáilte Ireland earlier this year announced funding for Outdoor Dining:

Part One of the Scheme - Outdoor Seating and Accessories - supports individual hospitality businesses with grants of up to €4,000 for seating, tables and outdoor accessories. This scheme which is fully funded by Fáilte Ireland is administered by the Local Authorities. Where the tables and chairs are located in a public space, the business must apply for a Section 254 licence, if the equipment is located on private property, planning permission may be required.

This scheme provided funding of almost €410,000 to 121 businesses throughout Wicklow with the scheme now closed and all businesses receiving their grant.

All Local Authorities were invited to apply to Fáilte Ireland for funding under Part Two - Local Authority Weatherproofing & Outdoor Dining Enhancement Scheme - to develop streets and public spaces to facilitate outdoor dining in urban tourism centres, enabling access to outdoor seating for extended periods throughout the year.



Wicklow County Council applied for and was awarded funding for Outdoor Dining and Weatherproofing for Market Square in Wicklow Town (€119,000) and Abbey Lane in Arklow (€81,000). Works have commenced on the Wicklow project with five of the seven canopies/umbrellas installed and some wiring to be completed. The final two will be installed at the Gaol and works should start shortly.

#### **Rural and Urban Regeneration Development Fund Grant Applications**

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects. It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway. This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance the Blessington as a place to visit. Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

A call was announced for cat 1 proposals with a closing date for applications on the 29th April 2022.

#### **URDF: Urban Regeneration Development Fund**

The Wicklow Town URDF Project for the development of the library at the old Ulster Bank Building and the redevelopment of Fitzwilliam Square has been completed. Total cost for the development of the Library was €6 million, with €3 million funded via the Department of Housing, Local Government and Heritage URDF and €1 million from the Department of Rural and Community Development. €2 million matched funding was committed by Wicklow County Council.

The €2m Fitzwilliam Square refurbishment project, funded by an amount of €1.5m under the Department of Housing, Planning & Local Government URDF scheme, has created a multi-functional space, improving accessibility and enhancing the presentation and public realm of the Town Centre at Fitzwilliam Square. A new outdoor venue for community events, performances and exhibitions, and outdoor dining is now available. The Halpin monument which was concealed is now made more visible and contributes to tourism and the town's maritime heritage. The newly created space is also now responding to the recent health



and safety challenges associated with the COVID-19 pandemic and will go towards helping to support the recovery of the tourism and hospitality sector.

Part 1 of the Arklow URDF Project the refurbishment of the Courthouse and the development of an Enterprise Space in the former Town Council offices. Part 2 of the project the public realm works are currently underway.

#### **Bray Harbour Area Integrated Regeneration**

Funding of €7.14m has been announced for the Bray Harbour Area Integrated Regeneration Project from the Urban Regeneration and Development Fund (URDF) and this funding has the capacity to unlock the great potential of Bray Harbour and surrounding area.

RPS made a presentation recently to the Bray MD Members on Bray Harbour Improvement Feasibility Study. RPS are currently in the process of finalising the Feasibility Report to include the additional Civic Space work that Bray MD wished to include as part of this project. When the feasibility report issues to the Council, the RPS team will make some recommendations regarding the best course of action for the next phase of the project.

#### **Maritime**

The area of offshore renewable energy is rapidly evolving. Due to the number of projects proposed off the coast of Wicklow it is important that the County engages with the process to enable the community of Wicklow to benefit from the opportunities arising while mitigating against any likely impacts that any offshore renewable project will have.

Key milestones have been

The Offshore Renewable Energy Support Scheme Consultation. Wicklow County Council made a submission strongly supporting the case for the funds created as a result of the offshore renewable energy projects to be managed and distributed locally rather than centrally.

The adoption of the Maritime Area Planning (MAP) Act 2021 aimed at harnessing Ireland's offshore wind potential while protecting our marine environment

One of the elements of the MAP is the creation of a new maritime consent process (MAP)



Under the special transition provisions in the MAP Act, the Minister for the Environment, Climate and Communications will have the responsibility for assessing and granting MACs for a first phase (Phase One) of offshore projects, which satisfy the definition of "relevant maritime usage" under the Act (the Relevant Projects).

The relevant projects of interest to Wicklow include the Codling Wind Park and the Dublin Array

Applications for MACs from these projects will open this year and will mark an important step towards reaching our 2030 targets.

A consultation process on the Offshore Renewable Energy Maritime Area Consent (MAC) Assessment for Phase One has opened and will run until 16<sup>th</sup> February.

The purpose of the consultation is to:

- Set out the proposed approach to MAC assessment for Relevant Projects
- Provide important information on various aspects of the new MAC regime for Relevant Projects
- Invite feedback from interested stakeholders on the proposed approach to the assessment of Phase One MAC applications

#### **Food and Beverage Strategy**

Funding of €175,000 has been secured via the LEADER Food Programme for a Food and Beverage Coordinator role for Wicklow Naturally CLG and a tender for the supply of event costs for the period 2021 - 2023 in support of Wicklow Naturally's Promotional Activities Plan. Wicklow Naturally will contribute 5% from subscriptions and it is proposed that Wicklow County Council will contribute €35,000 over the two year life of the project.

Wicklow Naturally hosted a stall at this years 'Gifted', Ireland's premier Craft and Design Fair in the RDS along with a stall at Russborough House and Park Christmas market in December promoting members produce and it was great to see the interest in food and drink from County Wicklow. Wicklow Naturally has also increased their network of members throughout 2021 to add to the array of County Wicklow produce.

Wicklow Naturally, Wicklow County Council, the Wicklow Local Enterprise Office and Sustainable Tourism Ireland have come together to offer an online conference to explore opportunities in the circular economy



for food producers on the 3<sup>rd</sup> February from 10am to 3pm. The conference will look at how these businesses can improve their business model and processes to become more efficient and create more sustainable opportunities. ## 3. Planning and Development

#### **County Development Plan Review**

The consultation period for the draft County Development Plan 2021-2027 ended on 30<sup>th</sup> of August 2021. Over 300 submissions were received. The Chief Executive prepared the Report under Section 12(4) of the Planning and Development Act 2000 (as amended) on the submissions made to the Draft County Development Plan and this was issued to the Elected Members. Workshops will be scheduled in January 2022.

#### **Wicklow Heritage & Biodiversity Office**

Community Monument Fund (CMF). Wicklow County council received a funding allocation of €65,000 for Wicklow archaeology projects under the CMF 2021 from the Department of Housing, Local Government and Heritage. The seven successful projects are as follows; Baltinglass Hillforts, an assessment of archaeological significance; Whitfield Graveyard access improvements; Wicklow Town Community Archaeology Initiative; Dunganstown Castle conservation advice, Kilbride archaeological investigations, Arklow Castle conservation report and the development of Conservation Management Plans for historic graveyards (Ballymacroghue, Mullinacuffe and Whitefield). All projects are complete.

Protected Structures Grants - . There were two successful projects under Historic Structure Fund (HSF); Killruddery Clock tower repairs approved for €50,000 and Conservation works to the 'weir' at Russborough House approved for €50,000. The total allocation for County Wicklow was €72,000 which was distributed to 8 different applicants. All projects under both schemes are now complete.

County Heritage Plan programme - The 2021 programme of actions are complete.

Digital Upskilling course for individuals involved in community heritage projects and activities took place from 22<sup>nd</sup> October – end October. This free course was run over seven online workshops co-funded by the Heritage Council and Wicklow County Council through the County Heritage Plan.

Wicklow Biodiversity Action Funding of €29,950 was allocated under the National Biodiversity Action Plan fund based on application submitted by Heritage Officer. Three projects were undertaken to enhance conservation management of council owned properties, 1 at Brittas Bay, 2 at selected historic graveyards and 3 at Kilmacanogue marsh. All projects are now complete.

Biodiversity Awareness programme: Coastwatch community workshop held in Wicklow Town 29<sup>th</sup> Sept. Heritage Office is co-ordinating this volunteer citizen science survey for County Wicklow. Programme of nature themed zoom evening/ lunchtime talks (8 in total) held in partnership with Wicklow Library Service held from Feb- July. Other activities include production and free distribution of publications (Wicklow Wildlife posters and Gardening for Wildlife booklets and other Wicklow habitat guides)

#### **E-Planning Project**

The commencement of the roll out of the ePlanning system is scheduled in Wicklow for Q1 2022. The project will include the following elements:

- Standardised naming/structure of all documentation in Local Authorities and An Bord Pleanála.
- Web Portal through which all electronic planning applications and all correspondence regarding same would pass.
- All submissions can be made on-line for both planning application and part VIII applications.
- Fees will be paid online by means of card payment or EFT.
- Part VIII applications for all Local Authorities would be submitted and stored centrally.
- Referrals to all prescribed bodies and the receipt of their submissions would be electronic.
- Electronic transfer of planning files to An Bord Pleanála following an appeal.

The e-Planning system will provide a better service to the public. It will allow agents to build their applications before submission, and will reduce the printing, copying and scanning of documentation. It



will also facilitate electronic interaction between Local Authorities, An Bord Pleanála and prescribed bodies.

A significant number of court cases were taken in recent months with successful outcomes, sending a clear message from Wicklow County Council in this regard.

# **Whitestown Remediation Project**

Wicklow County Council has employed Fehily Timoney & Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr. Justice Humphreys



Draft remediation plan was lodged with Brownfield restoration Ireland Limited (BRIL) on 27<sup>th</sup> November 2020.

Following the receipt of submissions from a number of prescribed bodies, the High Court instructed WCC to incorporate the requests contained in the submissions into the draft plan and to commence surveys required for an Appropriate Assessment.

Surveys of the qualifying interests, as agreed with NPWS, were completed in December and results are being collated into report form.

# **Recycling Centres**

A review of all of the Recycling Centres in line with the National Review document recently published on the DECC website is underway to assess how these Civic Amenities are operating with respect to both the service provided and VFM.

Ark Housing opened their newly renovated Charity shop at Bray Recycling Centre. The book stand formerly in the Recycling centre will now be located in the charity shop and managed by Ark Housing with books available for a nominal donation.

A tender has been published to set up a Multi-Party Framework for Civil and Structural Engineer-Led Integrated Design Team Consultancy Services for various projects established in the next 4 years with the replacement of the Asbestos Roof in Bray Recycling Centre and general refurbishment of the centre.

Arrangements were put in place to carry out shredding of Christmas trees in 10 locations around the county in early January.

#### **Climate Action**

#### Climate Action Plan 2021 - Securing Our Future

The Climate Action Plan, which was launched on 4<sup>th</sup> November 2021, is an ambitious plan to put Ireland on a more sustainable path, cutting emissions and creating a cleaner, greener economy and society

The Climate Action Plan follows the Climate Act 2021, which commits Ireland to a legally binding target of net-zero greenhouse gas emissions no later than 2050, and a reduction of 51% by 2030. These targets are a key pillar of the Programme for Government.



The plan sets out 475 separate actions to halve Ireland's greenhouse emissions by 2030, including extensive offshore wind power, retrofitting 500,000 homes and putting a million electric vehicles on the roads.

The public sector will lead by example and halve emissions by 2030. Green Teams will be established in every public sector body. No new fossil fuel heating systems will be installed in public buildings after 2023, except in very limited exceptional circumstances. All new fleet purchases will be electric from 2023, where such vehicles are available.

A new National Retrofit Plan will drive demand and make retrofitting more affordable whilst there are increased targets for district heating and the public sector, and strengthening building standards for all buildings.

Just transition principles are embedded in the plan, including the principles that people need to be equipped with the skills to benefit from changes and that costs need to be shared. A Just Transition Commission will be established.

All increases in carbon tax receipts are earmarked for targeted social protection measures, an expansion of retrofitting, particularly for social and low-income homes, and agri-environmental projects.

### **Wicklow Climate Action**

The Tree Management Policy was passed by the CABA SPC on 9<sup>th</sup> December to go to the full Council on 10<sup>th</sup> January.

RPS Consulting Engineers is progressing the base line carbon footprint study for the Arklow Decarbonisation Zone. A draft Implementation Plan is expected by the end of Q1.

Electric Vehicle Chargers (4No.) at Shoreline Greystones have been commissioned and are in operation. We are awaiting an upgrade to the power supply to the new chargers at Blessington Main Street. This was due to be carried out by ESB Networks at the end of December but has been delayed due to Storm Barra.

The Climate Action Officer is coordinating an input from a number of departments to develop a strategy for the Council on the rollout of EV Chargers in the public domain and also transitioning fleet to EVs.



#### **Environmental Awareness**

- The annual Christmas decoration competition for primary schools was held. As with last year it was promoted as an in-school activity with a prize being offered for each participating school. No county awards were held as a Covid prevention measure. Twenty primary schools participated in the competition this year.
- Discussions were held with the PPN network on opportunities to seek funding under the Climate Action Fund which has a theme of Climate Education, Capacity Building and Learning by Doing. It was agreed that a project to assist SECs who have completed energy master plans would be beneficial. A group including PPNs, SEAI county mentors and the three local authorities of Wicklow, Meath and Kildare are working to develop an application for funding with Irish Rural Link who will be lead partner for the application. If successful, the project will work with the Energy Bureau being established for the three local authorities.
- Funding has been awarded by the EPA for two LAPN projects this year. The first project for which funding was granted will for a Wicklow Naturally webinar on the circular economy for food producers. This project will be delivered in collaboration with the Wicklow LEO, highlighting the Green for Micro programme. Work has commenced on developing content on the circular economy for the Wicklow Naturally website. The webinar has been scheduled for February the 3<sup>rd</sup>.
- A second project will link to the Bikes for Africa project and involve delivery of workshops on bicycle repair in the three larger recycling centres and a video animation to promote extending the life of bicycles through good maintenance. Workshops will target both adult and youth participation.
- An LAPN project to provide training on composting has now been completed with training provided in Hollywood, Blessington, Grangecon and Newtownmountkennedy. Advice was also given to Clermont campus. The project was extended in December to include Loreto College in Bray.
- Judging has been completed in the annual Tidy Town, Estates and sustainable development awards. This year the awards referenced the sustainable development goals.
- The annual Tree Grant was advertised with a closing date for the 8<sup>th</sup> of October. Grants of up to 75% are provided for trees planted. Twenty nine applicants were successful in being awarded a grant to plant native trees with funding provided for 4,700 trees in total. Municipal districts were consulted on suitability of sites selected by communities. Four groups had completed planting by the end of the year with most delaying planting events due to Covid.
- Wicklow County Council is one of three local authorities involved in an EPA funded pilot on separate collection of textiles which will test different approaches for improving the collection



of textiles. Donegal and Clare will test new collection systems while Wicklow will use a communications campaign to increase use of existing textile disposal options. The communications campaign will target one town, for which we will use Arklow, focusing on the charity shops in the town and the recycling centre.

- Wicklow County Council is working with eight other local authorities to develop a series of short videos on dog fouling for use on social media. The campaign will include six animated video each of which shows the impact dog fouling has on others using a variety of scenarios.
   Matching gifs will be developed which can be shared by residents associations more easily on Whats app groups and will serve as reminders of the main campaign. The videos are currently in production.
- Eleven teams from County Wicklow successfully completed entries for this year Relove
   Fashion Competition which offers students the opportunity to develop skills in developing a circular economy approach to textiles and fashion.

### **Sustainable Energy Committees**

Work continues on the Energy Map Plans, EMPs for Enniskerry, Greystones/Delgany, Wicklow and Blessington. Greystones/Delgany and Wicklow are almost complete.

Newtownmountkennedy, Glenmalure and Laragh have completed their Energy Master Plans (EMP) in November.

High Park in Kiltegan has just commenced working on its EMP with consultants.

The Arklow SEC received grant approval for EMP funding in December.

### **Dog Licences**

During the month of November 2021, 287 reminders were sent to owners of dogs whose licences expire-during the month or early December. A total of 348 annual dog licences were renewed and 21 Lifetime licences were issued in November.

#### M11N11 Junction 4 to 14 Improvement Scheme

TII have allocated no funding in 2022 to progress Junction 4 to 14 Improvement Scheme and this scheme is now effectively paused. Wicklow County Council will continue to work with Partners TII and Department to highlight need for this important scheme to continue.

The scheme progressed through Phase 2 Option Selection with the announcement of the preferred route in August 2021, this cumulated with presentations to both Wicklow County Council and Dun Laoghaire Rathdown County Council elected members and TD's. During September a non-statutory public display of the preferred option was undertaken and both the project team with the land liaison team were available for consultation during a period of 6 weeks. The final Option Selection report was published on December 14<sup>th</sup>, and the project website was updated to include information for the Bus Priority Interim Scheme.

**M11N11 Bus Priority Interim Scheme –** The scheme progressed with the development of the Phase 2 (Options Selection) and Phase 3 (Design and Environmental Evaluation) during 2021. The Section 85 was agreed by both Wicklow County Council and Dun Laoghaire Rathdown County. An Interim Bulletin update was published in December for the scheme and the website was launched also. In 2022 the scheme will progress with its detailed design

N11 Parallel Service Road at Kilmacanogue - Substantial completion of the scheme was in September 2021. Snagging of outstanding works continued until the end of 2021. The road works speed limit order was lifted on 01 October 2021, with the exception of the Parallel Service Road which will retain the RWSLO of 50km/h. The speed limit of 60km/h included in the current bye-laws will apply on the N11 mainline. It is intended to amend this bye-law to allow a 100km/h speed limit as intended by the Part 8 for the scheme, a review of the speed limits for county Wicklow is currently being undertaken.



**N81 Knockroe Bend Realignment –** The scheme was completed in 2021, with the defect remediation works carried out in December.

# N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following the completion of the Phase 1 (Feasibility Report) for the N81 Tuckmill Lower, Hangman's Bend, Whitestown Lower and Irishtown West projects (the 'N81 Four Studies'), Wicklow County Council has requested approval from TII to progress the scheme to Phase 2 (Route Selection) in accordance with the TII Project Management Guidelines (PMG).

**N81 Energy Reducing Public Lighting –** Airtricity completed the retrofitting of Energy Reducing public lighting at two sites along the N81, Hollywood Junction and Lambs Junction. Funding was allocated by TII for this project.

### Arklow HTC: Sub - Project Parade Ground Public Realm:

2021 - Scheme under construction.

### **Bray Sustainable Transport Bridge:**

2021 - Part VIII application for the above project went out on public consultation the 22<sup>nd</sup> July 2021, closing date was the 6<sup>th</sup> September 2021. An Bord Pleanála recommended that Wicklow Council suspend a decision on the Part 8 on the 30<sup>th</sup> August 2021 until such time that the Board determines if a EIAR is required for the above project. It should be noted that Wicklow County Council had already determined that an EIAR is not required.

A decision on whether an EIAR is required will be made by the Board on or before the 4<sup>th</sup> February 2022 and following determination a decision will be made in relation to detailed design.

#### **RRDF**

#### Making Baltinglass Hub for South West Wicklow:

2021 - Arup was appointed consultant on scheme and a tender package for construction issued in December.

#### **Blueprint for Blessington:**

2021 – A successful application was made under RRDF for project funding for design, planning and building purchase. Documents are being prepared for procurement of consultants for the masterplan.

# Newtownmountkennedy Town Centre Refurbishment Scheme / 'Placemaking at Newtownmountkennedy':

Plans are following completion of public consultations and preliminary design, work is underway to prepare and lodge Part VIII documents for the scheme.

# Wicklow County Council Compulsory Purchase Chapel Road Pedestrian and Cyclist Infrastructure Improvement Scheme) No.1 Order, 2021

An Bord Pleanala intends to determine the application for confirmation of this CPO on or before the 10<sup>th</sup> February 2022. Following decision it is intended that detail design and tender preparation will commence.

# Blessington Inner Relief Road:



Preliminary ecological and aborist surveys for preferred route have been identified and designed, and landowners have been contacted. Ground investigation work to commence in January and detailed ecological surveys to be completed in end of Quarter 1 2022.

## **Arklow Shillelagh Greenway:**

2021 - Route has been identified, ecological surveys are completed Landowners have been informed of decision to acquire necessary lands by Compulsory Purchase Order. NIS and planning documents are being prepared.

#### **Wicklow Greystones Greenway:**

2021 - Feasibility Report complete with emerging preferred route identified. Additional funding of €350,000 has been secured to undertake ecological surveys and prepare planning documents for the scheme.

#### **Blessington Greenway:**

Route has been identified and letters of consent have been received from landowners Planning documents under Section 177AE of the Planning and Development Act were lodged with An Bord Pleanála for approval on 14th January 2022.

Cunningham's Corner & Sallys Bridge – Specific improvement grant project to continue in 2022

**Bridge Works -** Approximately 18 bridge rehabilitation projects varying in size and scale to be completed in 2022 with some bridge works being also funded through the Climate Adaption

**Winter Maintenance** – Very mild Christmas period – very little gritting over past month – 19 Grit nights to end of 2021 with 151 routes gritted in total

**Public Lighting Energy Efficiency Project (LED retro-fit scheme) –** Eastern Region Works Contract project tender assessment board meeting have reviewed tender and awaiting decision on contract for the region.

**Speed Limit Review -** A county wide review of speed limits has commenced. Elected members, the Garda and a range of stakeholders are being contacted in advance of the preparation of a draft review document.

There were **137 incidents** attended during the month of December 2021. Individual Fire Stations were mobilised on a total of **165 occasions** including 9 incidents in other counties.

Operational activity for the month of December **increased by 30% from the preceding month** (November 2021 – 127 mobilisations). This can be attributed to 11 flooding incidents on Christmas Day, 17 trees down, incidents on 7<sup>th</sup> December due to Storm Barra, an increase in ambulance assists (up from 8 to 13) an increase in false alarm "good intent" incidents (up from 2 to 11) and chimney fires (up from 3 to 16). There was a reduction in alarm activations (down from 25 to 14) and bonfires (down 18 to 8).

Operational activity for the month of December 2021 was up 47% on the equivalent month in 2020 (December 2020 – 112 mobilisations). Most of the increase can be accounted for by strict COVID restrictions in 2020 and incidents related to severe weather events (trees down on 7<sup>th</sup> December and flooding on 25<sup>th</sup> December). Eliminating the weather event incidents activity levels are back close to 2019 levels.

#### Sample Incidents (December 2021)

- > 05/12/2021 Baltinglass and Dunlavin fire crews responded to an overturned car with casualty on the N81 near Stratford.
- ➤ 06/12/2021 Rathdrum and Arklow fire crews attended an RTC at Ballyraine involving a car leaving the road and striking a tree.
- 07/12/2021 There were 17 incidents of trees down (or similar) across the county, some involving vehicles and a caravan. 3 casualties were taken to hospital.
- > 18/12/2021 Tinahely and Carnew crews attended an RTC at Deerpark where a vehicle had left the road trapping the occupant. The casualty was extracted successfully.
- ➤ 25/12/2021 There were 12 separate flooding incidents across the county on Christmas Day in areas such as, Shillelagh, Enniskerry, Dunlavin, Baltinglass, Rathdrum, Ashford and Kilmacanogue. 2 houses were affected and a number of businesses in Baltinglass.
- > 27/12/2021 The only RTC in Wicklow that involved a fatality in 2021 occurred on the M11 when there was an incident involving a car and a bus.

- > 10/12/2021 Blessington fire crew supported crews from Naas at an RTC near Glending.
- > 27/12/2021 Dunlavin fire crew attended an alarm activation in Ballyshannon, Kilcullen.

- 25/12/2021 Arklow crew assisted crews from Gorey at flooding at Broooklyn Court in Gorey.
- 25/12/2021 Carnew crew attended an ambulance assist at Boleybaun, Inch.
- > 26/12/2021 Carnew crew assisted crew from Bunclody at an RTC at Coolmela, Clonegal.

- A 2-day Emergency Medical First Responder course was run for 6 students in Blessington.
- Cork City Fire Brigade undertook a 1-week consolidation training course in Bray Fire Station for new recruits.
- Wicklow County Fire Service undertook a joint project with Baltinglass Tidy Towns to have a mural painted on the side wall of the Fire Station depicting local sites of significant historical and archaeological interest.

Submissions of Certificate of Compliance on Completion have increased in November and December as demand for completion and closing of private dwellings prior to Christmas rose. All CCC's submitted in late November and December were validated excluding one CCC, where an extension of time was requested due to unforeseeable delays onsite.

Revised Information requests remain high as volume of Opt Outs in Wicklow is also on average between 50% to 60% each month. Opt Out submissions are generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt Out Submissions.

#### **Register of Electors**

The Franchise Section are currently making final preparations to produce the 2022/2023 Live Register of Electors on 1st February 2022 which will come into force on 15th February 2022.

The Franchise staff will continue to strive for excellence and accuracy on the Register of Electors database. We are continuing to accept applications from 18 year olds and new residents moving into the county in the event that an electoral event occurs and there is a requirement for a Supplement Register. We will continue to make contact with new housing developments and urban areas where new developments are coming on stream in an effort to get new residents register.

Once the Live Register is published we will be in contact with Nursing Homes with a view to updating the Disabled Special Voters List. It is hoped that when Covid Restrictions ease we can resume visiting Secondary Schools throughout the County with a view to getting 18 year olds registered to vote.

Work is ongoing and continuous throughout the year where is a lack of Eircodes and dates of birth. Wicklow Co Co are in the top 3 of local authorities in Eircode coverage on their register with over 99% of the electorate having an Eircode attached to their Register of Electors entry.

We are continuing to assist the LGMA in their exercise to have other Local Authorities achieve similar Eircode coverage on their own Register of Electors. Work is also progressing and the Wicklow County Council Franchise Section have significant input into, the new Electoral Register Modernisation Process with staff members forming part of the Department Committee on this process. The Franchise Section are also in the early stages of assisting the LGMA in developing an updated version of the current register database system with regular MS Team Meetings and discussions on this project. It is hoped to begin testing and troubleshooting this new system in late Spring 2022 with Wicklow being one of the two lead authorities on this project which in turn will be rolled out to other Councils as the year progresses'.

- Work continues with the business process mapping and DPIA's are being carried out for each process as
  it arises.
- Avaya IP Office Phone System has been modified to integrate the Avaya Contact Centre Select
  Hardware Appliance and software. This has led to greater integration with call reporting systems and has
  improved customer service delivery.



**Twelve Month Rates Waiver:** A waiver of commercial rates was applied to specified businesses for the first, second and third quarters of 2021. A further waiver was applied for Q4 2021 and was targeted at the hospitality, arts and certain tourism sectors. There was no application process required for this scheme. Wicklow County Council automatically applied a 100% credit in lieu of commercial rates for the quarters to eligible properties.

### **General Municipal Allocation and Discretionary Fund 2021 and 2022**

The Discretionary Funding allocation for 2021 was decreased in line with the 2021 LPT rate reduction. The 2021 funding provision consists of mainly General Municipal Allocations used to support local groups and initiative etc. There was no public realm funding allocated in 2021, however unspent monies in this area from 2020 have been made available to Municipal Districts. The Level 5 Covid restrictions on construction which were in place up to May 4<sup>th</sup> prevented any public realm works being carried out up to that date.
