ITEM NO. 5

To approve a temporary overdraft accommodation of €20m for the financial year ending 31st December 2022

Elected Members were circulated with a letter from Mr. Brian Gleeson, Head of Finance, requesting the approval of a temporary overdraft accommodation of €20m for the financial year ending 31st December 2022.

It was proposed by Cllr. V. Blake, seconded by Cllr. I. Winters and agreed to approve a temporary overdraft accommodation of €20m for the financial year ending 31st December 2022.

ITEM NO. 6

To enter into a Section 85 Agreement between Wicklow County Council and Dun Laoghaire Rathdown County Council for the N11/M11 Bus Priority Interim Scheme

Further to the report circulated with the agenda Mr. J. Bowes, Senior Engineer outlined the following:

- Severity of traffic issues on the N11 at peak time needs early intervention to address problems on the corridor.
- A project to assess the feasibility of providing bus lanes on the N11 is progressing.
- If feasible, bus lanes could offer a practical solution in advance of the main junction scheme.
- This separate project called the Bus Priority Interim Scheme is a multi-authority project involving Wicklow County Council, Transport infrastructure Ireland (TII), National Transport Authority (NTA) and Dun Laoghaire Rathdown County Council.
- The Bus Priority Scheme is being implemented in accordance with Transportation Infrastructure Ireland's project management guidelines.

• In order to facilitate the project in an efficient manner to the operation and preliminary design of statutory orders, Wicklow County Council proposed to enter into a Section 85 agreement, with Dun Laoghaire Rathdown County Council.

Following a brief discussion it was proposed by Cllr. D. Mitchell, seconded by Cllr. S. Bourke and agreed to enter into a Section 85 Agreement between Wicklow County Council and Dun Laoghaire Rathdown County Council for the N11/M11 Bus Priority Interim Scheme.

ITEM NO. 7

To consider NOAC Local Authority Performance Indicator Report 2020

Elected Members were circulated with the National Oversight Audit Committee (NOAC) Local Authority Performance Indicator Report, 2020 on 27th October 2021.

Ms. L. Gallagher, Director of Service gave a brief overview of the Wicklow County Council performance in relation to some of the 42 indicators. Wicklow County Council improved its performance across a range of indicators during 2020, despite COVID-19 challenges while providing additional innovations and services during the pandemic. The NOAC Local Authority Performance Indicator Report 2020 shows Wicklow County Council made advances last year, in particular in the areas of Community and Business supports. While COVID-19 placed a considerable burden on the Council, with a reduction in revenues and strained resources Council staff continued to deliver essential services throughout the pandemic.

Wicklow County Council established the Community Call service to provide support to more than 1,795 people since March 2020.

Alongside this, Wicklow County Council continued to deliver essential services throughout COVID, as the Performance Indicators Report 2020 shows:

- Wicklow County Council added 251 units to the social housing stock in 2020
- 88.7% of motor tax transactions were conducted online in 2020, a significant increase from 2019
- The Local Enterprise Office approved 301.9 (per 100,000 population) trading online vouchers to support Wicklow businesses to increase their online offering. The LEO also provided mentoring to 563.8 (per 100,000 population) businesses.
- In 2020, total road improvement and maintenance expenditure was €7,627,350 for strengthened and resealed on 156.2 km of both local and regional roads
- There were more than 1,459,825 million visits to council websites and our social media following increased by 22.2% to 80,626 in 2020.
- Wicklow has continued to demonstrate that it is a clean county with 80% of the County shown to be either litter free or only slightly littered. This is continuous level of improvement from 68% in 2018 and 76% in 2019.

Following a broad discussion it was agreed to send a letter to the National Oversight Audit Committee requesting the NOAC Local Authority Performance Indicator Report issue in quarter 1 of the year following the year it relates to, in order to make the information more timely.

- Local meetings in each municipal district in the new year.
- Online meetings with Public Participation Network (PPN) members on the 24th November 2021.
