A bye read from Bunlavin pesses along the West side. Bunlavin is the next market town about two giles distant. Fuel is got at Marrowmore Bog about four miles dietant. Rathselfesh House is 66 feet long by 32 broad, built in form of an oblong, but has cross-houses & cutlets at the South and; it is only one story high. There is a Green-House attached to the South end, and also well sheltered pleasure ground, divided by several walks & ornamented with trees There is an excellent Coach walk from the ena shrubs. trance at the North side of the Demesne to the House, and also another well gravelled pass from the House in a S.W. direction to the road from Baltingless to Athy.
