		<p>Freedom of Information, could I get a copy of the "multiple correspondences" between the Bray MD Town Engineer and NCBI please? I initiated the rainbow crossing in Arklow. I have had meetings with NCBI and I am also a Disability Activist most of my life, and the Arklow crossing was seen by NCBI who informed me that it would not impact on anyone Blind or Visually impaired as the design is 'outside' of the actual crossing and not part of the crossing. I am waiting for a phone call from NCBI today in relation to this, to clarify what has happened. The Arklow crossing Design does not impact on anyone as stated above, and has been copied by Limerick, Cork, and South County Dublin to name a few. The coloured lines are not part of, or in the pedestrian crossing - training to cross the road at Traffic Lights teaches everyone to walk from kerb to kerb between the solid white lines only - that applies to everyone - the coloured lines are a distance away on the outside of those white lines, so if someone was walking over the coloured lines they do not know how to cross the street. Those that are blind/visually impaired are not taught to cross the street diagonally as it would be dangerous, so they are nowhere near the coloured lines. I have spoken to NCBI about this article, which they now have, and they also have great concerns about being quoted by the Town Engineer as being "opposed" to the crossings, which is not the case. They are looking into this also</p>
