This month:

#### Broadcaster Charlie Bird conferred with the Freedom of County Wicklow

Journalist and Broadcaster Mr Charlie Bird was conferred with the Freedom of County Wicklow by Wicklow County Council on 26<sup>th</sup> September, in recognition of his work and outstanding achievements in the field of broadcasting and journalism and more recently in his campaigning and raising funds for the Irish Motor Neurone Disease Association and Pieta House.

Mr. Bird was only the third recipient of this unique honour: Oscar-winning actor and Wicklow resident, Daniel Day-Lewis, was the first in 2009 and World champion boxer, Katie Taylor, was the second in 2011.

The conferring of the honorary freedom of the County Wicklow is bestowed by the County Council on a person who has distinguished themselves in such a manner as is deemed worthy to have their name entered onto the Roll of Persons So Honoured.

#### CLAR Funding for 5 Projects in County Wicklow

Under the Clár programme 2022 Wicklow has been awarded almost €170,000 for upgrades to public lighting in Askanagap and Kilpipe. Community halls in Knockananna and Akanagap are also to benefit from the scheme.

CLAR is an initiative under 'Our Rural Future' that aims to provide funding for small infrastructural projects in designated rural areas. 'Our Rural Future' is the whole-of-government policy for rural Ireland for the period 2021-2025. It is about a community-based approach to rural development which recognises that the people who know best what their area needs are the people that live there.

#### Wicklow Shortlisted for National Awards

Wicklow County Council has been shortlisted in the 19<sup>th</sup> annual Chambers Ireland Excellence in Local Government Awards 2022 for six projects.

The 2022 Excellence in Local Government Awards, showcase best practice in local government and recognise the skills, hard work, innovation and enthusiasm within local government that can often go unrecognised.

#### **Potential units**

Wicklow County Council currently has agreements in place for units in Delgany, Bray, Rathnew, Wicklow, Rathdrum, Kilcoole and Enniskerry with delivery ranging from 2022-2024. This includes the 59 units listed above. WCC is in negotiations in respect of over 100 further units with delivery dates yet to be confirmed.

Wicklow County Council is currently holding discussions with a number of developers at preplanning and planning stage. There are over 100 potential Part V units with planning permission but it's difficult to determine whether they will all proceed or even on what timescale.

Further long-term vacant properties are currently being identified for future batches of CPOs.

Further reports relating to Co Wicklow on <u>www.vacanthomes.ie</u> were received in June. Information received from the public in this manner is crucial to identifying vacant houses and to taking action.

Since it began in 2017 we have received 206 reports relating to Co. Wicklow. 12% of these contained insufficient information to identify the house in question. 21% of reports related to the same house (often multiple reports submitted by the same person).

#### Croí Cónaithe (Towns)

This is a new scheme announced by the Department of Housing, Heritage and Local Govt in July 2022. Up to €30,000 grant available for houses which are:

- Vacant for more than 2 years.
- Built prior to 1993.
- Within a town or village (rural houses not covered).



• To be used as the applicant's permanent dwelling.

The grant amount can be increased to €50,000 in cases where the building is Dangerous or Structurally Unsound (requires an Engineers Report). Buildings which are currently non-residential (such as vacant commercial units – shops etc) but which the applicant intends to convert to residential use, can also qualify.

It is intended to revitalise towns and villages by addressing vacancy and dereliction.

A small number of applications have been received and a number of enquiries about the scheme have been received and answered.

4 houses that were approved for sale at the January Housing and Corporate Estate SPC meeting are been advertised for sale to either existing tenants of Wicklow County Council or persons on the WCC social housing list.

#### Infill Sites

- Blackhills Two 3 bed semi-detected properties are nearing completion.
- Knockroe Part V111 approved and a revised stage 2 application has been submitted to the department for 2 x 4 bedroomed fully accessible units

#### Housing Maintenance - Heating Upgrade Programme

The adopted budget for 2022 is €236,000 and due to the significant increase in cost of new installations, only 19 houses will be done in 2022. Work has started on new Gas heating installations and will then move on to Oil as the same contractor is doing both. Gas & oil boiler maintenance contracts have been renewed and servicing has started. Arising from the procurement process there have also been significant increases in the cost of boiler servicing – in the range 12 to 23%. Similar increases will apply to boiler repair and replacement costs.

The Homeless HAP Place finder provides assistance in:

- seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- > liaising with specific households to establish their specific needs;
- > establishing relationships with local property agents and landlords; and,
- supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- To date, 405 households (300 families & 105 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1<sup>st</sup> October, 2018 to 31<sup>st</sup> August 2022. (177 homeless cases, 219 prevention cases to date and 9 direct provision). 120 properties were sourced by WCC.

#### Addressing Homelessness in partnership with Approved Housing Bodies

#### Homeless Supported Temporary Accommodation – Kilmantin Hill, Wicklow

There are 11 clients supported in the Kilmantin Hill facility, operated by Dublin Simon, with continuing transition by the clients to suitable, alternative accommodation.

#### Homeless Family Service – Fitzwilliam Road, Wicklow

Dublin Simon have been engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of 3 x 1 bed units 2 x 2 bed units and 2 x 3 bed units - Refurbishment works and snagging are now complete.

6 of the apartments in the hub are now occupied with a nomination for the 7<sup>th</sup> referred to Dublin Simon I



It is envisaged that families will avail of the service for circa 6 month STA (Supported Temporary Accommodation) with key working support to enable family's transition from homelessness into Homeless HAP or alternative longer term accommodation.

#### Homeless Supported Temporary Accommodation – San Remo, Bray

San Remo opened to clients in October 2020. The facility, operated by Dublin Simon, incorporates a service model where there are a number of emergency/cold weather Beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

The Neighbourhood Liaison Committee is now operational and meets monthly.

Bi- monthly meetings are held with Dublin Simon and Wicklow County Council staff

#### Homeless Supported Accommodation - Carraig Eden, Greystones

The facility providing 35 ensuite bedrooms with associated kitchens and common areas is fully operational. Wicklow County Council have made arrangements to run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

#### Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients.

#### Housing First

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid-East Region and Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Housing first recognises that a stable home provides the basis for recovery in other areas.

Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the implementation of the programme.

Wicklow County Council has, to date, successfully accommodated 11 clients under Housing First and it is hoped that 1 further allocation will take place in the coming weeks. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation – the main issue facing this programme is the availability of one bed units in suitable locations with easy access to services etc.

#### **Traveller accommodation**

#### Ukrainian Response

• As of 13<sup>th</sup> September, the numbers of Ukrainians Displaced Persons in emergency type accommodation is 1,035 (although we know that there are considerably more in the County)

- WCC are currently assessing all Displaced Ukrainians persons in the County in order to identify their accommodation needs as well linking them in with all the relevant services and supports within the community.
- WCC are working through a list of pledged properties within the County and matching families accordingly. As of the 13<sup>th</sup> September we will have housed 121 number displaced Ukranian people. Larger buildings and vacant units are also being identified and explored as potential options for medium to long term accommodation. –
- Arklow Rest Centre closed at the end of May.
- The Community Reponse Forum continues to meet on a fortnightly basis

Arts

#### Local Live Performance Programming Scheme (LLPPS 4)

Strand 4 of our LLPPS programme commenced in August with the roll out of a four day family festival event in Rathdrum with performances by many Wicklow based artists, musicians and singers. The line-up for September events is underway.

#### Music Programmes for Older Persons

The Mobile Music Machine 'Covid Care Concert' series 2022 continues its presentation of concert performances in residential care home facilities throughout County Wicklow.

#### **Strategic Projects**

The deadline for submitting applications to the Strategic Projects Award Scheme 2023 is 13<sup>th</sup> September 2022. The Scheme is open to artists, national resource organisations, individual curators, and / or artist collectives.

#### **Creative Wicklow Grant Scheme 2022**

Letters of Offer have been dispatched to the successful applicants for the Creative Wicklow Grant Scheme.

#### Culture Night

Culture Night takes place on Friday, 23<sup>rd</sup> September 2022. #### **Dormant Account Funding for Library Supports**



Wicklow County Council Library services are happy that their funding application for Dormant Accounts Funding has been successful. New interesting initiatives and resources will now be possible as will the opportunity to build on existing services to support children with dyslexia and other literacy delays. Planned programming includes a pilot outreach intergenerational activity with a selection of nursing homes in the county, a program of events with men in Shelton Abbey Open Prison, a Minecraft course for children in the Bray/ Ballywaltrim area, a Comic Bookclub and an early literacy range of activities for families with babies and pre-schoolers.

The funding will also facilitate the purchase of a

subscription to LOTE – an online database of children's books in languages other than English, an online subscription to Times Tables Rock Stars – a virtual fun activity to support children in Primary schools as they learn their times tables.

Finally the purchase of "C-pens" which have a simple mechanism that lets the user scan text to have words read aloud and have words defined if needed. These will be available for borrowing at each of our branches.

Patrons were treated to refreshments while the Wicklow Ukulele Players provided the entertainment, playing a host of well-known songs.


Almost 90,000 visits to the library have taken place since opening last year.

What can you find in your County Archives: Wicklow County Archives – Digital Project for Heritage Week 2022



You might be surprised at the volume and variety of records relating to your county in your local archives! In this digital presentation, archivist Catherine Wright describes the collections held in the Wicklow County Archives Service, focusing on collections common to most local authority archives and discuss their usefulness as sources for research. These include Grand Jury records, Boards of Guardians, Town Commissioners and Town and County Councils as well as private family papers and business collections.



County Archives are widely used by local historians, family historians, academics and researchers of varied interests. During this time of commemoration, county council records are invaluable as a tool in understanding the role played by local government in the path to independence and county archivists have played a key role in Decade of Centenary projects. Indeed, the collections of county archives tell the story of the development of communities and the authorities who served them and place this story within the national context. #### **Engagement with Marginalised Communities**

County Wicklow has been selected as one of four pilot projects to develop and test engagement strategies to support inclusive participation. The project aims to develop toolkits that can be adapted and used by local authorities and other state agencies to enable better engagement with hard to reach groups.

Following an expressions of interest process administered by Pobal on behalf of the Department of Rural and Community Development, funding of up to €40,000 has been approved for each of 4 LCDCs.

Clare, Fingal, Galway City and Wicklow will undertake pilot programmes to support participation and engagement by marginalised and disadvantaged communities in the Local Economic and Community Planning (LECP) process which is currently underway in each local authority area. The process will take six months and in Co. Wicklow's case involves both participation and capacity building.

#### **Core Aims & Actions**

- Through the networks available to members of the LCDC, WCC & Co Wicklow PPN, key community leaders and service providers within/working with the target groups will be identified and encouraged to undertake training that will support them to understand the background & context for developing the VCWB & the LECP as well as providing them with the facilitation skills & tools needed for them to run this process of consultation in their communities & those they work with.
- This will extend the reach of the consultations and engage with those groups which are harder to reach.
- The facilitators will also be trained to support the data analysis process that will inform and develop the VCWB as well as the LECP.
- This in-depth consultation should also provide direction and help prioritise some of the actions within the LECP.
- Collaborating with key agencies in this process should also result in cohesive & complimentary local plans, work plans and strategies e.g. SICAP and LEADER plans.
- Record and report on the learning from this process

#### Pride of Place 2022

The Co-operation Ireland Pride of Place competition 2022 judging took place on 6<sup>th</sup> and 7<sup>th</sup> of September 2022. The following groups were assessed by the two judges, under these three categories -

- Community Wellbeing An Tochar GAA and Wicklow Sports and Recreation Partnership for their collaborative on the "Irish Sign Language Project."
- Community Resilience The Wicklow and Arklow Ukrainian Hubs
- Community Creative Place The Chatting Benches An Garda Siochana's project

The three groups made impressive presentations to the judges over the two days. The winners of the competition will be announced at a Gala Awards Ceremony, which will take place in January 2023. This competition is dubbed the "Oscars of the Community Sector", the "Pride of Place" Awards are an annual competition organised by Co-operation Ireland and sponsored by IPB Insurance. celebrates the best in community development and recognises the selfless efforts of people in making their local area a better place to live work and socialise.

#### **Economic Development, Planning and Infrastructure**

#### 1. Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). LECPs detail how Local Authorities will support economic and community development in their areas.

The next Wicklow Local Economic and Community Plan (LECP) 2023 – 2029 will set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of County Wicklow, both directly and in partnership with other economic and community development stakeholders.

The Economic Development unit is seeking to engage with the business, tourism and wider community to help identify priorities for the County over the lifetime of the plan.

Wicklow County Council has appointed a team of experts from People and Place to assist with the preparation of the LECP.

#### Retail

#### Bray Central

Practical Completion Cert has been agreed and the transfer of Title has begun.

Oakmount continue to engage with prospective anchor tenants on the two main units in the centre. It is hoped that agreements to let will be settled in the coming weeks. Oakmount has advised that there are leases in place on all of the leisure spaces and heads of terms are agreed with several new retail units. Fit out of the restaurants continues and Press Up Group has advertised for staff for these units.

#### **Town Teams**

Under the Government policy, Town Centres First, the establishment of Town Teams is encouraged and we are likely to see more Town Teams in situ over the coming years.



Most Town Teams in Wicklow have been operating since 2018. It is considered timely to carry out a review of the town teams and with this in mind Wicklow County Council has appointed Mr Allen McAdam of MCA Consulting to conduct the review. The result of the review will be presented to the Council and to the Town Teams in September, 2022.

Since the review was carried out, the government policy document Town Centre First was published, and the Council has received sanction to appoint a Town Regeneration Officer on a three year contract.

#### **Blessington Town Centre First Masterplan**

Blessington has been awarded funding of €100,000 to develop a Master Plan for the town under the Town Centre First policy. This will also allow plans for projects identified as part of the drive to become e-Greenway ready to be advanced.

This initiative is a key part of Our Rural Future – the Government's ambitious five-year strategy designed to reimagine and revitalise rural Ireland. It is also linked to the Government's Housing for All strategy and a key component of the Town Centre First policy.

Wicklow County Council will work closely with local community groups, retailers and members of the Town Team in devising and delivering on the objectives of the Masterplan building on the very comprehensive Health Check carried out by Future Analytics.

#### Arklow Town Team

The Interactive Tourism Kiosk project is progressing well. The screen has been installed in the new public realm area at the Parade Ground in Arklow. The design process is still ongoing. An EXPLORE ARKLOW section is being created exclusively for the screen with the onus placed on brand new maps of the town, its points of interest, amenities, and selected walks.

Arklow Town Team were delighted to support The Vessels exhibition with funding received from Creative Wicklow Grants Scheme 2022, to host a number of 'Old Tales made New' events in Arklow. The exhibition celebrates the history of Arklow, its culture and heritage through the eyes of Sean Redmond, James Burke and Adam Burke. The launch was a great success, and the exhibition will be displayed in the Arklow Maritime Museum until 31<sup>st</sup> October.



The funding will also be used for the Giant Tea Cup Project. The Town Team have purchased a giant teacup made out of fibreglass which will be restored by local group 4o2 Creative Artivists. A call out for broken, chipped and unwanted Arklow pottery has been made, to be reused into making a beautiful mosaic for the teacup. The finished cup will be installed at a location in Arklow for all to enjoy.

A feasibility study is to commence in September on the Ballyduff River in Avoca to identify the optimum solution for fish to move through an impassable barrier at Glenart Ornamental weir.

#### Bray Town Team / Bray Town Recovery Team

Terms of reference were issued to the Bray MD Members in 2021. The Cathaoirleach is reviewing these and will be examining the best way forward.

#### **Greystones Town Team**

A very successful multi-Cultural event was held at Burnaby Park on 20<sup>th</sup> August, 2022 where the Greystones Town Team actively supported the African Irish Society Wicklow. The event comprised of music, dance, food, costume, storytelling and language classes. It was well supported and an enjoyable day for all attendees.

#### **Tourism**

#### Tourism Strategy and Marketing Plan 2018-2022

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

The Key Priorities are:

- 1. Develop New Accommodation

#### **Tinahely Agri Show:**

Wicklow Tourism was present at the Agri Show in Tinahely over the August Bank Holiday. Main focus was to present and promote the Wicklow Passport. Many passports were distributed raising tremendous interest from members of the public.

#### Wicklow Passport:

A few Wicklow Ambassadors Certificates were issued over the summer, including two from the US who spent time in Wicklow with families. Another Certificate was delivered to a Bray resident who collected all passport stamps either walking or cycling around Wicklow. #### Abbey Grounds, Wicklow

The purchase of the Abbey Grounds, Wicklow completed in August and it is intended that the space will be enhanced and redeveloped into the Abbey Gardens and Event Space. The Parochial House has been retained by St. Laurence O'Toole Diocesan Trust and a separate entrance way will be provided as part of the redevelopment.

The redevelopment will include converting the existing Coach House for use as a Café/Retail/Exhibition space and public toilets, installing a natural amphitheatre arrangement to provide for public performance events, a new pedestrian access, pathways for improved accessibility, and public seating.

The plans take careful consideration of the conservation and enhancement of the biodiversity of the grounds, as well as the protection of the ruined remains.

#### **Glendalough Masterplan and Wicklow Visitor Orientation Study**

In 2020, Fáilte Ireland, in partnership with National Parks and Wildlife Service (NPWS), the Office of Public Works (OPW), the National Monuments Service (NMS), and Wicklow County Council commissioned Consarc Design Group with a multidisciplinary team to deliver a Visitor Experience and Management Masterplan for Glendalough and Wicklow Mountains National Park and Visitor Orientation Recommendations for Co. Wicklow.

Key issues identified in the brief included:

- Improving the regional and seasonal spread of visitors
- Encouraging more tourists to visit outside seasonal peaks
- Encouraging people to visit areas outside of the main attractions all intended to mitigate against regional and seasonal congestion and deliver a better experience for all
- Increase dwell time in the county

The consultancy team undertook an assessment and consultation process to discern key issues which affect the National Park experience. In tandem with this consultation and information gathering, detailed site surveys were conducted to assess the existing ecological and archaeological sensitivities of the area.



The following recommendations are made, working together to effectively disperse visitors to sites across the county:

- Enhanced online presence particularly via social media channels
- Enhanced quality on the ground improvements to basic visitor infrastructure
- Product enhancement and product development
- Strengthened outdoor recreation hubs
- Increased Connectivity

Improving the quality and sustainability of outdoor recreation sites is integral to achieving effective dispersal within the park and on a county wide level.

A shuttle bus service to Glendalough ran over the summer months to improve traffic congestion in the area and was very successful. The shuttle bus has now ceased and signage has been replaced to reflect this.

#### **Outdoor Performance Space**

The letter of Contract Award for design Consultants issued to the successful tenderer on the 30<sup>th</sup> March. The successful tenderer is Vincent Hannon Architects. An initial meeting with officials from the Council was held on 21<sup>st</sup> April.

Meetings have taken place with Strand Road residents, Royal Marine Terrace and Martello Terrace. A site meeting took place on the 9<sup>th</sup> May with the Design Team, Council officials and representatives from the Mermaid Theatre where the different canopy options were discussed. Initial drawings showing canopy options are being considered. When the final design is agreed drawings will be prepared and presented to the Members prior to commencing the Part 8 process

#### **Rural and Urban Regeneration Development Fund Grant Applications**

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects. It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway. This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve



Wicklow County Council's long-term vision for Blessington and enhance Blessington as a place to visit. Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

Two applications have been submitted for RRDF category 1 proposals in April 2022. The applications were Rathdrum RISE (Regenerate, Invest and Support Enterprise) and Baltinglass; Looking Back and Moving Forward. A decision on these applications is expected in Q4 2022.

#### **URDF: Urban Regeneration Development Fund**

Part 1 of the Arklow URDF Project involves the refurbishment of the Courthouse and the development of an Enterprise Space in the former Town Council offices. Part 2 of the project the public realm works are currently underway.

#### **Bray Harbour Improvements**

The requirement for additional environmental assessments was identified in the draft Feasibility Report. During a meeting with RPS in March, RPS undertook to carry out an EIA Scoping Exercise as an add-on to their current engagement. It was also agreed that they should provide ecological services to undertake a Stage 1 Appropriate Assessment Screening. A fee proposal was submitted and included for additional public consultation on the scheme and the production of a 3D model for the improved visualization of the scheme. The fee falls within the value of the original tender for which RPS were appointed in 2019 to carry out the feasibility study. RPS has been instructed to proceed with this work. A follow up meeting is proposed to clarify the extent of the terrestrial elements of the scheme to be included in the EIA scoping report or which shall be deferred to till a design is available and may be instead be subject to a Part 8 planning process.

RPS was requested to carry out an EIA Scoping Exercise as an add-on to their current engagement. A draft EIA has been received and this is being reviewed at present. This identifies all of the potential environmental impacts that need to be addressed in the EIAR. A Stage 1 Screening for an Appropriate Assessment report has yet to be provided after which it is proposed to organise further public consultation that includes a 3D visualisation of the proposed scheme.



#### Land Management

Wicklow County Council Economic Development Unit are progressing the acquisition of an Enterprise Space in Greystones from Cairn and are also progressing the sale of the 1.33-acre site on Mill Road/South Beach to the HSE.

The purchase of the former Bank of Ireland building in Carnew has been completed and the building has been insured and secured. A Town and Village Renewal Scheme application has been approved by the Department of Rural and Community Development to fund the purchase of this building, and the application to draw down this funding is in process.

#### Maritime

The area of offshore renewable energy is rapidly evolving. Due to the number of projects proposed off the coast of Wicklow it is important that the County engages with the process to enable the community of Wicklow to benefit from the opportunities arising while mitigating against any likely impacts that any offshore renewable project will have.

Key milestones have been:

- The Offshore Renewable Energy Support Scheme Consultation. Wicklow County Council made a submission strongly supporting the case for the funds created as a result of the offshore renewable energy projects to be managed and distributed locally rather than centrally.
- The adoption of the Maritime Area Planning (MAP) Act 2021 aimed at harnessing Ireland's offshore wind potential while protecting our marine environment.
- The Marine Area Consent process is now open for relevant projects, it should be noted that the Arklow Bank Wind Farm, which is Ireland's first offshore wind farm, is at an advanced stage of planning and has been operating under an earlier consent regime. SSE has recently announced its intention to apply for a larger more ambitious project under the new MAC scheme.
- An Bord Pleanála granted planning permission to SSE Renewables to develop the onshore grid infrastructure necessary to connect the 800MW Phase 2 of Arklow Bank Wind Park.
- Codling Windpark has submitted their Marine Area Consent application, this is a very significant milestone in the development of Ireland's largest offshore windfarm.
- Shelmalere Offshore Windfarm (DP Energy Iberdola) has completed consultation on its EIAR



• Bord na Mona Ocean Winds Réalt na Mara Offshore Windfarm has delivered a number of community engagement clinics and is seeking to further engage with the local authority.

The next significant milestone will be the announcement of the Offshore Renewable Energy Support Scheme (ORESS) Auction either later in 2022 or early 2023. Under ORESS eligible projects will be invited to bid to deliver renewable energy services. The Community Benefit Fund associated with the ORESS Auction will be significant.

#### Food and Beverage Strategy

Funding of €175,000 has been secured via the LEADER Food Programme for a Food and Beverage Coordinator role for Wicklow Naturally CLG and for the supply of event costs for the period 2021 - 2023 in support of Wicklow Naturally's Promotional Activities Plan. Wicklow Naturally will contribute 5% from subscriptions and it is proposed that Wicklow County Council will contribute €35,000 over the two year life of the project.

Wicklow Naturally continues to increase its network of members in 2022 to add to the array of County Wicklow produce. Wicklow Naturally members will be represented at a range of events throughout the year including Taste of Wicklow, the Tinahely show, Ploughing Championships, OctoberFeast and Gifted; all aimed at raising the profile of Wicklow produce. Wicklow Naturally and its members continue to receive coverage in national and international media including Lonely Planet, Farmers Journal, Forbes and Nationwide.

Wicklow Naturally, supported by Wicklow County Council was successful in securing funding from the Department of Agriculture, Food and the Marine in respect of the development of Farm to Fork Trails as part of Wicklow's tourism offering. Wicklow Naturally has worked with Wicklow Tourism to develop this product. A number of trails have been identified, with photography, videography and a pilot tour took place in July.

The launch of Farm to fork trails was held on 31<sup>st</sup> August as part of the Wicklow Naturally food promotion campaign and was hosted by renowned chef Catherine Fulvio in the gardens of Ballyknocken House and Cookery School.



The Farm to Fork Trails will include guided and self-guided tours throughout County Wicklow. The trails aim to showcase the best of Wicklow food and drinks producers and providers, connecting the visitors' experience from Farm to Fork and offering a true taste of the Garden County.

Guided tours include return coach travel to several destinations such as farms, historic houses, food and drinks producers, farmers markets etc. Self-guided tours can be facilitated also.

It is hoped that the initiative will further enhance the reputation of County Wicklow as a great destination for quality food and drink.

### **Skills Taskforce for County Wicklow**

A Skills Taskforce Chaired by the Chief Executive has now been set up following meeting held on the 20<sup>th</sup> of July to coordinate key stakeholders, in partnership between Government, industry, and education and training providers, to continue with engagement and explore areas of collaboration to build skills education and training programmes in County Wicklow, including the Wicklow County Campus, that will meet the future employment needs of the sectors.

The Skills Taskforce will meet on Friday 23<sup>rd</sup> September 2022 and it is expected to receive a report from the Sub Group / Education Sub Committee. It is also expected that nominations from the three industries, i.e. renewables, food and the screen sector will be agreed.

Wicklow County Council will shortly be advertising for consultants to carry out a skills audit to identify existing skills and competencies and future skills required to support economic development in the County.

### 3. Planning and Development

#### **County Development Plan**

The Proposed Material Amendments (PMA's) to the Draft County Development Plan 2022 – 2028 went on display from 27 April - 25 May 2022. 76 submissions were received. The 3<sup>rd</sup> CE report, which goes through each of the PMA's and the valid submissions received, was issued to the members on Tuesday 26 July and is available to view online <u>https://www.wicklow.ie/Living/Services/Planning/Development-Plans-Strategies/National-Regional-County-Plans/Wicklow-County-Development-Plan-2022-2028/Stage-6</u>

The members will return for a final meeting (12 September 2022) to decide on each amendment, and then adopt the final plan.

#### Local Area Plans

The Forward Planning Department has commenced work on the preparation on new LAPs for Greystones – Delgany & Kilcoole, Wicklow Town & Rathnew and Blessington (which will be delivered in that order). The team are at the data gathering and surveying stage, and will be consulting with all internal departments and state agencies over the next few weeks

#### Residential Zoned Land Tax

This is a new tax to activate vacant land for residential purposes, and which will in time replace the Vacant Site Levy, was enacted as a part of the Finance Act 2021, as referred to in Circular NRUP 06/2021 of 22 December 2021. The aim of the tax is to activate and bring forward the development of housing on lands which are suitably zoned and serviced, as indicated on maps to be prepared and published by local authorities for their respective functional areas. These maps are to be published by 01 November 2022. The legislation also sets out certain lands which are to be excluded from the scope of the tax. The tax measure is intended to encourage activation of existing planning permissions on lands which are identified as being in scope and to incentivise owners of suitable lands without planning permission to commence the process of engagement with Planning Authorities.

While residential zonings which include existing dwellings are to be included on the map(s), where connected or able to be connected to services, permanently occupied residential premises which are liable for Local Property Tax will not be liable for the tax.

**Pollinator resources** – Advice and resources available. Over 200 'managed for wildlife' and 'Don't mow let it Grow' outdoor signs distributed to MDs and members of public. Noticeable increase in pollinator friendly management at roadside verges, roundabouts and open spaces.

**East Coast Nature Reserve Events:** Monthly seasonal free public event programme in place in partnership with Bird Watch Ireland at East Coast Nature Reserve. Dragonfly themed outing held for Heritage Week, 50+ attendance.

**Brittas Bay Conservation project** (Works underway supported by Local Biodiversity Action Plan funding allocation):

- Continuation of conservation measures
- Recording & monitoring (incl citizen science)
- Community Engagement programme Heritage Week digital project

**Conservation Management Plans for WCC owned land at Bray Head and Wicklow Head:** RFT process complete, ecological consultants appointed and work underway at Bray.

### Climate Action (Built Heritage - Archaeology):

**Community Monuments Fund (CMF) :** Funding to increase the resilience of our Built Heritage (archaeology) to climate change via Community Monument Fund (CMF) 2022- Seven CMF projects currently underway, overseen by Heritage Officer, allocations as follows:

#### Whitestown Remediation Project

Wicklow County Council has employed Fehily Timoney & Company to advise on the remediation of the site at Whitestown, in accordance with the judgments of Mr. Justice Humphreys

The first draft remediation plan was lodged with Brownfield restoration Ireland Limited (BRIL) on 27th November 2020. Following submissions from a number of parties a revised remediation plan, which incorporated requests contained in the submissions, was circulated on the 28th April 2022. Submissions on the revised remediation plan have been received from a number of parties and work is ongoing in reviewing these submissions and to submit the final Remediation Plan and NIS to the court before the end of September 2022.

#### **Climate Action**

#### **Climate Action Plan 2021 – Securing Our Future**

The Climate Action Plan, which was launched on 4<sup>th</sup> November 2021, is an ambitious plan to put Ireland on a more sustainable path, cutting emissions and creating a cleaner, greener economy and society



The Climate Action Plan follows the Climate Act 2021, which commits Ireland to a legally binding target of netzero greenhouse gas emissions no later than 2050, and a reduction of 51% by 2030. These targets are a key pillar of the Programme for Government.

The plan sets out 475 separate actions to halve Ireland's greenhouse emissions by 2030, including extensive offshore wind power, retrofitting 500,000 homes and putting a million electric vehicles on the roads.

The public sector will lead by example and halve emissions by 2030. Green Teams will be established in every public sector body. No new fossil fuel heating systems will be installed in public buildings after 2023, except in very limited exceptional circumstances. All new fleet purchases will be electric from 2023, where such vehicles are available.

A new National Retrofit Plan will drive demand and make retrofitting more affordable whilst there are increased targets for district heating and the public sector and strengthening building standards for all buildings.

Just transition principles are embedded in the plan, including the principles that people need to be equipped with the skills to benefit from changes and that costs need to be shared. A Just Transition Commission will be established.

All increases in carbon tax receipts are earmarked for targeted social protection measures, an expansion of retrofitting, particularly for social and low-income homes, and agri-environmental projects.

Wicklow County Council will commence the Advance Planning Stage of the development of Wicklow's Climate Action Plan in Q2 of 2022. This will include a review of the Climate Adaptation Strategy adopted in September 2019 and a Countywide Baseline Emissions Inventory (BEI). As such the plan will incorporate both climate mitigation and adaptation measures.

### **Wicklow Climate Action**

### Mid-East Energy Unit

Wicklow County Council, in partnership with Meath and Kildare County Councils is establishing the Mid East Energy Unit. As lead authority, Wicklow County Council is at the final stages of signing a MOU with the SEAI to progress the establishment of the Energy Unit.

Service Level Agreements between Wicklow and the partnering authorities are being progressed in parallel. Work within the energy unity will deliver on public sector energy efficiency and energy reduction projects via the SEAI Pathfinder scheme which includes 50% funding for these projects from the SEAI.

Arklow Decarbonisation Project: RPS Consulting Engineers has delivered the Baseline Emissions Inventory, the Register of Opportunities and Placemaking and Active Travel Reports and the draft Implementation Plan. The Final



Implementation Plan will be delivered in the coming weeks. The DZ Implementation Plan will become a chapter of the Climate Action Plan.

#### **Bicycle Parking**

• Create bicycle friendly buildings for employees and visitors, by putting bicycle parking in place by 2022 – which is secure, accessible and simple for cyclists to recognise and use.

As per this action in the Climate Action mandate for the public sector - Work has commenced to identify suitable locations to install bicycle parking at our public buildings.

A **National EV Strategy** was launched by the Department of Transport in March. This strategy places an onus on the Public Sector to increase EV penetration in the public sector fleet, to coordinate the delivery of infrastructure across all levels of government and to facilitate the development of a comprehensive mixed-type EV charge point network serving the needs of all citizens. The Climate Action Officer is coordinating an input from a number of departments to develop a strategy for the Council on the rollout of EV Chargers in the public domain and TWES are working on transitioning the Council fleet to EVs.

The Green Team are working on a number of initiatives:

- A draft Paper Use Policy has been drawn up.
- Eco friendly cleaning products for our buildings
- A staff travel survey which may result in car pooling
- Home Energy Retrofit Information day for Staff and use of the Home Energy Saving Kit.
- A number of members will attend training in September.

ALCNature have been appointed to develop a **Conservation Management Plan for Bray Head and Wicklow Head**. For Wicklow Head an initial meeting has been held between the Climate Action Team, Forward Planning and Sports Partnership to ensure there is a smooth crossover between the plans being developed by each section

### **Environmental Awareness**

- Kids educational workshops were held on the four Blue Flag beaches and Arklow Beach. The workshops were given by Seashore Kids and are part of our Blue Flag education programme. All were well attended. A second workshop was held in Arklow due to high demand.
- A Bikes' for Africa project with the Rotary Clubs of Wicklow and Bray began receiving bikes. Bikes are
  accepted in all recycling centres with a storage facility installed in Arklow. The bikes will be repaired at
  Shelton Abbey Open Prison before being shipped to The Gambia. Good sturdy bikes suitable for students
  commuting to school are being sought. The project was funded under the anti-dumping initiative and



helps to develop circular economy activity in our recycling centres. The target of 120 good quality bikes was achieved by the end of August.

- An LAPN project is linking to the Bikes for Africa project and involved delivery of workshops on bicycle repair in the three larger recycling centres and a video animation to promote extending the life of bicycles through good maintenance. The video was used to advertise the workshops. All workshops programmed for the first week of August were fully booked and more workshops will be programmed for September.
- The annual Tidy Towns, Estates and Sustainable Development awards for Tidy Towns, residents associations, community groups, businesses and schools were judged. The awards have been linked to the Sustainable Development Goals.
- Wicklow County Council is one of twelve local authorities that partnered to deliver a new dog fouling campaign which contains six videos, seven social media posts, one gif and an advertisement for the local papers. The campaign continued over the summer months. The campaign aims to highlight the impact of dog fouling on all while reminding owners of their responsibility to pick up after their dog. The campaign was well supported on social media with many sharing the campaign posts.
- The annual tree grant to support planting of native trees and hedgerows in communities has been launched and is now open for application. 75% of the cost of planting trees is grant aided. Applications are coming in ahead of the September deadline.
- An LAPN project to provide training on composting has now been completed and a case study was
  prepared. The project was extended to provide training for Newcastle Tidy Towns with a site developed at
  the community centre during July and August.
- Second hand school books sales were held in Arklow, Bray and Wicklow recycling centres in association with local scout troops. The sales were popular with a good turnover of books and funds raised for the scouts.
- A Climate Action for TY event is being planned for October. It will be held in the Brockagh Centre and Raoul Empey of Sustineo will be the key note speaker. Relove Fashion was also relaunched for schools.

### Sustainable Energy Committees

Greystones/Delgany and Wicklow Town SECs both completed their energy master plans. A claim for the SEAI funding has been submitted.

The Energy Master Plan for Enniskerry I snow complete. Work is near completion on the Energy Map Plans, EMPs for High Park and Blessington. In Arklow survey work is being undertaken. A new application for an Energy Master Plan has been received from Carnew Community Care. Newtownmountkennedy, Glenmalure and Laragh have also completed Energy Master Plans.

A meeting was held with Dunleer Sustainable Energy Community to explore collaboration with their team sharing their experiences of delivering energy efficiency and renewables projects in their community.

#### M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website www.n11m11.ie on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding has been provided to continue during 2022.

Wicklow County Council project team are continuing to meet with the public and any interested parties.

#### M11N11 Bus Priority Interim Scheme

The BPIS seeks to achieve the early delivery of bus priority measures in advance of the main scheme between Loughlinstown Roundabout to Junction 9 (Glenview).

The BPIS web site is now available on www.n11m11bpis.ie. This website will provide up to date information on the progress of the scheme.

#### N11 Parallel Service Road at Kilmacanogue

A noise assessment of the 7 no residential properties that are adjacent to the new Parallel Service Road Scheme was carried out during April and May 2022. The draft report concluded that the change in junction layout does not change the noise levels at nearby properties when compared to the previous layout. However, when road traffic speeds are increased to 100kph along the N11, noise levels were elevated at the nearest noise sensitive locations by up to 4.5 dB Lden. This would cause a potentially significant impact to the receptors along the N11. Following on from this report, feasible noise mitigation measures are now being investigated.

#### N81 Knockroe Bend Realignment

The tenders for the Per Cent Art Feature are being procured by the Arts Officer.

#### N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following completion of Transport Infrastructure Ireland (TII) Phase 1 feasibility studies (N81 Four Studies – Feasibility Report), Wicklow County Council will now look to progress the following two projects:

- N81 Whitestown Lower Project; and
- N81 Hangman's Bend and Tuckmill Project.

Wicklow County Council will commence procurement for Technical Advisors to undertake TII Project Management Guideline Phases 2 to 4 (inclusive) for the above projects, with the aim to procure an advisor and commence in 2022.

#### N81 Pavement Capital Works

Resurfacing works of 1km of the N81 between Tuckmill and Saundersgrove will be tendered for in 2022. The design of the pavement is being carried out, expected to be completed by Quarter 3.

### N81 Capital Maintenance

Resurfacing work at Monaspick and Annalecky was completed in May.



Applications for funding for drainage works at Mullycagh and Tinode have been approved and works are to be completed in Quarter 3.

#### N81 Fencing Retrofit

The contract for the fencing will commence in Q3.

#### **N81 Invasive Species Removal**

The contract has been awarded for the removal of invasive species identified along the N81. Works are to commence in Quarter 3.

#### Arklow Public Realm

Construction works activities are well advanced with the following elements completed or under construction at the present time:

Install pedestrian crossings top of lane
Prepare subbase for tarmacadam
Main Street – North side of road adjacent courthouse
Complete ducting
Reduce ground and backfill
New connection to watermain for the feed to the courthouse
Kerbing and preparation of paving.

#### Arklow to Shillelagh Greenway

Options Report to be finalised for a few sections of the greenway. Once discussed with the landowners, the emerging preferred route will be finalised and public consultation undertaken. Tenders have been sought for the role of Independent Agronomist, it is anticipated that the independent agronomist will be appointed in the very near future. Once appointed, the Agronomist's details will be communicated to Landowners.

#### Baltinglass Town Centre Plan

Wicklow County Council has conducted the procurement process for a contractor and submitted the Tender Report and recommendation. Additional funding is required over and above the original allocation and is under consideration. Award of contract is to be undertaken once approvals have been obtained.

#### Blessington Inner Relief Road

Review of detailed design along with potential SUD strategies for the scheme is underway. Additional topographical surveys were undertaken in July and August to assist in the preparation of documents to allow the Council to seek statutory approval.

# Wicklow County Council Compulsory Purchase (Chapel Road Pedestrian and Cycle Infrastructure Improvement Scheme) No. 1 Order 2021



Consultants continue to proceed with the detailed design and tender preparation. Notice to Treat will be issued within the next month which will commence formal discussions on compensation.

#### **Redford Junction**

This is to upgrade the existing signal-controlled Redford Park Junction consisting of improvements for pedestrians and cyclist with the upgrade of footpaths and the inclusion of protected cycle track facilities, as well as an improvement through the upgrade of two existing bus stops in the immediate vicinity of the junction. Report to Members on the Part 8 Consultation has been finalised and will be brought before the Members of the Greystones Municipal District Council at the first available meeting in Autumn 2022.

Revised Information requests were extremely high in August for both Commencement Notices and Certificate of Compliance on Completion, 86% of submissions required revised information in August. It should be further noted that some Opt Out Submissions are requiring 2 to 3 Revised information requests which results in submissions being assessed 2 to 3 times to ensure compliance prior to commencement.

Opt Out submissions are both extensions and single unit dwellings, generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt Out Submissions.

NBC & MSO Quarterly Newsletter dated June 2022 has requested LA's to focus resources on compliance with Building Regulations in Opt Out Submissions, Wicklow Building Control continue to perform rigorous assessment





of submissions at commencement stage and onsite presence during constructions. These methods remain the best way to promote compliance with Building Regs.


