Lissolemen (Parish) (contd.)

Esqre., Coolstin Park & Post town Tinehaly. About half of the Psh. arable land, remainder grazing. Two grave yards in Psh., one in Knocklow East & the other in Lissolemen T.Ld. - Two meats in Psh. and five Raths, the largest of which (a very extensive one) is in Rath East T.Ld. - There are two very good houses in the Psh.; Knocklow East not inhabited at present and Rath House, the residence of B. R. Whelan Esqre. The road from Tullow to Carnew passes along the South side of the Parish. The River Deerin bounds the West side of the Psh. The Psh. is part of the Union of Aghold. No place of worship within the Psh. Nearest Market and Post town, Tullow, distant about two miles.

Surface undulating; three fourths aft of this T.Land in Grazing, the remainder under cultivation. Market & post Town, Tullow, Distant one and a half miles. Knocklow Ho. in this T.Ld., not inhabited at present. Two raths in T.Ld. Road fr from Tullow to Carnew passes along the South side. River Deerin bounds the N.W. side. A grave yard on N.W. side of T.Ld.
