Proposed: 20 No. Social dwellings-Barndarraig Ballinacor East, Co. Wicklow

Appropriate Assessment (AA) Screening Determination

Pursuant to the requirements of the above, Wicklow County Council is proposing to construct a housing development consisting of the construction of 20 No. Social dwelling together with all associated site works at Barndarraig Ballinacor East, Co. Wicklow. The accommodation shall consist of the following: 4 No. 3 bed 2 storey houses, 10 No. 2 bed 2 storey houses, 3 No. Age-Friendly 1 storey house and 3 No. group housing consisting of 1 No. 2 bed and 2 No. 3 bed detached houses.

It is intended to place the plans and particulars for the proposed development on public display in accordance with the requirements of the Part XI of the Planning and Development Act 2000 (as amended) and Part 8 of the Planning and Development Regulations, 2001 (as amended)

Having regard to Article 6 of the Habitats Directive 92/43/EEC and (inter alia) the Department of Housing Planning Community and Local Government's *Appropriate Assessment of Plans and Project in Ireland Guidance for Planning Authorities (2010)*, Screening of the development for Appropriate Assessment was carried out in March 2025 by Moore Group — Environmental Services


Following an examination, analysis and evaluation of the relevant information, including in particular the nature of the project and its potential relationship with European sites and their conservation objectives, as well as considering other plans and project and applying the precautionary principle, the screening has determined that there is no potential for likely significant effects on any European sites.

For the reasons outlined above it is considered that the application for consent for the proposed development does not require an Appropriate Assessment or the preparation of Natura Impact Statement (NIS)
