
PUBLIC NOTICE

The Maritime Area Planning Act 2021 and the European Communities (Birds and Natural Habitats) Regulations 2011

Invitation for public submissions on an application for a maritime usage licence and an appropriate assessment

Electricity Supply Board has applied to the Maritime Area Regulatory Authority ("MARA") for a maritime usage licence under section 117 of the Maritime Area Planning Act 2021 to undertake marine environmental surveys for the purposes of site investigation at Moneypoint, Co.Clare. Marine site investigation works will include marine geophysical surveys, marine environmental/ecological surveys and metocean Surveys. The proposed geophysical surveys include MultiBeam echosounder, sub-bottom profiler, side scan sonar and magnetometer surveys and may also incorporate visual surveys e.g. drop down video or remotely operated vehicle. Marine geotechnical surveys i.e. sampling/coring boreholes at 20 locations to a maximum of 30m investigation depth below seabed level and vibrocores at approximately 25 locations. The licence application is for a period of 3 years.



A related Natura impact statement has been submitted with the above licence application. 
