Sir John Boorman Honoured by Wicklow County Council

World famous film director and long-time Wicklow resident, Sir John Boorman, was honoured by Wicklow County Council today (Weds) with a Lifetime Achievement Award.

Mr Boorman, who directed such films as 'Deliverance' and 'The General' has made Wicklow his home for a long number of years. He now plans to return to his native England to be closer to family.

At a ceremony in County Buildings, Wicklow, the Council conferred a civic award for a lifetime contribution to the screen industry and through this and his lifelong commitment to the natural world bringing enrichment and honour to County Wicklow.

Wicklow included in list of 'Best of the World 2023' Destinations

Wicklow has been included in a 'Best of the World 2023' list of destinations by the famous National Geographic magazine.

National Geographic has compiled its annual Traveller's 'Best of the World' list recommending 35 destinations for 2023. The selection is split into five categories: Adventures, Culture, Nature, Family and Community.

The list highlights some of the most exciting and exceptional experiences on the planet, 25 of those selected by National Geographic global editors, and another 10 selected by the UK edition.

Wicklow is featured as one of the top family destinations alongside San Francisco, Trinidad and Tobago, Colombia, Manchester, Switzerland and Bath.

Beyond the Trees Avondale Recognised as a World Leader

Age Friendly Ireland has awarded Age Friendly recognition to Beyond the Trees Avondale, acknowledging it as the first age friendly tourist destination in the country.

Beyond the Trees Avondale received its official Age Friendly Charter and will now also be recognised by the World Health Organisation (WHO) as an international model of good practice for age friendly development.

Beyond the Trees is a spectacular new visitor destination, developed in partnership between Coillte, Fáilte Ireland and EAK Ireland in Avondale Forest Park, County Wicklow, combining a stunning 700 metre Treetop Walk with a 12-story high Viewing Tower, created for the project by EAK Ireland.

Age friendly principles were incorporated into Beyond the Trees Avondale in order to ensure its ease of use and accessibility across the life course.

Further long-term vacant properties are currently being identified for future batches of CPOs.

Further reports relating to Co Wicklow on www.vacanthomes.ie were received in June. Information received from the public in this manner is crucial to identifying vacant houses and to taking action.



Since it began in 2017 we have received 206 reports relating to Co. Wicklow. 12% of these contained insufficient information to identify the house in question. 21% of reports related to the same house (often multiple reports submitted by the same person).

Croí Cónaithe (Towns)

This is a new scheme announced by the Department of Housing, Heritage and Local Govt in July 2022. Up to €30,000 grant available for houses which are:

- Vacant for more than 2 years.
- Built prior to 1993.
- Within a town or village (rural houses not covered).
- To be used as the applicant's permanent dwelling.

The grant amount can be increased to €50,000 in cases where the building is Dangerous or Structurally Unsound (requires an Engineers Report). Buildings which are currently non-residential (such as vacant commercial units – shops etc) but which the applicant intends to convert to residential use, can also qualify.

It is intended to revitalise towns and villages by addressing vacancy and dereliction.

A small number of applications have been received and a number of enquiries about the scheme have been received and answered.

4 houses that were approved for sale at the January Housing and Corporate Estate SPC meeting are being advertised for sale to either existing tenants of Wicklow County Council or persons on the WCC social housing list.

Housing Maintenance - Heating Upgrade Programme

The adopted budget for 2022 is €236,000 and due to the significant increase in cost of new installations, only 19 houses will be done in 2022. 17 of those installations were complete as of 11th of October.

Housing Maintenance - Boiler servicing & safety checking campaign

The focus now is on servicing and safety checking of 1416 Oil and 2269 Gas boilers around the county. Contractors are reporting **access rates as low as 60%** which is surprising given the current "Cost of Living" crisis with high fuel costs. It is in tenants' interests to ensure that they provide access to contractors to service and safety check boilers. Oil boilers in particular will consume more fuel if soot build up is not removed at the annual service. Also important checks and replacement of components such as fuel hoses are carried out on oil boilers which prevents expensive loss of fuel and environmental damage which is extremely expensive to clean up. All new boilers fitted now are condensing boilers which have higher thermal efficiency and use less fuel.

The Homeless HAP Place finder provides assistance in:

- > seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness;
- > liaising with specific households to establish their specific needs;
- > establishing relationships with local property agents and landlords; and,
- > supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- ➤ To date, 416 households (306 families & 105 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October 2018 to 31st October 2022. (180 homeless cases, 227 prevention cases to date and 9 direct provision). 124 properties were sourced by WCC.

Addressing Homelessness in partnership with Approved Housing Bodies

Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

There are 11 clients supported in the Kilmantin Hill facility, operated by Dublin Simon, with continuing transition by the clients to suitable, alternative accommodation.

Homeless Family Service - Fitzwilliam Road, Wicklow

Dublin Simon has been engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of 3 x 1 bed units 2 x 2 bed units and 2 x 3 bed units - Refurbishment works and snagging are now complete.

All of the apartments in the hub are now occupied.

It is envisaged that families will avail of the service for circa 6 month STA (Supported Temporary Accommodation) with key working support to enable family's transition from homelessness into Homeless HAP or alternative longer term accommodation.



Homeless Supported Temporary Accommodation - San Remo, Bray

San Remo opened to clients in October 2020. The facility, operated by Dublin Simon, incorporates a service model where there are a number of emergency/cold weather Beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

The Neighbourhood Liaison Committee is now operational and meets monthly.

Bi- monthly meetings are held with Dublin Simon and Wicklow County Council staff

Homeless Supported Accommodation - Carraig Eden, Greystones

The facility providing 35 ensuite bedrooms with associated kitchens and common areas is fully operational. Wicklow County Council have made arrangements to run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients.

Housing First

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid-East Region. Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Housing first recognises that a stable home provides the basis for recovery in other areas.

Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the implementation of the programme.

Wicklow County Council has, to date, successfully accommodated 12 clients under Housing First and it is hoped that 1 further allocations will take place before the end of 2022. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation – the main issue facing this programme is the availability of one bed units in suitable locations with easy access to services etc.

Traveller Accommodation

A mid-term review of the Traveller Accommodation Plan 2019 - 2024 has been completed and submitted to the Traveller Accommodation Unit.

Ukrainian Response

As of 11th November the numbers of Ukrainians Displaced Persons in emergency type accommodation is 1,350
(although we know that there are considerably more in the County)

- WCC are currently assessing all Displaced Ukrainians persons in the County in order to identify their accommodation needs as well linking them in with all the relevant services and supports within the community.
- WCC are working through a list of pledged properties within the County and matching families accordingly. As of the 14th October we will have housed 131 number displaced Ukrainian people. Larger buildings and vacant units are also being identified and explored as potential options for medium to long term accommodation.
- A new National Vacant Home call which will be lead be Local Authorities will launch on 24th November called "Offer a
 Home". A property can be offered directly to Wicklow County Council and the Ukraine Response Team will be
 responsible for these pledges.
- The Community Response Forum continues to meet on a fortnightly basis

Age Friendly Ireland

County Wicklow Age Friendly Strategy 2023-2027

The strategic goals and actions for the new 5 year strategy, developed in consultation with individual members of the Age Friendly Alliance, were presented to the full meeting of the Age Friendly Alliance in September and adopted by the Alliance. The full draft to the Age Friendly Strategy 2023-2027, will be presented to the Alliance at its next meeting, in December.

Beyond The Trees Avondale - National Recognition as Age Friendly Tourist Destination

Beyond the Trees Avondale' received national recognition as the first age friendly tourist destination in the country. Minister Mary Butler TD presented its official Age Friendly Charter, at a launch event on 3rd November. It is now recognised by the World Health Organisation (WHO) as an international model of good practice for age friendly development. A case study publication was also launched by Age Friendly Ireland, outlining the work undertaken at Beyond the Trees Avondale, with input from members of the Older People's Council and Disability and inclusion Steering Committee.









Older Person's Council

The Older Person's Council (OPC) – met in September and October, to agree on the programme for the annual Seminar and Open Day scheduled for 25th November. Preliminary results of the research commissioned by the OPC, in collaboration with Citizens Information Services and MABS, older people's use of financial services on the internet in County Wicklow will be presented at the Seminar. Speakers from MABS, Sage Advocacy and Alone have also been confirmed for the Nov 25th Event, which will be held in the Brockagh Resource Centre, Laragh.

Triobikes for Community Care

Wicklow County Council have purchased two triobikes, with funding from the Outdoor Recreation Infrastructure Scheme, these will be deployed to two community care centres for the use of older people in their care and vulnerable older adults with limited mobility, for outdoor recreation.

The Bikes arrived in September and will be deployed when assembly is completed and pilot training has been scheduled.






Disability Inclusion Steering Committee Update





Ukrainian Refugee Health and Wellbeing Support

Wicklow County Council has received notification from the Department of Health that an additional allocation of €28,575 is being made available to the Local Authority for Ukrainian Refugee health and wellbeing support. The proposed activations under this programme must be submitted to the Department by the 18th November for the purpose of improving the health and wellbeing of Ukrainian Refugees. Collaboration between Wicklow County Council, Bray Area Partnership and County Wicklow Partnership is ongoing in planning interventions and delivering initiatives for this element of funding.

Bray Community Addiction Team Stabilisation Programme

Bray Community Addiction Team is running 12 week stabilisation course in Wicklow Town for active drug users. The aim of the course is for service users to potentially reduce their drug use. As part of this course Healthy Wicklow is funding 3 weeks of healthy food made easy and 3 weeks of yoga/creative element which commences on 9th November.

Active Communities

Tinahely/Shillelagh/Carnew



A Cool Dude 5 week healthy eating programme started in Crossbridge national school on the 7th November for the 16 pupils in 5th & 6th class. A dance and healthy food made easy programme will commence on the 10th November for Tinahely active retirement group for 5 weeks. Local physio David Blake is starting a 4 week injury prevention course for Knockananna women's group on the 17th November.

Rathnew

Two active on the green events are taking place in Drumkay and Hazelbrook Rathnew on the 12th and 19th November respectively. On the day there will be representation from Leinster Rugby to deliver drills/fun activities and Aisling Nolan will also be there to deliver a pound taster session. The hugely popular

giant garden games will also be available. A 4 week walk and talk programme is starting on Wednesday 23rd and will take place every Wednesday and Friday evening.

Social Inclusion Community Activation Programme (SICAP)

- Bray Area Partnership and Co. Wicklow Partnership have been successful in their applications to the government's International Protection Integration Fund (IPIF) which supports the integration of International Protection Applicants/asylum seekers. Bray Area Partnership have been awarded €20,000 and Co. Wicklow Partnership €16,600. Projects will begin shortly.
- Both Partnerships are currently compiling their SICAP Annual Plans 2023 and have sought voluntary increases in relation to the number of individuals they will support next year. In 2023 BAP will work with 477 individuals and CWP will work with 376. The deadline for submission of Annual Plans is November 18th after which time the plans will be assessed by the LCDC and Pobal.

Men's Shed Funding

The Minister for Rural and Community Development, Heather Humphreys TD, has announced funding of €800,000 to support Men's Sheds. The initiative will see grants of €2,000 provided to over 400 Men's Sheds nationwide to assist them with running costs such as electricity or insurance bills. The individual grants will be distributed to the over 400 Men's Sheds via its representative body, the Irish Men's Sheds Association (IMSA).

Blessington eGreenway

An Bord Pleanála had listed the decision date on the planning submission for the Blessington eGreenway Project, as the 25th October 2022. No decision on the Project has received from the Bord on this date. A new decision date is not available and Wicklow County Council awaits correspondence from the Bord.



Economic Development, Planning, and Infrastructure

1. Economic Development

Local Economic and Community Plan (LECP) (Economic)

The Economic Development Unit of the Enterprise and Corporate Services Directorate is charged with implementing the economic actions in the Local Economic and Community Plan (LECP). LECPs detail how Local Authorities will support economic and community development in their areas.

The next Wicklow Local Economic and Community Plan (LECP) 2023 – 2029 will set out, for a six-year period, the objectives and actions needed to promote and support the economic development and the local and community development of County Wicklow, both directly and in partnership with other economic and community development stakeholders.

5 High Level Goals have been identified incorporating both Community and Economic Development. The Economic Development unit is seeking to engage with the business community and government and local agencies to help identify priorities for the County over the lifetime of the plan.

Wicklow County Council has appointed a team of consultants from People and Place to assist with the preparation of the LECP. The timeline for completion of the Plan is end of 2023.

Retail

Bray Central

The transfer of Title took place on 28th October 2022. Since then two restaurants and the car park with 250 spaces have opened. Oakmount continue to engage with prospective anchor tenants on the two main units in the centre. It is hoped that agreements to let will be settled in the coming weeks. Oakmount has advised that there are leases in place on all of the leisure spaces and heads of terms are agreed with several new retail units.

Town Teams

Under the Government policy, Town Centres First, the establishment of Town Teams is encouraged and we are likely to see more Town Teams in situ over the coming years.



Town Teams in Wicklow have been operating since 2016. It is considered timely to carry out a review of the town teams and with this in mind Wicklow County Council appointed Mr Allen McAdam of MCA Consulting to conduct the review. The result of the review was presented to the elected members at their October meeting and a response is being prepared in respect of the points raised.

The review is currently being presented to the Town Teams and it is proposed to have a plenary session with all Town Teams early in 2023 when the TRO is in place. Interviews have been held recently to appoint the Town Regeneration Officer and it is expected that she will be in place early in the New Year.

Blessington Town Centre First Masterplan

Blessington has been awarded funding of €100,000 to develop a Master Plan for the town under the Town Centre First policy. This will also allow plans for projects identified as part of the drive to become e-Greenway ready to be advanced.

This initiative is a key part of Our Rural Future – the Government's ambitious five-year strategy designed to reimagine and revitalise rural Ireland. It is also linked to the Government's Housing for All strategy and a key component of the Town Centre First policy.

Wicklow County Council will work closely with local community groups, retailers and members of the Town Team in devising and delivering on the objectives of the Masterplan building on the very comprehensive Health Check carried out by Future Analytics.

Blessington Town Team

At the most recent Blessington Town Team meeting held on 27th of September last, updates on the following projects were given to the town team members.

- Progress on the Blessington Inner Relief Road.
- An update on the Towns First Policy.
- The Blessington RRDF.
- Progress on the Blessington CCTV scheme.
- The ongoing work of the Tidy Towns group.

The next meeting is due to take place on the 29th November 2022

Arklow Town Team

A new Arklow Pottery website was launched on the 11th November in Arklow Library. The website explores and records the history and heritage of Arklow Pottery. The project was initiated by Arklow Town Team and funded by The Heritage Council. The website offers its visitors the opportunity to follow the Arklow Pottery Trail through the town. The website has been well received by many families who have a connection with Arklow Pottery and by visitors to the town with an interest in pottery and antiques. A feasibility study for the Ballyduff weir has been completed by CDM Smith Ireland Ltd. The report identifies the optimum solution for fish to move through an impassable barrier at Glenart Ornamental weir on the Ballyduff River in the Avoca catchment.

Bray Town Team / Bray Town Recovery Team

Terms of reference were issued to the Bray MD Members in 2021. The Cathaoirleach is reviewing these and will be examining the best way forward.

Wicklow Town Team

Wicklow MD is progressing the Part 8 to reconnect Wicklow Town Centre and the South Quay through its network of laneways was advertised and put on public display on the 26th October. The project, which is funded through Town and Village funding seeks to reanimate and revitalise these important central links between South Quay, Harbour and Port, Main Street and Market Square through lighting and some large-scale public artwork. The theme throughout the project will have a local and maritime focus. Closing date for submissions is the 12th December 2022.

The AGM of Wicklow Town Team was held on the 29th September. Wicklow Town Team has now been in existence for 5 year. Reports were provided from the working groups.

The Heritage trail has been a great success with over 500 people taking part in the guided walks. A Wicklow Camino Trail and Ballyguile to Dunbur Scenic Walking route is also being explored.

Discussions regarding with Wicklow MD re Part 8 and Licence to provide the Murrough Bike Track are underway.

Greystones Town Team

The Christmas Lights will be switched on in Greystones on Saturday 19th November, 2022 and Santa and his helpers will arrive from Hollyhead. The parade will follow a route throughout the district on the day also. This event is co-ordinated by the Greystones Town Team with the support of Greystones MD

A Ladies Night will take place in Greystones on Thursday 24th November 2022. Local businesses will be open on the night and provide an opportunity to shop local and enjoy some entertainment on the night too.

Tourism

Tourism Strategy and Marketing Plan 2018-2022

The strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the next 5 years

Wicklow Included in Best of the World 2023 destinations by National Geographic

Wicklow has been included in a 'Best of the World 2023' list of destinations by the famous National Geographic magazine. Wicklow is featured as one of the top family destinations alongside San Francisco, Trinidad and Tobago, Colombia, Manchester, Switzerland and Bath. Special mention is given to 'Beyond the Trees – Avondale,' its canopy walk, 12 story tower and Ireland's tallest slide.

Avondale recognised as First Age Friendly Tourism Destination in Ireland

Beyond the Trees Avondale received its official Age Friendly Charter and is also recognised by the World Health Organisation (WHO) as an international model of good practice for age friendly development.

Autumn Colours of Wicklow

Wicklow Tourism produced a promotional blog focussed on autumn colours in Wicklow. Wicklow is home to the largest forestry area in Ireland. It is probably where autumn colours can be best experienced when from October to December, the 'fifty shades of green' turn to Brown, red, yellow and gold!

Bray International Flavours

In October, we decided to focus on the various restaurants around the Bray area offering distinctive international flavours. We have compiled a list of appetising, award-winning venues providing internationally renowned food from highly skilled chefs.

France TV shoots in Killruddery

France Television is the biggest TV group in France and Wicklow were host to a crew from France Television to shoot the pumpkin pie competition that was held in Killruddery over the Halloween weekend.

Würzburg Visit

A delegation from Würzburg visited Wicklow over the October bank holiday weekend. County Wicklow and the town of Bray are twinned with the city of Würzburg, Lower Franconia, Germany.

The delegation was treated to a tour of Wicklow to enjoy all it has to offer in the line of scenic beauty and the delights of local food and drink producers. The tour included breakfast at Kilruddery, lunch at Wicklow Brewing Company, a tour at Coolakay House and a whiskey tasting at Powerscourt Distillery. They also got to experience Beyond the Trees at Avondale, the new jewel in the crown for Wicklow.



Wicklow County Campus Masterplan

The Wicklow County Campus Masterplan will focus on developing Wicklow County Campus as a Centre of Excellence in Enterprise, Education, and Innovation in County Wicklow. With the Masterplan in place, Wicklow County Council will use it to act as a catalyst for economic development in the county and attract investment and further development.

The Tender for the Masterplan is in the process of being awarded with the contract due to commence in December.

Abbey Grounds, Wicklow

The purchase of the Abbey Grounds, Wicklow completed in August and it is intended that the space will be enhanced and redeveloped into the Abbey Gardens and Event Space. The Parochial House has been retained by St. Laurence O'Toole Diocesan Trust and a separate entrance way will be provided as part of the redevelopment.

The redevelopment will include converting the existing Coach House for use as a Café/Retail/Exhibition space and public toilets, installing a natural amphitheatre arrangement to provide for public performance events, a new pedestrian access, pathways for improved accessibility, and public seating.

The plans take careful consideration of the conservation and enhancement of the biodiversity of the grounds, as well as the protection of the ruined remains. The plans are being amended at present following archaeological surveys of the grounds.

Glendalough Masterplan and Wicklow Visitor Orientation Study

In 2020, Fáilte Ireland, in partnership with National Parks and Wildlife Service (NPWS), the Office of Public Works (OPW), the National Monuments Service (NMS), and Wicklow County Council commissioned Consarc Design Group with a multidisciplinary team to deliver a Visitor Experience and Management Masterplan for Glendalough and Wicklow Mountains National Park and Visitor Orientation Recommendations for Co. Wicklow.

The Consultants have presented the Draft Plan to the Councillors and the consultation period will run from 11th November, 2022 until 18th January, 2023. The Draft Plan can be viewed in Libraries and online. There will be an opportunity to discuss the plan with the design team on Tuesday 29th November at the Brockagh Centre, Glendalough. This will be a walk in event running from 2 pm – 4 pm and from 6 pm to 8 pm. There will also be an online consultation event on Wednesday 7th December. A separate meeting for the local Glendalough Group will be arranged.

Outdoor Performance Space

The letter of Contract Award for design Consultants issued to the successful tenderer on the 30th March. The successful tenderer is Vincent Hannon Architects. Meetings have taken place with Strand Road residents, Royal Marine Terrace and



Martello Terrace. Site meetings have taken place with the Design Team, Council officials and representatives from the Mermaid Theatre where the different canopy options were discussed. The project team continue to consult with experts in this industry on the different styles of canopy options available. When the final design is agreed drawings will be prepared and presented to the Members prior to commencing the Part 8 process.

Rural and Urban Regeneration Development Fund Grant Applications

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects. It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway. This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance Blessington as a place to visit. Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

URDF: Urban Regeneration Development Fund

Part 1 of the Arklow URDF Project involved the refurbishment of the Courthouse and the development of an Enterprise Space in the former Town Council offices which is now complete. Part 2 of the project the public realm works are nearing completion.

Bray Harbour Improvements

The requirement for additional environmental assessments was identified in the draft Feasibility Report. RPS was requested to carry out an EIA Scoping Exercise as an add-on to their current engagement. A draft EIA has been reviewed and approved. This identifies all of the potential environmental impacts that need to be addressed in the EIAR. A Stage 1 Screening for an Appropriate Assessment report has yet to be provided after which it is proposed to organise further public consultation that includes a 3D visualisation of the proposed scheme.

Land Management

Wicklow County Council Economic Development Unit are progressing the acquisition of an Enterprise Space in Greystones from Cairn.

A resolution was signed in respect of the disposal of 0.54 hectares (1.33 acre) site on Mill Road/South Beach to the HSE for the development of a Primary Health Care Centre.



A disposal notice was brought before the Elected Members on 3rd October, 2022 and a Resolution signed for the disposal of 0.4047 hectares (1 acre) or thereabouts of land on School Road, Lugduff, Tinahely, Co. Wicklow to Automatic Plastics Limited.

A claim has been submitted to the Department of Rural and Community Development to draw down the funds which were approved for the purchase of the former Bank of Ireland building in Carnew.

Offshore Renewable Energy

The area of offshore renewable energy is rapidly evolving. Due to the number of projects proposed off the coast of Wicklow it is important that the County engages with the process to enable the community of Wicklow to benefit from the opportunities arising while mitigating against any likely impacts that any offshore renewable project will have.

Key milestones have been:

- The Offshore Renewable Energy Support Scheme Consultation. Wicklow County Council made a submission strongly supporting the case for the funds created as a result of the offshore renewable energy projects to be managed and distributed locally rather than centrally.
- 2. The adoption of the Maritime Area Planning (MAP) Act 2021 aimed at harnessing Ireland's offshore wind potential while protecting our marine environment.
- 3. The Marine Area Consent process is now open for relevant projects, it should be noted that the Arklow Bank Wind Farm, which is Ireland's first offshore wind farm, is at an advanced stage of planning and has been operating under an earlier consent regime. SSE has recently announced its intention to apply for a larger more ambitious project under the new MAC scheme.
- 4. An Bord Pleanála granted planning permission to SSE Renewables to develop the onshore grid infrastructure necessary to connect the 800MW Phase 2 of Arklow Bank Wind Park.
- 5. Codling Windpark has submitted their Marine Area Consent application, this is a very significant milestone in the development of Ireland's largest offshore windfarm.
- 6. Shelmalere Offshore Windfarm (DP Energy Iberdola) has completed consultation on its EIAR
- 7. Bord na Mona Ocean Winds Réalt na Mara Offshore Windfarm has delivered a number of community engagement clinics and is seeking to further engage with the local authority.
- 8. Energia is hosting monthly information clinics in Wexford and South Wicklow in respect of the South Irish Sea Project



The next significant milestone will be the announcement of the Offshore Renewable Energy Support Scheme (ORESS) Auction in 2023. Under ORESS eligible projects will be invited to bid to deliver renewable energy services. The Community Benefit Fund associated with the ORESS Auction will be significant.

Food and Beverage Strategy

Funding of €175,000 has been secured via the LEADER Food Programme for a Food and Beverage Co-ordinator role for Wicklow Naturally CLG and for the supply of event costs for the period 2021 - 2023 in support of Wicklow Naturally's Promotional Activities Plan. Wicklow Naturally will contribute 5% from subscriptions and it is proposed that Wicklow County Council will contribute €35,000 over the two year life of the project.

Wicklow County Council recently appointed James Burke Associates (JBA) to carry out a review of The Wicklow Food and Beverage Strategy 2019-2021 and to develop an Action Plan going forward. The new Plan will be similar to the original Plan but will have more focus on Climate Action and development of the Food Incubation Hub.

As part of the Review, James Burke updated the Wicklow Naturally members at a recent meeting in the Glenview Hotel giving them the opportunity to hear about the Review of the Food Strategy and to receive their feedback.

James Burke will deliver a draft of the new Plan on the 14th December, 2022.

Wicklow Naturally has continued to increase its network of members in 2022 which adds to the array of County Wicklow's finest food and drink producers.

Wicklow Naturally has been involved in a number of activities in recent months:

October Feast is a month-long celebration of Wicklow's food and drinks story, including farming, foraging, brewing, distilling, and much more. October is traditionally the end of the harvest, so it is the perfect month to showcase Wicklow Naturally's members' unique selection of food and drink. The launch of the event took place on Saturday 1st October at Powerscourt Distillery. Highlights from the event were Meet the Makers, Enjoy a taste of Wicklow Naturally, Have a Culinary Adventure with bespoke food and drink from the producers, Forage for Tasty Ingredients, Library Talks on 'stopping food waste', Wicklow Naturally Indoor Market and the October Feast Student Challenge for both primary and secondary school students.

Wicklow Naturally will feature at Gifted which will held in the RDS from 30th November to 4th December, 2022. Gifted is Ireland's biggest and best Christmas craft fair, featuring 100's of makers, designers and artisan food producers.

The Farm to Fork Trails continues as guided and self-guided tour throughout County Wicklow with the aim of showcasing the best of Wicklow food and drinks producers and providers. It is hoped that the initiative will continue to enhance the reputation of County Wicklow as a great destination for quality food and drink.



Skills Taskforce for County Wicklow

The Skills Taskforce is now up and running and now has members representing the Film, Food and Renewables sectors.

A Request for Tender has been published with a deadline for responses in November 2022 to engage consultants to carry out a skills audit to identify existing skills and competencies and future skills required to support economic development in the County and also to produce a Skills Strategy for the county.

Greenways Update

Arklow Shillelagh Greenway

The route options continue to be revisited for a few sections of the proposed greenway route with updated ecological surveys just having been completed on those sections. The role of independent agronomist has just been appointed; the Agronomist's details will be communicated to Landowners in the coming weeks.

Wicklow Greystones Greenway

Wicklow County Council has just recently appointed consultants to this project, an inception meeting between the Council and the Consultants will take place in the coming weeks. The consultant will be tasked with carrying out detailed environmental surveys and develop and bring forward the project to statutory approval stage.

Blessington eGreenway

Planning documents under Section 177AE of the Planning and Development Act were lodged with An Bord Pleanála with the end date - 4th March 2022. No update has been received yet from An Bord Pleanála on a likely decision date. It is still anticipated that an oral hearing will be required by ABP before any decision is made.

2. Planning

Wicklow County Development Plan 2022-2028

Wicklow County Council made a new County Development Plan 2022 - 2028 (CDP) on Monday 12th September 2022. This plan replaces the Wicklow County Development Plan 2016-2022.

The new plan is in effect as of 23 October 2022 other than those elements that have been the subject of the draft Ministerial Direction, which was published for public consultation on 03 November 2022. The final date for the making of submissions was 16 November 2022 and a total of 14 submission were received. The Chief Executive's Report to the OPR and the Minister will issue in December 2022, after the matter is discussed at the Council meeting of 05 December 2022.

Healthy Placemaking, **Climate Change** and **Economic Opportunity** are the three overarching cross-cutting themes that inform and shape all aspects of the new plan. The plan also includes the Core Strategy and the Settlement Strategy for the County.

- This plan also includes new Town Plans for the following settlements:- Baltinglass, Newtownmountkennedy, Rathdrum, Ashford, Aughrim, Carnew, Dunlavin, Tinahely, Avoca, Donard, Newcastle, Roundwood, Shillelagh and Laragh-Glendalough.
- This plan is accompanied by a Strategic Environmental Assessment (SEA), an Appropriate Assessment
 Natura Impact Report and a Strategic Flood Risk Assessment as well as a number of other important
 appendices.
- As part of the making of the new County Development Plan, the Record of Protected Structures (RPS) and the Schedule of Tree Preservations Orders have been amended, including the making of additions, deletions and amendments to existing entries. The RPS is included in Appendix 4 of the published County Development Plan. Owners and occupiers of relevant structures have received a separate written notification with regard to this.

Local Area Plans

Work has commenced on the preparation on three new LAPs for Greystones – Delgany & Kilcoole, Wicklow Town & Rathnew and Blessington. The team are at the data gathering and surveying stage, and are currently consulting with all internal departments and state agencies. It is intended to start pre-draft plan public consultation in Q4 2022.



Consultants have been appointed to carry out the SEA and AA for these LAPs and they have commenced their preliminary work. All other studies / assessments are intended at this time to be carried out in-house.

Residential Zoned Land Tax

This is a new tax to activate vacant land for residential purposes, and which will in time replace the Vacant Site Levy, was enacted as a part of the Finance Act 2021, as referred to in Circular NRUP 06/2021 of 22 December 2021. The aim of the tax is to activate and bring forward the development of housing on lands which are suitably zoned and serviced, as indicated on maps to be prepared and published by local authorities for their respective functional areas. These maps are to be published by 01 November 2022. The legislation also sets out certain lands which are to be excluded from the scope of the tax. The tax measure is intended to encourage activation of existing planning permissions on lands which are identified as being in scope and to incentivise owners of suitable lands without planning permission to commence the process of engagement with Planning Authorities.

While residential zonings which include existing dwellings are to be included on the map(s), where connected or able to be connected to services, permanently occupied residential premises which are liable for Local Property Tax will not be liable for the tax.

The Minister has issued guidelines under Section 28 of the PDA to provide guidance to planning authorities in the preparation and publication of maps to identify lands in the scope for this new RZLT.

Mapping has been undertaken and lands identified. Advertisements were placed in local papers over a 3 week period week beginning Monday 17th October 2022 and the draft map was published on the Wicklow County Council website on November 1st. Submissions can be made by post, online through the consultation hub and by email. The closing date for submissions will be the 1st January 2023. Submissions will be published on the Wicklow County Council website.

Heritage Officer –November 2022

Climate Action: Biodiversity Actions/ Activities

Brittas Bay Conservation project Continuation of conservation measures, including ecological recording & monitoring and conservation grazing. A Community Engagement programme of field outings and workshops is underway, six events in total. Volunteer Sea Buckthorn removal day held on 5th November, final event planned for 19th November.

Wicklow Barn Owl Project – Over 30 confirmed sightings of Barn Owls for county Wicklow, have now been recorded, a significant increase from 3 at the start of the project. Over 170 potential sites for future nesting boxes have been identified through public engagement.

Conservation Management Plans for WCC owned land at Bray Head and Wicklow Head: Heritage Office liaising with MD staff and ALCNature (ecological consultants). Drafts due by end of year.



Pollinator resources –Over 200 'managed for wildlife' and 'Don't mow let it Grow' outdoor signs distributed to MDs and members of public. Noticeable increase in pollinator friendly management at roadside verges, roundabouts and open spaces.

East Coast Nature Reserve Events: Monthly seasonal free public event programme in place in partnership with Bird Watch Ireland at East Coast Nature Reserve. Next event on Sunday 13th November with Bird Ringing demonstration, final event scheduled for 11th December.

Climate Action (Built Heritage - Archaeology):

Community Archaeology Service for County Wicklow

Allocation received through County Heritage Plan Fund from the Heritage Council and WCC for appointment of a part time community archaeology service. A programme is currently underway by De Faoite Archaeology and managed by the Heritage Officer. Part of the programme entails the survey of medieval ecclesiastical sites in Wicklow through a recording template specially developed by the Council's GIS officer.

Community Monuments Fund (CMF): Funding to increase the resilience of our Built Heritage (archaeology) to climate change via Community Monument Fund (CMF) 2022- Seven CMF projects currently underway, co-ordinated by Heritage Officer, allocations as follows: Arklow Castle repairs, Arklow Castle repairs €84,621; Mullinacuffe Historic Church ruins repairs €14,954; Castlekevin, Roundwood conservation plan €18,682; Baltinglass Hills – Lidar Survey €29,362; West Wicklow Medieval church and graveyards –geophysical survey and access improvements €30,000; Castlekevin podcast production €7,748; Abbey Lane, Arklow – research & interpretation €7,072.

Climate Action (Built Heritage - Architecture):

Conservation Management Plan for Clermont: Consultants 7L appointed as part of multi-disciplinary team to provide conservation management advice for natural, built and cultural heritage at Clermont House and campus. Initial meeting held on 12th Sept. Report due by end of year.

Protected Structures Grants: Projects under the Built Heritage Investment Scheme (BHIS) and the Historic Structure Fund (HSF) grant schemes from the Department of Housing, Local Government and Heritage underway. BHIS includes 11 projects under a county allocation of €96,000. HSF includes 3 projects; €25,000 towards Russborough Weir Wall repairs; €40,000 for St Matthews Church, Newtownmountkennedy, and €10,000 to vernacular house at Greenan More. Project, reporting and recoupment overseen by heritage officer in 2022 on behalf of the planning section.



Development Management

E-Planning Project

The commencement of the roll out of the ePlanning system is scheduled in Wicklow for Q1 2023.

The project will include the following elements:

- Standardised naming/structure of all documentation in Local Authorities and An Bord Pleanála.
- Web Portal through which all electronic planning applications and all correspondence regarding same would pass.
- All submissions can be made on-line for both planning application and part VIII applications.
- Fees will be paid online by means of card payment or EFT.
- Part VIII applications for all Local Authorities would be submitted and stored centrally.
- Referrals to all prescribed bodies and the receipt of their submissions would be electronic.
- Electronic transfer of planning files to An Bord Pleanála following an appeal.

The e-Planning system will provide a better service to the public. It will allow agents to build their applications before submission, and will reduce the printing, copying and scanning of documentation. It will also facilitate electronic interaction between Local Authorities, An Bord Pleanála and prescribed bodies.

The Remediation Plan has been presented to the Courts and confirmation is awaited

Climate Action

Climate Action Plan 2021 - Securing Our Future

The Climate Action Plan, which was launched on 4th November 2021, is an ambitious plan to put Ireland on a more sustainable path, cutting emissions and creating a cleaner, greener economy and society



The Climate Action Plan follows the Climate Action and Low Carbon Development Act 2021, which commits Ireland to a legally binding target of net-zero greenhouse gas emissions no later than 2050, and a reduction of 51% by 2030. These targets are a key pillar of the Programme for Government.

The plan sets out 475 separate actions to halve Ireland's greenhouse emissions by 2030, including extensive offshore wind power, retrofitting 500,000 homes and putting a million electric vehicles on the roads.

The public sector will lead by example and halve emissions by 2030. Green Teams will be established in every public sector body. No new fossil fuel heating systems will be installed in public buildings after 2023, except in very limited exceptional circumstances. All new fleet purchases will be electric from 2023, where such vehicles are available.

A new National Retrofit Plan will drive demand and make retrofitting more affordable whilst there are increased targets for district heating and the public sector, and strengthening building standards for all buildings.

Just transition principles are embedded in the plan, including the principles that people need to be equipped with the skills to benefit from changes and that costs need to be shared. A Just Transition Commission will be established.

All increases in carbon tax receipts are earmarked for targeted social protection measures, an expansion of retrofitting, particularly for social and low-income homes, and agri-environmental projects.

Wicklow Climate Action

Climate Action Plan

Wicklow County Council has commenced the Advance Planning Stage of the development of Wicklow's Climate Action Plan and ran a tender competition to appoint a consultant to develop a Countywide Baseline Emissions Inventory (BEI) and a Climate change Risk Assessment. The deadline for tender responses was 20th October and eight responses were received, four each for the two lots, four on the baseline emissions inventory and four on the climate risk assessment. They are currently being assessed. Arklow Decarbonisation Zone will form a chapter of the plan.

Mid East Energy Unit

Wicklow County Council, in partnership with Meath and Kildare County Councils is establishing the Mid East Energy Unit. As lead authority, Wicklow County Council is at the final stages of signing a MOU with the SEAI to progress the establishment of the Energy Unit.

Service Level Agreements between Wicklow and the partnering authorities are being progressed in parallel. Work within the energy unity will deliver on public sector energy efficiency and energy reduction projects via the SEAI Pathfinder scheme which includes 50% funding for these projects from the SEAI.

In advance of the establishment of the Energy Unit WCC has purchased a licence to use an energy management software called Energy Elephant. This will assist in managing the energy usage in all WCC buildings and to identify projects which can be progressed by the Energy Unit through the Pathfinder Programme.



The recruitment process for the positions of the Regional Energy Manager and the Energy Officer is in progress.

Arklow Decarbonisation Project

RPS Consulting Engineers has delivered the Baseline Emissions Inventory, the Register of Opportunities and Placemaking and Active Travel Reports and the draft Implementation Plan. The Final Implementation Plan will be delivered in the coming weeks. The DZ Implementation Plan will become a chapter of the Climate Action Plan.

Bicycle Parking

Create bicycle friendly buildings for employees and visitors, by putting bicycle parking in place by 2022 –
 which is secure, accessible and simple for cyclists to recognise and use.

As per this action in the Climate Action mandate for the public sector, work has commenced to identify suitable locations to install bicycle parking at our public buildings, car parks and amenities.

New posts

The posts of Biodiversity Officer and Community Climate Action Officer have been advertised

EV Charge Point (EVCP) Infrastructure

Wicklow County Council is collaborating with Easy Go to build on the existing EVCP infrastructure in the County. Municipal District Engineers will work with Easy Go to identify suitable locations for installations.

The Green Team are working on a number of initiatives:

- A draft Paper Use Policy has been drawn up.
- · Eco friendly cleaning products for our buildings
- A staff travel survey was completed with a great response. Results are being analysed.
- Home Energy Retrofit Information day for Staff was held in September and was well attended.
- Weekly key information notices are being circulated to all staff as part of the Reduce Your Use Campaign Several members of the Green Team have completed Green Team training and are now working on the development of an action plan for the coming year.

ALCNature have been appointed to develop a **Conservation Management Plan for Bray Head and Wicklow Head**. For Wicklow Head an initial meeting has been held between the Climate Action Team, Forward Planning and Sports Partnership to ensure there is a smooth crossover between the plans being developed by each section.

Environmental Awareness

 An assessment is being undertaken on the possibility of introducing an ebike rental scheme for commuters in Bray. Discussions have taken place with three service providers and each has been asked to submit a



proposal on how they would operate a service for Bray. The aim is to find a service provider who will trial a scheme for 12 months.

- An application submitted to the Regional Waste Management Office for funding to work with Wicklow Naturally to look at better waste segregation practice in the food sector and waste prevention for the sector has been successful. One initiative will be promotion of a deposit return scheme for coffee shops. Training will also be provided on waste segregation and waste prevention.
- Wicklow is participating in the Rubbish Film festival with Create Schools based in Clermont. The schools
 participation is funded by Wicklow County Council. Five schools have registered for the project.
- A Bikes for Africa project with the Rotary Clubs of Wicklow and Bray has exceeded targets receiving over 150 bikes. The bikes will now be repaired in Shelton Abbey Open Prison before being shipped to The Gambia.
- A travel survey was undertaken with staff and will be used to look at what options can be explored to reduce car dependence for staff.
- The annual Tidy Towns, Estates and Sustainable Development awards for Tidy Towns, residents associations, community groups, businesses and schools were judged. The awards have been linked to the Sustainable Development Goals.
- Thirty community groups were awarded a tree grant in October and planting is now under way. Three further
 applicants were received and are being processed.
- A Climate Action for TY event was held in October. It will be held in the Brockagh Centre and Raoul Empey of Sustineo was the key note speaker. 140 students from four Wicklow secondary schools participated.
- To mark October Feast, talks on food waste were given in Blessington and Greystones libraries.

Sustainable Energy Committees

A one day study tour for SECs with completed EMP's was planned to Dunleer SEC in Co. Louth. Participating SECs were invited to collaborate on a joint project to identify houses for a Community Fund retrofitting project.

Greystones SEC is leading on a solar meitheal project which aims to group householders looking to install solar panels on their properties together as one project with the aim of getting a better price while also help to ensure all household get a quality installation. Several SECs are participating.

The Energy Master Plan for Blessington is now complete. Work is near completion on the Energy Master Plans for High Park. In Arklow survey work is being undertaken. A new application for an Energy Master Plan has been received from Carnew Community Care. Newtownmountkennedy, Glenmalure, Greystones, Enniskerry, Wicklow and Laragh have also completed Energy Master Plans.

Water Framework Directive River Basin Management

- Water Quality in Ireland Report 2006-2021 published by EPA.
- Nearly half of Ireland's surface waters are in an unsatisfactory condition caused by human activities that cause water pollution or habitat degradation.
- 50% Rivers, 69% Lakes, 36% Estuaries and 81% Coastal Waters are good or better.
- The picture in Wicklow is expected to buck the trend and show an improved situation awaiting release of data from the EPA.
- Main causes in order of magnitude are run-off from farm yards and land, drainage and barriers in rivers, discharges poorly treated sewage from urban wastewater treatment plants, domestic wastewater treatment system and storm water overflows and run-off from forestry.
- WFD Directive requires that all waters are protected and restored to satisfactory condition by 2027.

Deco Paints and Solvent Regulations.

- 1 Vehicle refinisher (car spraying) installation was issued a compliance certificate.
- 1 Dry Cleaner installation was inspected.

Petrol Vapour Recovery Regulations.

1 Filling station was inspected.

Smokeless Coal Regulations

- New regulations governing the sale and distribution of solid fuels came into effect on 31st October this year.
 These extend the ban on the sale and distribution of smoky solid fuels to the entire county and countrywide and make retailers and transporters (including couriers) legally liable for the product which they carry for sale or distribution.
- The sale of turf is also banned in all circumstances. People with turbary rights may still cut and burn their own turf, as well as gift it to family, friends etc.
- The moisture content of timber is also regulated for the first time and is required to carry specific labelling.
- All solid fuel packaging must carry the label "Contents Comply with Air Pollution Act Regulations".
- Interim measures are to apply for labelling in the 2022/2023 season.

In July An Bord Pleanala published two orders approving the Planning Application (EIAR) and Compulsory Purchase Order (CPO) for Arklow Flood Relief Scheme. As the Judicial Review period has expired, Wicklow County Council has moved to confirm the CPO and procure the detailed design to allow construction proceed. The Council will also procure further Archaeological and other surveys in the coming months to inform the detailed design.

TRANSPORTATION

M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website www.n11m11.ie on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding has been provided to continue during 2022. Wicklow County Council project team are continuing to meet with the public and any interested parties.

M11N11 Bus Priority Interim Scheme

The BPIS seeks to achieve the early delivery of bus priority measures in advance of the main scheme between Loughlinstown Roundabout and Junction 9 (Glenview). The scheme is currently at the Options Selection phase (Phase 2 of TII's Project Management Guidelines).

A non-statutory public consultation on the preferred option commenced on 28th November 2022. A two day public consultation event took place in the Glenview Hotel on the 28th and 29th November 2022. Submissions will be accepted up until 22 December 2022.

The public consultation information is available to view on the BPIS project website www.n11m11bpis.ie. This website will provide up to date information on the progress of the scheme.

N11 Parallel Service Road at Kilmacanogue

A noise assessment of the 7 no residential properties that are adjacent to the new Parallel Service Road Scheme was carried out during April and May 2022. The draft report concluded that the change in junction layout does not change the noise levels at nearby properties when compared to the previous layout. However when road traffic speeds are increased to 100km/h along the N11, noise levels were elevated at the nearest noise sensitive locations by up to 4.5



dB Lden. This would cause a potentially significant impact to the receptors along the N11. Following on from this report, feasible noise mitigation measures are now being investigated.

N81 Knockroe Bend Realignment

The tenders for the Per Cent Art Feature are being procured by the Arts Officer. A Design & Delivery Competition for new public sculpture closed on e-tenders on 23rd November 2022.

N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"

Following completion of Transport Infrastructure Ireland (TII) Phase 1 feasibility studies (N81 Four Studies – Feasibility Report), Wicklow County Council will now look to progress the following two projects:

- N81 Whitestown Lower Project; and
- N81 Hangman's Bend and Tuckmill Project.

Wicklow County Council have commenced the procurement of Technical Advisors to undertake planning and design services under TII Project Management Guideline Phases 2 to 4 (inclusive), with the aim to appoint an advisor and commence Phase 2 early in 2023.

N81 Pavement Capital Works

Resurfacing works of 1km of the N81 between Tuckmill and Saundersgrove will be tendered for in 2022. The design of the pavement is being carried out, expected to be completed in 2023.

N81 Capital Maintenance

Resurfacing work at Monaspick and Annalecky was completed in May. Drainage works at Mullycagh and Tinode were completed during October 2022.

N81 Fencing Retrofit

The contract for the fencing was completed in November 2022.

N81 Invasive Species Removal

Annual treatment completed in September 2022.

N81 Bus Stop at Hollywood

Following comments received from TII, further work is being undertaken to look at the proposal in more detail. The scope of the study has been extended to consider possible improvements for vulnerable road users at the junction. TII have provided funding for this further study.

Arklow to Shillelagh Greenway

The route options continue to be revisited for a few sections of the proposed greenway route with updated ecological surveys just having been completed on those sections. The role of independent agronomist has just been appointed; the Agronomist's details will be communicated to Landowners in the coming weeks.

Baltinglass Town Centre Plan

Wicklow County Council has conducted the procurement process for a contractor and submitted the Tender Report and recommendation. Additional funding is required over and above the original allocation and reports have been prepared to aid those discussions. Award of contract is to be undertaken once approvals have been obtained.

Blessington Inner Relief Road

Detailed design along with the preparation of associated documents to allow the Council to seek statutory approval is ongoing.

Wicklow County Council Compulsory Purchase (Chapel Road Pedestrian and Cycle Infrastructure Improvement Scheme) No. 1 Order 2021

Consultants continue to proceed with the detailed design with the preparation of the tender documents. Notices to Treat will be issued within the coming weeks, which will commence formal discussions on compensation.

Redford Junction

The Part 8 was approved by the Members of Greystones MD in October 2022. Work has commenced in the preparation of detailed design and the preparation of tender documents to allow the project to proceed to construction.

Winter Maintenance

The winter maintenance season commenced on the 15th October 2022 and will continue until the end of April 2023. To date weather has been extremely mild and consequently no salting has occurred to date.

Wicklow Greystones Greenway

Wicklow County Council has just recently appointed consultants to this project, an inception meeting between the Council and the Consultants will take place in the coming weeks. The consultant will be tasked with carrying out detailed environmental surveys and develop and bring forward the project to statutory approval stage.

Blessington eGreenway

Planning documents under Section 177AE of the Planning and Development Act were lodged with An Bord Pleanála with the end date - 4th March 2022. No update has been received yet from An Bord Pleanála on a likely decision date. It is still anticipated that an oral hearing will be required by ABP before any decision is made.

Active Travel Updates

Glenart pedestrian link (Arklow MD)



Pedestrian accessibility link improvements at the rear of the Woodlands housing development located between Lamberton and Glenart. The works will involve the construction of a pedestrian access ramp and the installation of public lighting along the scheme. Contractors have been appointed for the project.

Herbert Road (Bray MD)

Construction of approx. 400m of pedestrian footpath in order to connect the end of the existing footpath on Herbert Road to the pedestrian footbridge on the N11. On completion of the scheme, pedestrians coming from the Bray direction will have uninterrupted pedestrian facilities on the bus stops located on the R-117. Works have commenced on the project and should be substantially completed by the end of November.

Ashford to New Developments footpath (Wicklow MD)

Improve pedestrian facilities along the R-764 by widening the footpath and upgrading the public lighting. Works have commenced on the project.

Bellevue Junction Improvement works in Delgany. (Greystones MD)

Upgrading of the junction of the R-762 and Bellevue Hill. The project will improve pedestrian accessibility and safety and enhance village centre aesthetics by widening and landscaping the paved pedestrian areas, upgrading public transport facilities, undergrounding services and upgrading public lighting. Works have commenced on the project and should take approx. 14 weeks.

Sidmonton Square (Bray MD)

Accessibility improvements to improve the safety of pedestrians. Works have commenced on the project and should be substantially completed by the end of November.

Powerscourt National School (Bray MD)

Pedestrian improvements adjacent to Powerscourt National School to improve the safety of children and pedestrians. Works have commenced and will take approximately one month to complete.

Kilpedder to Willow Grove Rapid Deployment Scheme (Wicklow MD)

Construction of approx. 960m of new and upgraded footpaths with public lighting, along the L-5406 between Kilpedder to Willow Grove. Works have commenced on the project.

Greystones Seafront to Kilcoole (Greystones MD)

Provision of approx. 4000m of cycle and pedestrian route from Greystones Seafront through Charlesland to Lott Lane, Kilcoole. Inception meeting held for the project.

Sea Road to Train Station Kilcoole (Greystones MD)

Provision of approx. 1200m of cycle and pedestrian facilities from Sea Road to Kilcooole Train Station. Inception meeting held for the project.

Wicklow - Rathnew Transport Study (Wicklow MD)

A transport strategy for the Wicklow Town – Rathnew area which will provide a strategic framework for the development of better integrated and more legible transport services. It will also identify specific priorities for the development of public transport, walking, cycling and road facilities. Tenders have been advertised for consultants to manage the study.



Scalp Pedestrian and Cycle Improvement Scheme (Bray MD)

Tenders have been advertised for consultants to manage the Preliminary Stage and Options Assessment Stage of the scheme, which looked into the feasibility of the provision of cycling facilities and improved pedestrian facilities between Enniskerry and Kilternan.

Rocky Road, Wicklow Main Street to Marlton Road (Wicklow MD)

Provision of approx. 1000m of pedestrian and cycle facilities along Rocky Road, Wicklow Town. Inception meeting to be held for the project.

R-772 Ashford (Wicklow MD)

Provision of approx. 1000m of cycle facilities and footpath improvement works along R-772 Road in Ashford linking the residential developments at Rosanna to the south and the Holy Rosary National School to the north. Inception meeting to be held for the project.

Cunningham's Corner, Roundwood

Works on Cunningham's Corner, Roundwood have now been completed. The completion of this safety improvement scheme will improve the road, providing a safer transport route on this key piece of infrastructure.

There were **164 incidents** attended during the month of October 2022. Individual Fire Stations were mobilised on a total of **189 occasions** including 13 incidents in other counties.

Operational activity for the month of October **increased by 44% (+58 mobilisations) on the preceding month** September 2022 – 131 mobilisations). This was mainly due to an increase in Bonfires +19 (up from 28 to 48), RTCs +5 incidents, +10 mobilisations (up from 18 to 28), alarm activations +14 (up from 18 to 32) and flooding's +9 (up from zero to 9). The increase in Bonfires due mainly to Halloween period occurred despite action taken in conjunction with Gardaí, Environmental Wardens and by interacting with local businesses to eliminate the supply of combustible materials.

Operational activity for the month of October 2022 was up 49% (+62 mobilisations) on the equivalent month in 2021 (October 2021 – 127 mobilisations). When compared year on year increases occurred in mobilisations to domestic fires +16 (up from 2 to 18), RTCs +14 (up from 14 to 28), alarm activations +18 (up from 14 to 32) and flooding +9 (up from zero to 9). Bonfires were the same as 2021. The increased activity was mainly in Greystones, Rathdrum and Arklow.

Building Control continues to experienced high construction activity & completion of units in October 2022. 84 new residential units in were notified to LA for Commencement and 210 newly completed residential units and 114 new Duplex units were submitted, assessed and validated in October.

Building Control continued with site inspection in October to identify non-compliances with Building Regs onsite and 2 No. Section 11 Compliance Requests were issued.

Revised Information requests were extremely high in October for both Commencement Notices and Certificates of Compliance on Completion, 95% of Commencement Notice submissions & 75% of Certificate of Compliance on Completion submissions required revised information. It should be further noted that some Opt Out Submissions are requiring 2 to 3 Revised information requests which results in submissions being assessed 2 to 3 times to ensure compliance prior to commencement.



Opt Out submissions are both extensions and single unit dwellings, generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt Out Submissions. Unfortunately as the construction sector activity has increased, the quality of submissions has decreased, which is leading to delays in validation of submissions.

NBC&MSO Quarterly Newsletter dated September 2022 has requested LA's to focus resources on compliance with Building Regulations in Opt Out Submissions, Wicklow Building Control continue to perform rigorous assessment of submissions at commencement stage and onsite presence during constructions. These methods remain the best way to promote compliance with Building Regs.

Water Services

In Quarter 3 2022, Wicklow County Council staff continued to provide Water and Wastewater Services under the current Service Level Agreement (SLA) with Irish Water.

Annual Service Plan 2022

Wicklow County Council works alongside Irish Water in line with Key Performance Indicators under the Annual Service Plan. As a part of the Annual Service Plan, Water Services in Wicklow County Council is required to deliver on performance measures and Key Performance Indicators.

The Annual Service Plan 2022 outlines all 69 performance measures alongside all corresponding baselines and targets. Each measure and associated objective has been grouped into one of four categories, namely: -

1. Learning & Growth (7 measures)

Objective: To continuously improve and drive transformation and change initiatives

2. Customer (17 measures)

Objective: Providing services that are valued by customers. This is influenced by the CRU Customer Handbook and proposed Performance Assessment metrics

3. Internal Process / Compliance (30 measures)

Objective: Adherence to all reporting requirements and meeting regulatory requirements as set out by the relevant statutory and regulatory bodies, e.g. CRU and EPA

4. Financial (15 measures)

Objective: Providing a cost effective service, within budgetary constraints

Within the four categories of performance measures there are three distinct tiers:



- 1. KPIs 17 measures
- 2. Operational Measures 39 measures
- 3. Tracking Measures 6 measures

Drinking Water

Wicklow County Council staff work with Irish Water under a service level agreement (SLA) to provide safe and clean drinking water to the people of Wicklow. This year the Council continues to work under changes to the working environment that were brought in due to Covid-19. Normal operation and maintenance works have been on-going with caretakers, leakage locators, plumbers and leakage inspectors ensuring quality and supplies from water treatment plants (WTPs) and within networks, haven't been affected during this period. Administration, outdoor, technical and engineering staff continue to work together to ensure the best service is delivered on a daily basis.

Operation and Maintenance Works:

Reservoir Cleaning:

There is an on-going program of reservoir cleaning and repair currently being carried out by Irish Water and the water services staff of Wicklow County Council, to ensure the highest quality water is supplied and distributed into the networks. Site visits have been completed on 20 reservoirs due for cleaning in 2022. This year service cleaning inspections have taken place at reservoirs in Giltspur, Priestnewtown, Tinahely, Rathdrum, Redcross Intermediate, Ballydonnell, Ballinaclash, Ballymurtagh and at the three reservoirs in Lamberton (Arklow). Cleaning works completed at Broomhall and finishing up at Glending. Cleaning works at Raheen and Barnbawn are to be completed before the end of 2022.

Burst Mains & Leak Repairs:

On a daily basis, there are burst mains and leak repair carried out by Wicklow County Council water services staff. Often, these are on smaller mains but regularly they are on larger pipes on roads and can cause a lot of disruption. This can be due to older pipes, pressure build up or pipe strikes. These incidents can happen at any time during the day or night and water leakage inspectors, leakage locators, plumbers and external contractors make themselves available to fix these issues.

Leakage Equipment Pilot:

Wicklow County Council is currently involved in trialling new leakage equipment on behalf of Irish Water. This equipment detects noise on the network and gives the leakage crews locations of possible leaks. Loggers are currently being used in Wicklow Town following trials in Bray, Delgany, Blessington, Kilpedder and Arklow. In total Wicklow County Council has got 400 leakage loggers available for deployment. The Council has 150 extra leakage loggers than it had in Q1 so the capacity for leakage detection has increased.

Water Network Programme: Mains Rehab.

Irish Water, in partnership with Wicklow County Council, are currently progressing a number of water improvement projects, to improve security of supply, water quality and reduce the levels of leakage.

Pressure Management

Irish Water, in partnership with Wicklow County Council, are currently progressing a number of pressure management projects, to improve security of supply and reduce the levels of leakage across Wicklow. Up to the end of Q3 there are 110 PRV controllers installed across the county which help control and stabilise the pressure throughout the network.

District Metering Areas (DMA)

Through the Irish Water, Water Network Programme, Wicklow County Council is currently replacing DMA flow meters across the county in order to track and manage the leakage in the metered water network more efficiently.

- Glenealy/Rathdrum. Irish Water has appointed Design Consultants for this commission.

Waste Water

Waste Water Operations and Maintenance (O&M) Section

The primary function of the Waste Water Section, working under the Service Level Agreement (SLA) with Irish Water, is the on-going management, operation and maintenance of existing waste water treatment plants, in order to ensure continued production of effluent discharges to the environment to required standards and to keep the waste water collection network running properly.

The Waste Water Section also organises regular compliance sampling, and testing of effluent parameters and reporting of results (to Irish Water/Environmental Protection Agency).

So far in 2022, there have been no ELV parameter exceedances which represents the best compliance performance in any year to date (for the first 9 months of year).

In addition, reports are provided to Irish Water as to feasibility and particular requirements in relation to connection applications and pre-connection enquiries (received by IW) and similarly in relation to planning applications.

Capital Maintenance & Minor Capital Improvement Works

O&M expenditure falls under two main headings or funding sources – i) day to day operational goods and services and ii) Capital Maintenance (CM). Capital Maintenance expenditure essentially provides for the like-for-like replacement of components and equipment, as and when required due to normal wear and tear or breakdown.



From time to time (subject to various issues, including level of staffing available) more substantial or notable works are proposed by WCC (and if approved by IW) are progressed by the Wicklow County Council O&M Section under CM funding. There were no such notable projects completed or effectively underway in Q3 2022.

Irish Water Capital Works (Waste Water)

[Note Wicklow County Council has no role in the delivery of the following Irish Water projects]

Arklow Wastewater Treatment Plant:

Irish Water continues to make substantial progress in advancing this essential project for the people of Arklow. Looking back since the first overturned sod marked the beginning of a busy year of construction, the existing buildings on the treatment plant site were demolished and the inlet pump station and the treatment plant buildings have progressed significantly. Out in the town on the network sites, the underground tunnel along the North Quay containing a new interceptor sewer has been completed. The river crossing tunnel and the installation of a new interceptor sewer on the South Quay has started and will continue into 2023.

The project will bring significant benefits to the local community including environmental protection and improved water quality in the River Avoca for angling, water sports, and marine life. It will also act as a catalyst for housing and support economic growth and development in the town.

Blessington Wastewater Treatment Plant Upgrade:

The upgrade to the Blessington WWTP is ongoing and is anticipated to be completed in Q4 of 2022. The Upgrade will increase the PE into the plant and allow planning applications that have been granted, subject to planning permission to be progressed.

Avoca Wastewater Treatment Plant

Further Information requested by Planning Authority is expected to be submitted by IW by mid/late November 2022.

Aughrim Wastewater Treatment Plant Upgrade: - (Small Town & Village Growth Programme)

This Project is currently with IW asset delivery section and is in the early stages of design etc. No recent status/progress update has been received.

Tinahely Wastewater Treatment Plant Upgrade:- In Q3, IW asset strategy personnel visited the Tinahely wwtp site to obtain/confirm details of existing infrastructure, as a prelude to assessing and establishing requirements and scope of (any) proposed plant upgrade and associated cost estimates for subsequent review and hopefully approval for handover to asset delivery section to progress the project to completion.

Key Performance Indicators (KPI's):

Under the Annual Service Plan with Irish Water, Wicklow County Council continued to be scored on Key Performance Indicators. The 2022 Q3 score was 91.5% which reflects the excellent performance of Wicklow County Council staff across all pillars within the Annual Service plan throughout the year. The Quarter 3 report for 2022 includes:

- A score of 100% was achieved for Timely Response to Workflow Queries
- A score of 100% for Drinking Water Supply Microbiological Compliance
- A score of 100% for Waste Water Treatment Incident Reporting (Category 1-5)

Local Authorities have been issued with a printed supply of new registration forms ERF1 and issued other form variants in pdf format to print as required.



Official Languages (Amendment) Act 2021

Amongst the provisions of the Official Languages (Amendment) Act 2021, there is a new statutory obligation for public bodies in relation to advertising, general communications and commercial communications which engage with the public.

Section 10A. (Advertising by Public Bodies) of the Official Languages Act (Amendment) 2021 places duties on public bodies in relation to the way they communicate in the State's official languages. The advertising sector is a very important communication medium, and accordingly this new provision is expected to be of considerable importance. These provisions came into effect on 10th October 2022.

- The IT Helpdesk continues to streamline the workflow for the technical support team with an average of 33 tickets a day this month, providing assistance for both in-house and remote workers.
- Examination of system upgrades potential is continuing.

GIS & Systems Analysis

- Residential Zoned Land Tax Portal has gone live. Draft maps are displayed on the website and the interactive map has gone live.
- The map production of the County Development Plan (2022 2028) has been finalised. The relevant GIS applications have been updated with the new datasets.
- Public Consultation on a Strategic Environmental Assessment of a Draft Masterplan for Glendalough and Wicklow Mountains National Park and Visitor Orientation has commenced and is available to view on the touchscreen in the foyer.

Customer Service Delivery

- Support for the Customer Service Innovation Hub is ongoing. The Customer Service project requires a high level of IT collaboration with both hardware and software elements integrated into the Hub.
- Work continues with the business process mapping and DPIA's are being carried out for each process as it arises.
- Avaya IP Office Phone System has been modified to integrate the Avaya Contact Centre Select Hardware
 Appliance and software. This has led to greater integration with call reporting systems and has improved
 customer service delivery.


