Item 1: Votes of Sympathy.

Item 2: Confirmation of Minutes of the Ordinary Meeting of AMD dated 14th May 2025

The minutes of the Arklow Municipal District Ordinary Meeting held on the 14th May 2025 were proposed by Cllr. Fitzgerald and seconded by Cllr. Murphy.

Item 3: Matters Arising.

Cllr Leonard requested that the minutes for the Special meeting of the 28th May be amended and her use of the term bullied be retracted.

Item 4: Consideration of Reports and Recommendations.

To adopt AMD SMDW works for 2025.

- Cllr. Leonard requested a breakdown of the Arts Funding. She said that €10,000 would greatly help with the Arts CLG being set up.
- Cllr. Bourke said with Arklow getting €25,000 and Baltinglass receiving €48,000 it would be good to get a breakdown of funding for the next meeting.
- The roundabout scheme provides €21,000 per annum which is used for match funding for projects.
- A complete breakdown of parking charges and fees was requested for the next meeting.
- A complete breakdown of Harbour and Pier Maintenance for Arklow was requested.
- Cllr. O'Toole enquired how we can get funding for Development and Erosion. Can workshops or budget meeting be organised with the Finance Department.
- Cllr. Leonard requested figures for the turnaround for relets/retro-fit houses. Members were reminded that Housing matters should be referred directly to that directorate.
- A housing workshop for Relets/ Allocations in the AMD was requested.
- Cllr Kennedy asked for information on two derelict houses previously offered for sale in the district, he said the pending buyers have heard nothing.

Members were reminded that the Schedule needed to be agreed at the Municipal Meeting or it would need to revert to the full Council. Any adjustments made needed to be balanced out elsewhere as the SMDW must balance.

Cllr. Kennedy proposed and Cllr. Fitzgerald seconded the Schedule as circulated.

Work continuing on cleaning Main Street. Areas for repair have been identified.

Other works

Topographical Survey completed on Rathdrum Main Street. Information to go to consultant Masterplan of Seaview Avenue – Waiting on ESB maps before procuring consultant.

The following matters were discussed.

- Vale Road, potholes will be repaired.
- A price is being sought for fencing for Glendale it is on the 2026 programme.
- Speeding is an issue on the Vale Road, DE will organise a traffic study.
- Rory O'Connor traffic study resulted in no speeding violations being recorded.
- Retailers are very happy with the Pavement Cleaning.
- Topographical survey for Rathdrum is gone to the Consultants.
- Can we write to TDs for more funding for overlaying on roads as we got no increase on previous year?
- Roads at Halpins, the Quay and Leisure Centre are all to be assessed.
- Breakages in footpaths on Main Street, Ferrybank, and side streets need to be assessed.
 Areas identified are being dealt with by staff, we will tender for the rest.
- Still a backlog on LIS, Toberpatrick is scheduled to be done this year.
- Report from owners of Morgan Doyles, Main St. is required stating the building is safe, once received the railings will be removed. This falls under the remit of the Environment Section.
- LIS is not for public roads, they cover private laneways. The rules of this scheme are set down by the Department.

Item 7: Correspondence

The DA stated AMD have been liaising with representatives from the Wicklow Pride Committee and we have a number of different options to support pride. We are very hopeful what was proposed by them will be acceptable.

Cllr. Leonard is in favour of the pride crossing being re-installed and feels it is cruel to erase the crossing.

The pride crossing has been discussed at a plenary meeting as it is not in keeping with legislation.

Item 9: Any other business

- Cllr. O'Toole said housing in the District needs discussion; people are living in unsuitable conditions. MDs should contact Wicklow for proper delegations as vulnerable people are being put in to bad situations.
- Some people cannot get onto the housing system.
- Cllr. Leonard said Housing is in crisis and there is a gap in the system. Housing need to have a conversation with AMD. She also asked how many housing do we have to be allocated. Why do we only have one Social Worker for the County, it is a National problem and we need to lobby our TDs.
- Cllr. Fitzgerald had a person call to his home seeking assistance. Cllr. Fitzgerald rang the Minister and he arranged them to meet in Arklow.

- F Keogh suggested asking the homeless officer to attend an MD meeting.
- The DA confirmed that the TSO meets tenants in AMD by appointment.
- Cllr. O'Toole asked if the running track could provide storage for the local athletics club. .
- A report on Public lighting for Pound Hill and Templerainey Heights was requested for the . next meeting.
- Cllr. Leonard said 402 Collective have a unit rented on Lr. Main Street and will have a gallery . and workshops. They have received lots of support from LSP and asked her fellow Councillors for support with the project.

Fergal Keogh ended the meeting stating with the WWTP now commissioned that there are exciting times ahead for Arklow. We need to maximise Arklow to its full potential. This is a great opportunity to develop and see Arklow grow.
