ITEM NO. 1

Section 140 motion Local Government Act 2001 (as amended) in the names of Cllr. J. Behan, Cllr. M. Kavanagh, Cllr. P. Leonard and Cllr. T. Fortune.

The response will be followed by a brief pause following which the Cathaoirleach will ask the elected member to verbally indicate if there is disagreement or dissent as to the proposal put forward. If one or more elected member indicates they are not in agreement a roll call will be taken. If there is no dissent the amendment will be considered passed.

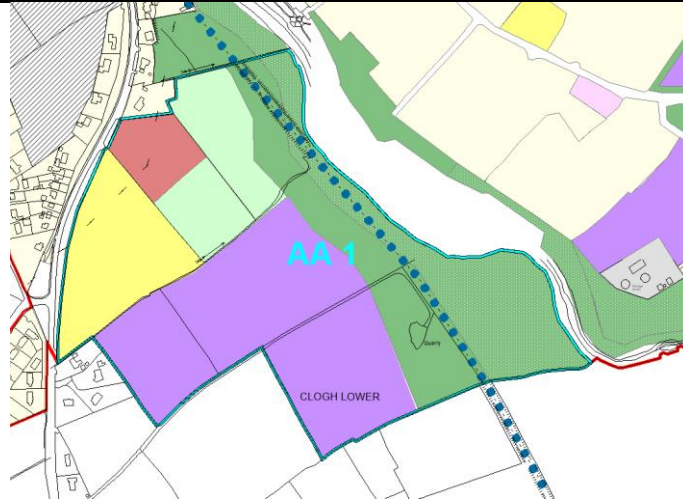

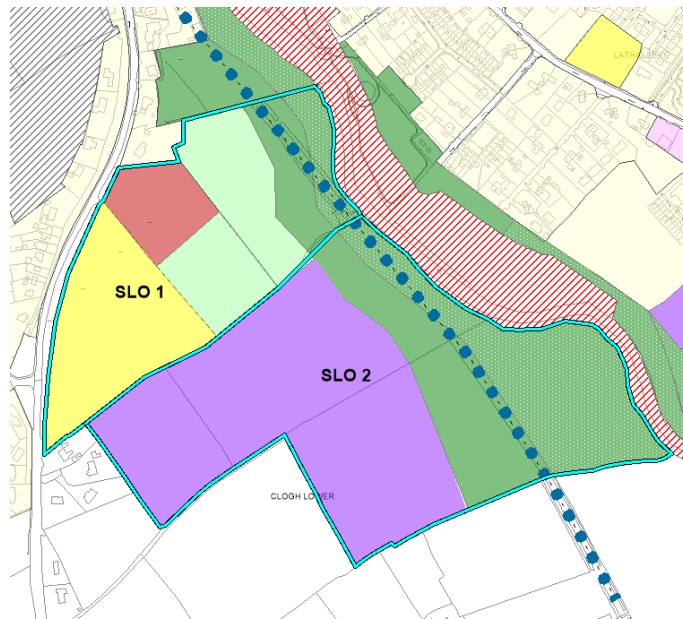

As I set out at the meeting of 29th March 2022, there is a need to bring low cost shopping to Baltinglass, which is a part of Wicklow that is lagging behind in this area in a big way. Hundreds of people leave Baltinglass every week to shop in Tullow, Carlow and parts of Kildare and this facility is needed badly, not only for Baltinglass, but also for the surrounding area.

Several different sites in the town have been examined for this form of retail, but these have

	not progressed. There is an opportunity on this site on the N81 to provide a suitable location for a low cost outlet.
