This month:

€100,000 in Heritage Funding for Local Communities - Wildlife, local economies and tourism in Wicklow are set to benefit from Heritage Council funding for seven individual projects.

The Heritage Council's Community Heritage Grant Scheme will help to conserve and restore built, cultural and natural heritage throughout the county. Work on these projects can begin immediately which will see local communities enriched through initiatives, from making previously unseen works of art available to the public, to equipping local communities with skills needed to protect biodiversity, to making landmarks of national significance accessible again. The projects will all be completed by the end of the year.

The projects to receive funding in County Wicklow include the Glencree Centre for Peace and Reconciliation, the Rathnew Heritage Group, Birdwatch Ireland, the Arklow Town Team, Avoca Parish Finance Committee, Rewild Wicklow and Roundwood and District Historical Archaeological and Folklore Society

'Best Micro Start -Up' Award for Arklow-based Company - Aqualicense, who are supported by Local Enterprise Office Wicklow, were this year's 'Best Micro Start-up' winners at the recent LAMA (Local Authority Members Association) Community & Council Awards.

Aqualicense, is an Arklow based company that provides consultation, planning, legal compliance and project delivery services for firms in the aquaculture and offshore energy industries.

In 2021 Aqualicense expanded their operations into the highly regulated offshore renewable energy sector which has helped the company grow considerably and they are now looking to expand their expertise into new markets internationally.

Established in 2019 by Kate Dempsey the company has gone from strength to strength. Kate firmly believes that any business operating in the marine space can be cognisant of the resultant environmental pressures so that mitigation is built into the initial project planning. This ethos is evidenced by the focus of Aqualicense on marine restoration and sustainability while providing consulting services to the Offshore Aquaculture and Offshore Renewables industries.

Colaiste Bhride wins Film Festival Awards - Colaiste Bhride in Carnew has won the County Wicklow award for the "Rubbish" Film Festival 2023, the first time schools from Wicklow have entered the competition.

Participating schools received two days of training in filmmaking with Createschool who are based at the new film hub on Clermont Campus in Rathnew, with Wicklow County Council sponsored the training. Schools had the challenge to make a short film focussing on climate action, consumption, and the sustainable development goals and to deliver a message visually in just one minute.

In a close competition Colaiste Bhride came out on top with their film called "The Last Drop" exploring water conservation. Temple Carrig School in Greystones were runners up with a film entitled "ReAct" which explored energy conservation and climate.

Schools also produced a film poster and East Glendalough School in Wicklow Town took the prize for best poster for their film "A Matter of Responsibility" which focused on waste management.

Wicklow County Council currently has agreements in place for units in Delgany, Bray, Rathnew, Wicklow, Rathdrum, with delivery ranging from 2022-2024. This includes the units listed above. WCC is in negotiations in respect of over 100 further units with delivery dates yet to be confirmed.

Wicklow County Council is currently holding discussions with a number of developers at preplanning and planning stage. There are over 100 potential Part V units with planning permission but it's difficult to determine whether they will all proceed or even on what timescale.

Affordable Housing

Greenhill Road Affordable Housing Scheme was launched to the public for applications on 09/01/2023, and closed on 30/01/2023. There has been a lot of interest from the public and Wicklow County Council received over 140 applications for the 36 properties. Wicklow County Council are currently 'sale agreed' on all the 36 units, and are having an open day on site for clients on Saturday 22nd April. Breakdown of properties that were available are below.

Wicklow County Council also received approval for future affordable housing schemes in the county in the past month – one development in Rathnew(44) and another in Baltinglass(22), These will be provided directly by the developer. Wickow County Council also has plans for further developments throughout the county.

Croí Cónaithe (Towns, Cities and Rural)

This is a new scheme announced by the Department of Housing, Heritage and Local Government in July 2022. Up to €30,000 grant available for houses which are:

- Vacant for more than 2 years.
- Built prior to 1993.
- Within a town or village (rural houses not covered initially)
- To be used as the applicant's permanent dwelling.

The grant amount can be increased to €50,000 in cases where the building is Dangerous or Structurally Unsound (requires an Engineers Report). Buildings which are currently non-residential (such as vacant commercial units – shops etc) but which the applicant intends to convert to residential use, can also qualify. It is intended to revitalise towns and villages by addressing vacancy and dereliction.

The Croí Cónaithe scheme has been extended in November 2022 to include rural locations also, opening up the scheme to derelict farmhouses etc. There has been a lot of interest in this scheme to date.

Housing Maintenance - Boiler servicing & safety checking campaign

The focus now is on servicing and safety checking of 1416 Oil and 2269 Gas boilers around the county. Contractors are reporting **access rates as low as 60%** which is surprising given the current "Cost of Living" crisis with high fuel costs. It is in tenants' interests to ensure that they provide access to contractors to service and safety check boilers. Oil boilers in particular will consume more fuel if soot build up is not removed at the annual service. Also important checks and replacement of components such as fuel hoses are carried out on oil boilers which prevents expensive loss of fuel and environmental damage which is extremely expensive to clean up. All new boilers fitted now are condensing boilers which have higher thermal efficiency and use less fuel.

The Homeless HAP Place finder provides assistance in:

- > seeking out potential properties suitable for households currently identified as homeless or at risk of homelessness:
- > liaising with specific households to establish their specific needs;
- establishing relationships with local property agents and landlords; and,
- > supporting those homeless households to (a) prevent the necessity to enter emergency accommodation or (b) to exit emergency accommodation and secure a tenancy.
- ➤ To date, 437 households (320 families & 112 singles) have been assisted under the Homeless HAP Scheme in Wicklow County Council from the inception on 1st October, 2018 to 31st March 2023. (184 homeless cases, 242 prevention cases to date and 10 direct provision). 127 properties were sourced by WCC.

Addressing Homelessness in partnership with Approved Housing Bodies

Homeless Supported Temporary Accommodation - Kilmantin Hill, Wicklow

Kilmantain Hill has 11 rooms to support persons either homeless, exiting a higher support facility or in danger of becoming homeless.



There are 10 clients supported in the Kilmantin Hill facility, operated by Dublin Simon, with continuing transition by the clients to suitable, alternative accommodation at the moment.

Homeless Family Service - Fitzwilliam Road, Wicklow

Dublin Simon has been engaged by Wicklow County Council to operate and manage the facility at Fitzwilliam Road, Wicklow as a Family Homeless Service. The building comprises of 3 x 1 bed units 2 x 2 bed units and 2 x 3 bed units — Four of the families have now transitioned or are in the process of transitioning to a permanent home and the resulting vacancies are in the process of being occupied with families experiencing or in danger of homelessness

It is envisaged that families will avail of the service for circa 6 month STA (Supported Temporary Accommodation) with key working support to enable family's transition from homelessness into Homeless HAP or alternative longer term accommodation.

Homeless Supported Temporary Accommodation - San Remo, Bray

San Remo is operated by Dublin Simon, incorporates a service model where there are a number of emergency/cold weather initiative Beds and Supported Temporary Accommodation Beds (STA). There is on site key working support linking in with clients.

The Neighbourhood Liaison Committee is now operational and meets monthly.

Bi- monthly meetings are held with Dublin Simon and Wicklow County Council staff

Homeless Supported Accommodation - Carraig Eden, Greystones

The facility providing 35 ensuite bedrooms with associated kitchens and common areas is fully operational. Wicklow County Council has made arrangements to run an in-reach service with the clients to support them as they continue their journey into more permanent accommodation.

Other Homeless Supported Accommodation

Wicklow County Council owned properties in Wicklow, Bray and Arklow, leased to AHBs, provide 12 units of low to medium supported accommodation targeted to the particular support needs of the clients.

A homeless outreach service has being rolled out in Bray and is proving very successful

Housing First

Peter McVerry Trust has been appointed as the Housing First Programme Implementer for the Mid-East Region. Wicklow County Council is committed to working with them to achieve the targets identified in the programme. Housing first recognises that a stable home provides the basis for recovery in other areas.

Properties will be provided by both Wicklow County Council and Peter McVerry Trust for the implementation of the programme.

Wicklow County Council has, to date, successfully accommodated 14 clients under Housing First and it is hoped that a further allocation will take place before the end of April 2023. Other clients proposed for Housing First have been assessed by the team and are availing of key support work pending finalisation of sourcing of accommodation – the main issue facing this programme is the availability of one bed units in suitable locations with easy access to services etc.

Energy Efficiency

Energy Efficiency Fabric Upgrade Phase 2

All 71 properties given approval for energy efficiency fabric upgrade works in 2022 have been substantially completed. Surveying of the houses identified for 2023 programme is substantially completed.

Ukrainian Response

• As of 9th March, the numbers of Ukrainians Displaced Persons in emergency type accommodation is 1,480 (although we know that there are considerably more in the County)

- WCC are currently assessing all Displaced Ukrainians persons in the County in order to identify their accommodation needs as well linking them in with all the relevant services and supports within the community.
- WCC are working through a list of pledged properties within the County and matching families accordingly. As of the 9th March we will have housed 201 number displaced Ukrainian people into pledged properties Larger buildings and vacant units are also being identified and explored as potential options for medium to long term accommodation.
- A new National Vacant Home call lead by Local Authorities has been launched and is currently in place for a property
 to be pledged directly to Wicklow County Council with a second promotional advertising campaign now running both
 nationally and locally from 4th -25th March. offerahome@wicklowcoco.ie
- The Community Response Forum continues to meet on a fortnightly basis.



2. Community

Launch of Hidden Disabilities Sunflower Initiative in Wicklow



Wicklow County became the first County Council in Ireland to recognise the Hidden Disabilities Sunflower lanyard across all of its public offices and libraries.

The lanyard is intended to alert County staff that the person wearing it has a hidden disability and may need extra assistance with whatever they want to do. People with non-visible disabilities living in or visiting County Wicklow can to collect a Sunflower Lanyard free of charge from any of the public offices or libraries.

The initiative was launched on 3rd April 2023 by Cllr. Tommy Annesley, Cathaoirleach of Wicklow County Council in the presence of Emer O'Gorman, Chief Executive, Wicklow County Council and Michael Nicholson, Director of Services for Community Cultural & Social Development and the elected members of Wicklow County Council. Funding for this initiative was provided by the Department of Rural and Community Development through the Community Enhancement Programme.

Wicklow County Council worked with Triple A Alliance Group and Hidden Disabilities Sunflower Ireland to get the initiative in place. The commencement of the Hidden Disabilities Sunflower initiative in Wicklow County Council is the continuation of the Council being proactive in providing making it easier for the citizens of Wicklow to engage with the Council and to access council services in both public offices and libraries.

Age Friendly Ireland

County Wicklow Age Friendly Strategy 2023-2027

The Age Friendly Programme Manager presented information on the next steps on implementation to the elected representatives at the Wicklow Council Meeting, on 6th March 2023.

The Wicklow Age Friendly County Alliance met on 15th March 2023, to progress the implementation of the **County Wicklow Age Friendly Strategy 2023-2027** and agree on work plan priorities for 2023.



Older People's Council

The County Wicklow Older People's Council Executive met on 24th March 2023, to agree work plan for 2023 and recruitment plan for new members, in advance of the Annual General Meeting of the wider OPC, scheduled for 26th May. The next meeting of the OPC Executive took place on 21st April 2023.

CLÁR

The Department of Rural and Community Development (DRCD) launched the CLÁR Programmes for 2023, on 29th March 2023.

Under the initiative, **grants of up to €50,000** will be provided to support the development of community and sports facilities, youth clubs, playgrounds, sensory gardens, walking tracks and much more.

For the first time under the CLÁR Programme, funding will be provided to carry out upgrades and improvements to spectator stands at local GAA and sports clubs.

CLÁR (Ceantair Laga Árd Riachtanais) or Funding for Small-Scale Rural Projects is a targeted investment programme which provides funding for small-scale - infrastructural projects in rural areas that have suffered the greatest levels of population decline.

Creative Wicklow Grant Scheme

22 applications were received for the Creative Wicklow Grant Scheme. These are currently being assessed and all applicants will be contacted with the panel's decision shortly.

2023 Artist one-to-one Coaching

32 applications were received for the Artist one-to-one Coaching Sessions. 20 artists have been selected and assigned a coach. Each artist will receive three one hour sessions and these will take place between April and September 2023.

Creative Places Baltinglass: Artist Coffee Morning

Wicklow Arts Office invited West Wicklow artists, musicians and creative practitioners to attend an Artist Coffee Morning on Friday 21st April from 9:30 – 11:30am 2023 in Germaine's, Main Street, Baltinglass.

Artists, musicians and creative practitioners of all discipline and experience levels came together to connect with others and find out more about Creative Places Baltinglass.

Visual Artist Training & Lifelong Learning

In partnership with Visual Artists Ireland, Wicklow Arts Office are providing a series of training and lifelong learning sessions for visual artists to include:

3. Socially Engaged Practice webinar led by Áine Phillips, a performance artist based in Galway, exhibiting and performing in Ireland and internationally since the late 80's - Tuesday 9th May 2023

National Poetry Day

Poet Jane Clarke and historian Joan Kavanagh lead a 5 km walk along the Miners' Way from Glendasan to the Upper Lake in Glendalough for a unique outdoor event on Poetry Day Ireland, 27th April 2023.

Blessington Greenway

The Planning application was lodged to An Bord Pleanála on 14th January 2022. A total number of 293 submissions were received by the Bord by the deadline of the 4th March 2022.

The submissions raised were based on the following issues -

- No Toilets 97
- Traffic Lights/Single Lane Traffic on bridges 239
- Parking 94
- Traffic 98
- Lack of Public Consultation 137
- Trees 25
- Fencing 38
- Environment 70

The Bord's decision on the application was due on the 7th July 2022, however this was extended to 25th October 2022. To date no correspondence received from the Bord on the submission.

On 16th of March 2023, a request for further information was received from An Bord Pleanála. WCC staff, in conjunction with Aecom, the consultants, are preparing a response to this further information request received from ABP.

The first Communications Working Group meeting took place on 6th March 2023.

It is proposed to launch a Greenways website over the next few weeks.

Community Recognition Fund 2023

Minister for Rural and Community Development, Heather Humphreys and Minister of State Joe O'Brien, have recently set out the details of the €50 million Community Recognition Fund that has been allocated across all local authorities.

Wicklow County Council is to receive a total of €1,680,887 from this fund.

The funding is specifically targeted at projects that are located in communities, towns and villages which are hosting the Beneficiaries of Temporary Protection and/or International Protection Applicants ("new arrivals") including towns identified



for the rapid build homes programme. It aims to support the development of facilities that will be used in the future by all members of the community.

Among the projects that will be supported are:

- The refurbishment of local sports clubs and facilities
- The upgrade of community facilities such as play areas, walkways, parks and community gardens
- The purchase of equipment to benefit local clubs, festivals, music and arts organisations
- The enhancement of school or parish facilities that are open to the wider community after hours or on weekends
- Transport infrastructure such as community vehicles and bus shelters

The funding will be drawn down over 2023 and 2024 with projects being delivered by the local authorities in conjunction with community organisations.

Feedback on this fund was sought through public consultation, the MD's, the LCDC and Elected Members. By the deadline of the 15th March 2023 a proposal for seven projects (see list below) was submitted to the Department of Rural and Community Development.

Baby Yoga at Blessington Library








Enniskerry Library - Writing and Performing Your First Piece of Poetry






New Library Book Club at Seomra Dunlavin

Economic Development, Planning, and Infrastructure

1. Economic Development

Local Economic and Community Plan (LECP) (Economic)

The Local Economic and Community Plan 2023 – 2029 (LECP) is in the final stages of completion. The purpose of the LECP is to set out for a six-year period the objectives and actions needed to promote and support the economic development and the local and community development of County Wicklow both by itself directly and in partnership with other economic and community development stakeholders.

The LECP will be developed in two sections to allow for flexibility and adaptability:

- 1) Strategy, with the high level goals and objectives for a period of six years
- 2) Implementation Plan, with actions, for a period of two years (renewed every two years)

The Economic and Enterprise Development SPC has the remit for the development of the economic element of the LECP and has held a number of meetings and workshops to achieve this. The LECP is developed from three main elements (i) data and evidence from the socio-economic profile of the county (ii) consultation (iii) national and local strategies, policies and plans. There are five main themes. The objectives and actions are being finalised under these integrated themes:

- Health, Resilience and Well-being
- Enterprise, Innovation and Creativity
- Climate Action
- A Connected County
- Equality, Diversity and Just Transition

Town Teams

Under the Government policy, Town Centres First, the establishment of Town Teams is encouraged, and we are likely to see more Town Teams in situ over the coming years.

Town Teams in Wicklow have been operating since 2016. At present there are four active Town Teams in Arklow, Wicklow, Greystones and Blessington. With the appointment of the Town Regeneration Officer, more Town Teams will be developed in line with regeneration priorities in the county. The future development of Town Teams will reflect the Town Centre First Policy and the review of Town Teams conducted by MCA Consulting. The Town Centre First approach is based on:

Delivering a vision plan for each town



- Building capacity and sharing experience
- Data informed development
- National and Regional funding and structures

Meanwhile the existing Town Teams are involved in projects aimed at the economic, social and cultural development of their towns.

Blessington Town Centre First Masterplan

Blessington has been awarded funding of €100,000 to develop a Master Plan for the town under the Town Centre First policy. This will also allow plans for projects identified as part of the drive to become e-Greenway ready to be advanced.

This initiative is a key part of Our Rural Future – the Government's ambitious five-year strategy designed to reimagine and revitalise rural Ireland. It is also linked to the Government's Housing for All strategy and a key component of the Town Centre First policy.

Wicklow County Council will work closely with local community groups, retailers and members of the Town Team in devising and delivering on the objectives of the Masterplan building on the very comprehensive Health Check carried out by Future Analytics.

Arklow Town Team

The March meeting for members of the Arklow Town Team was held on the 29th March 2023

International Woman's Day March 2023 – International Woman's Day provides an important opportunity to showcase commitment to woman's equality and also to raise awareness. A well-attended lunch was held in the Arklow Bay Hotel to celebrate and the theme "Embrace Equity" #Embrace Equity. Rachel Tyrrell, The Colour Club based in Arklow was the Key note speaker. Rachel is a recent winner of the Innovation Award in the LIFT Leadership Awards. The Town Team were delighted to welcome Emer O'Gorman, New Chief Executive of Wicklow County Council to speak after lunch. Arklow Town Team wish Emer the very best in her new role. Zehila Redmond, a volunteer with the Turkish Relief effort gave an update on the ongoing rescue operations in Turkey and Syria. A raffle was held on the day with proceeds going to the Turkey and Syrian Earthquake relief fund.

The Town Team would like to sincerely thank all who attended the lunch, to local businesses who supported the raffle and to the Arklow Chamber of Commerce who sponsored a table for transition year students to attend.

The Harbour to Headwaters Project – There was a very successful launch of the River Tourism project on the 22nd March 2023. The exciting Biodiversity Trail includes 14 locations across the region from the Harbour in Arklow right up



along the river catchment to the Headwaters of Glenmalure; you can find information panels specific to each of those points on the River network.

An application was made to the Heritage Council Community Scheme for funding to enable enhancements to the Arklow Pottery Website which will include audio recordings of past workers, improved accessibility for visually impaired persons as well as data entry of new patterns. Decision on the application will be due by early April.

Painted Playground Project, Seaview Avenue – A Special launch date will be announced shortly.

Flower Basket Scheme – The Town Team look forward to continuing the scheme for 2023. The Flower Baskets provide beautiful colour and are a welcome addition.

Greystones Town Team

Greystones Town Team CLG last meeting was held on Tuesday 21st March, 2023. Updates were provided from all existing sub groups of the Town Team and a new sub group - Community Well Being and Engagement, is being formed under the leadership of Mags Crean.

There is planning underway to promote the work of the Town Team and to launch a recruitment drive to get a cross section of volunteers participating. Additionally, there will be discussion about a new meetings format and content.

Wicklow Town Team

With the theme "Priming Wicklow Town and Surrounding Areas for Tourism Growth in 2023" Failte Ireland in partnership with Wicklow Town Team will provide a training workshop 2pm to 5p.m on the 19th April in the Bridge Tavern to support local businesses to drive tourism demand and increased dwell time in the area. The workshop will provide an opportunity to come together and explore the delivery of visitor focused collaboration and experiences in line with key motivators identified by the latest consumer research and insights.

With a focus on improving participant knowledge of tourism, the workshop will discuss the benefits a town can reap by working together to complement and cross-sell one another, along with practical marketing tips to support the greater destination sell.

Sparking creative and innovative thinking, businesses will be encouraged to brainstorm a series of collaborative experiences that showcase an enhanced overall visitor experience in Wicklow town, leading to longer stays.



Tourism

Tourism Strategy and Marketing Plan 2018-2022

The current strategy sets out a number of challenging but achievable priorities along with a series of detailed actions to be implemented over the lifetime of the strategy.

The Key Priorities are:

- 1. Develop New Accommodation
- 2. Develop Key Towns as Visitor Hubs
- 3. Develop a Masterplan for Glendalough
- 4. Grow Thematic Experiences
- 5. Market our County by Developing A Common Narrative

Tender documents are being prepared seeking consultants to develop a new Tourism Strategy to replace the current strategy taking into account the changes in tourism post Covid 19 and the focus on sustainable tourism.

Wicklow County Campus Masterplan

The Wicklow County Campus Masterplan will focus on developing Wicklow County Campus as a Centre of Excellence in Enterprise, Education, and Innovation in County Wicklow. Wicklow County Council will use the Masterplan to act as a catalyst for economic development in the county and attract investment and further development.



The project team consists of MOLA Architects as project leader, supported by a team consisting of a Transport Engineer, Landscape Architect, Ecologist, and a Quantity Surveyor.

Stage 1 – Data Collection and Analysis has completed, and the project is now in Stage 2. The project is expected to be complete early in Q3 of 2023.

Abbey Grounds, Wicklow

The purchase of the Abbey Grounds, Wicklow was completed in August 2022 and it is intended that the space will be enhanced and redeveloped into the Abbey Gardens and Event Space, through Destination Towns funding provided by Fáilte Ireland. The Parochial House has been retained by St. Laurence O'Toole Diocesan Trust and a separate entrance way will be provided as part of the redevelopment.

The friary contained within the Abbey Grounds is a Recorded Monument afforded statutory protection under the National Monuments Acts and it is also listed as a Recorded Protected Structure WTC-RPS24 in the County Development Plan 2021-2027.

Following Archaeological investigations in the grounds and the discovery of medieval remains an Archaeological report and archaeological impact statement have been recently submitted to The National Monuments Services.

It is now determined that it will be necessary to consider alternative design proposal for the overall project to ensure the preservation of the burial ground and archaeological remains associated with the Abbey, therefore redesign and procurement of separate items are continuing with the Architect.

Glendalough Masterplan and Wicklow Visitor Orientation Study

Fáilte Ireland, in partnership with National Parks and Wildlife Service (NPWS), the Office of Public Works (OPW), the National Monuments Service (NMS), and Wicklow County Council commissioned Consarc Design Group with a multidisciplinary team to deliver a Visitor Experience and Management Masterplan for Glendalough and Wicklow Mountains National Park and Visitor Orientation Recommendations for Co. Wicklow.

The Consultants have presented the Draft Plan to the Councillors and the consultation period ran from 11th November, 2022 until 18th January, 2023. Following the completion of the consultation period, the final plan will be produced taking account of the feedback received.



Outdoor Performance Space

The letter of Contract Award for design Consultants issued to the successful tenderer on the 30th March. The successful tenderer is Vincent Hannon Architects. Meetings have taken place with Strand Road residents, Royal Marine Terrace and Martello Terrace. Site meetings have taken place with the Design Team, Council officials and representatives from the Mermaid Theatre where the different canopy options were discussed. The project team continue to consult with experts in this industry on the different styles of canopy options available. When the final design is agreed drawings will be prepared and presented to the Members prior to commencing the Part 8 process.

Rural and Urban Regeneration Development Fund Grant Applications

Blessington has been awarded just over €1m funding under the Rural Regeneration Development Fund (RRDF). This will be used for a major regeneration of Blessington Town Centre and related projects. It will be utilised for the regeneration of Blessington Town Centre, the development of plans for public realm works, the redevelopment of a derelict property to create an eHub and a Visitor Centre for the forthcoming Blessington Lakes eGreenway. This strategic funding along with the planned completion of the Blessington Inner Relief Road and the funding for the Blessington Lakes eGreenway will help achieve Wicklow County Council's long-term vision for Blessington and enhance Blessington as a place to visit. Combined with the proposals for developing a Masterplan for Blessington, this project will add to the quality of life of the entire community by optimising digital connectivity, supporting employment and skills and enhancing the public realm in line with the objectives that underpin "Our Rural Future" Ireland's Rural Development policy.

The costings for Baltinglass Gateway to Southwest Wicklow have come in over budget on both the public realm and the Courthouse refurbishment. The proposals have been revised and an application for additional funding has been submitted to the DRCD.

URDF: Urban Regeneration Development Fund

Arklow and Wicklow URDF projects completed. Bray Harbour and Bray Public Transport Bridge in progress (design/planning stage). A non-statutory public consultation in respect of Bray Harbour was held in December.

A 3rd round URDF scheme has just been announced. The purpose of the scheme is to address long term vacancy and dereliction. It is intended that the scheme will fund local authorities to acquire long term vacant/derelict properties for refurbishment/repurposing and to bring them back into use primarily for housing. From the proceeds of the sale of the first round of refurbished properties local authorities will build up a revolving fund for the development of a rolling programme to address long term vacancy in the county



A briefing for the scheme has been held and the initial application for Wicklow has been submitted, including potential sites/buildings and a staffing submission. Some of the URDF team are due to visit Wicklow to review existing projects and details of our application.

It is likely that later in the year there will be a further call for URDF projects along the more traditional lines.

Bray Harbour Improvements

URDF Funding of €7,140,00 approved (75% match funding for total spend of €9,520,000) Consultants RPS appointed July, 2021 to undertake analysis of the terrestrial harbour environment with a view to presenting an options appraisal to complement ongoing marine work.

The requirement for additional environmental assessments was identified in the draft Feasibility Report. RPS was requested to carry out an EIA Scoping Exercise as an add-on to their current engagement. A draft EIA has been received which has been reviewed. A public information day and presentation to the elected members was held on 6th of December, 2022. In line with the EIA Regulations the report was submitted to An Board Pleanala requesting a formal scoping opinion in accordance with Article 95 of the Planning and Development Regulations 2001 (as amended), in respect of this project. The District Engineer is working on the preparation of tender documents to engage Consultants to prepare detailed design and produce contract documents.

Land Management

Wicklow County Council Economic Development Unit are progressing the acquisition of Enterprise Space in Greystones from Cairn.

A tender was published on eTenders to find a property consultant to take approx. 4.7 acres on the Mill Road, Greystones to market and seek proposals to include a hotel, some residential, and possibly some retail/office space. The tender has been awarded to Savills Commercial (Ireland) Ltd. and contracts have been signed and sealed.

Offshore Renewable Energy

The area of offshore renewable energy is rapidly evolving. Due to the number of projects proposed off the coast of Wicklow it is important that the County engages with the process to enable the community of Wicklow to benefit from the opportunities arising while mitigating against any likely impacts that any offshore renewable project will have.

Key milestones have been:

1. The Offshore Renewable Energy Support Scheme Consultation. Wicklow County Council made a submission strongly supporting the case for the funds created as a result of the offshore renewable energy projects to be managed and distributed locally rather than centrally.



- 2. The adoption of the Maritime Area Planning (MAP) Act 2021 aimed at harnessing Ireland's offshore wind potential while protecting our marine environment.
- 3. The Marine Area Consent process is now open for relevant projects, it should be noted that the Arklow Bank Wind Farm, which is Ireland's first offshore wind farm, is at an advanced stage of planning and has been operating under an earlier consent regime. SSE has recently announced its intention to apply for a larger more ambitious project under the new MAC scheme.
- 4. An Bord Pleanála granted planning permission to SSE Renewables to develop the onshore grid infrastructure necessary to connect the 800MW Phase 2 of Arklow Bank Wind Park.
- 5. Codling Windpark has submitted their Marine Area Consent application, this is a very significant milestone in the development of Ireland's largest offshore windfarm.
- 6. Shelmalere Offshore Windfarm (DP Energy Iberdola) has completed consultation on its EIAR
- 7. Bord na Mona Ocean Winds Réalt na Mara Offshore Windfarm has delivered a number of community engagement clinics and is seeking to further engage with the local authority.
- Energia is hosting monthly information clinics in Wexford and South Wicklow in respect of the South Irish Sea Project

The Offshore Renewable Energy Support Scheme (ORESS) Auction opened on 11th January 2023. The Community Benefit Fund (CBF) associated with the ORESS Auction will be significant. The Draft Terms and Conditions of the ORESS and the Rulebook for the CBF scheme have been published. The outcome of the auction will be known in Q2 2023.

In addition, the OREDP II (the Government's Draft Offshore Renewable Energy Development Plan is currently at public consultation stage.

Food and Beverage Strategy

Wicklow County Council appointed James Burke Associates (JBA) to carry out a review of The Wicklow Food and Beverage Strategy 2019-2021 and to develop an Action Plan going forward. The new Plan will build on the original Plan but will also focus on Climate Action and development of the Food Incubation Hub and on Food Poverty. A meeting has been held with James Burke to discuss and review outputs from the stakeholder meeting, to review progress on original goals and actions and to agree steps to final action plan.

An RIDF application has been successful for funding for two days of activities around October Feast to support Agri-Food Tourism in County Wicklow.

Skills Taskforce for County Wicklow

The Skills Taskforce has members from Wicklow County Council, the Training and Development sectors, as well as members representing the Film, Food and Renewables sectors.



A Request for Tender for a Skills Audit and Strategy was published in January. The contract was awarded to KPMG Ireland and contracts will be signed in mid-April. An initial meeting is being arranged in early May with the contractor to agree a methodology, timescales, and outputs.

Broadband Connection Points (BCP) and Remote Working Hubs

A tender will be published in Q2 of 2023 for the development of a marketing plan for all present and future Broadband Connection Points (BCPs) and Remote Working Hubs in County Wicklow, following a grant of €50,000.00 under the Town and Village Renewal Scheme from the Department of Rural and Community Development for this purpose.

Regional Enterprise Innovation Scoping Scheme (REISS)

A Priming Grant of €199,600 has been awarded to Clermont Enterprise Hub CLG from Enterprise Ireland's Regional Enterprise Innovation Scoping Scheme (REISS) for the provision of Architectural Design Services & Project Design Preparation (including Part VIII) for a Food Incubation Development Hub at Wicklow County Campus comprising regional infrastructure of scale for agri-food and drinks SMEs including specialist food production units, co-working innovation kitchens, and scaling and growth support services.

This funding will allow for plans to be primed for the full implementation of the Wicklow Naturally Food Incubation Centre. It will enable the recruitment of a project manager to advance plans for the centre, retention of an architect led design and multi-disciplinary team to prepare plans, appointment of a financial team to complete a business model and a financial analysis review, and the launch of a promotional awareness campaign.

The Wicklow Naturally Food Hub is expected to realise the following benefits within 3 years:

- Build sectoral improvement and smart specialisation with clear and achievable targets:
 - 4 food and drinks production tenants embedded in 4 independent food production units, creating 40 new jobs;
 - Development kitchen for product development, training, and small-scale production enabling 40 new food and drink start-ups to create 80 new jobs;
 - 1500 industry professionals participating in training/networking events;
 - 70 food and drink professionals attending regular networking events;
 - 30 businesses receiving business growth mentoring support;
 - 20% reduction in costs of new concept development for early stage start-ups;
- Facilitate food businesses to grow and develop their business by engaging with students academics and specialist mentors, through SETU and the Local Enterprise Office which are co-located on the Campus, to work on innovation led projects and avail of management capability training.
- Unlock real growth and scale in such a dense area of population as the mid-east region;



 Lever the benefits of affordable food infrastructure close to Dublin to attract new, innovative food businesses to relocate.

Wicklow County Campus is working towards a zero carbon status in the near future through the use of solar energy and biomass heating systems and this will carry forward to the Wicklow Naturally Food Incubation Hub, helping to deliver on the Government's Climate Action Plan 2019 and the European Green Deal plan to build a fairer economy while protecting our planet.

The Food Hub will facilitate the development of scalable, sustainable, and profitable food businesses across the mid-east by providing the physical environment to choreograph opportunities for food entrepreneurs to interact with each other and will support Wicklow food and drink companies to adjust, pivot, or reposition themselves to respond to new market realities arising from Covid-19, Brexit, and other market changes, including climate change/sustainability, innovation, and digital transition.

Local Area Plans

Work has commenced on the preparation on three new LAPs for Greystones – Delgany & Kilcoole, Wicklow Town & Rathnew and Blessington. The team are at the data gathering and surveying stage, and are currently consulting with all internal departments and state agencies. It is intended to start pre-draft plan public consultation in Q3 2023.

Consultants have been appointed to carry out the SEA and AA for these LAPs and they have commenced their preliminary work. All other studies / assessments are intended at this time to be carried out in-house.

Residential Zoned Land Tax

This is a new tax to activate vacant land for residential purposes, and which will in time replace the Vacant Site Levy, was enacted as a part of the Finance Act 2021, as referred to in Circular NRUP 06/2021 of 22 December 2021. The aim of the tax is to activate and bring forward the development of housing on lands which are suitably zoned and serviced, as indicated on maps that have been prepared and published by local authorities for their respective functional areas. These maps were published on Wicklow County Councils website on 01 November 2022. The legislation also sets out certain lands which are to be excluded from the scope of the tax. The tax measure is intended to encourage activation of existing planning permissions on lands which are identified as being in scope and to incentivise owners of suitable lands without planning permission to commence the process of engagement with Planning Authorities.

While residential zonings which include existing dwellings are to be included on the map(s), where connected or able to be connected to services, permanently occupied residential premises which are liable for Local Property Tax will not be liable for the tax. The Minister has issued guidelines under Section 28 of the PDA to provide guidance to planning authorities in the preparation and publication of maps to identify lands in the scope for this new RZLT.

The 'in scope' maps went on display from 01 November 2022 to 01 January 2023, with submissions invited.

Advertisements were placed in local papers and on the local radio station as well as Wicklow County Council social media. 75 submissions were received and all submissions have been published on the Wicklow County Council website. All 75 submissions have been assessed and responded to, before 01 April 2023, with a determination letter as to whether the lands in question are to remain in scope or be removed from the final map.

Built Heritage Capital Funds (Architecture)

34 applications were received to Built Heritage Investment Scheme (BHIS). Following an assessment process 19 projects were shortlisted for the total County Wicklow budget of €101,000 (includes €5,000 for Thatch), and funding has subsequently been confirmed for all projects by the Department. There were 7 applications under the Historic Structure Fund (HSF) grant scheme. Following assessment 5 projects were submitted to the Department and funding allocations have been confirmed for the following 2 projects; Crusher House, Barravore (stream1) €35,000 and Cronroe Gardeners cottage (vernacular) €10,000.

National Biodiversity Action Plan Fund

€100,000 has been made available to each Local Authority from NPWS, Department of Housing, Heritage and Local Government. Funding applications have been submitted. Proposals include the consolidation of existing projects and the development of new theme areas.

Archaeology

The Community Monuments Fund- CMF 2023 is co-ordinated on behalf of Wicklow County Council by the Heritage Office with applications invited by deadline of 27th Jan 2023. Applications received from private landowners, community groups, public authorities and other custodians of archaeological heritage. 11 project applications were prepared and submitted, awaiting outcome of applications.

A public event to highlight results from the CMF 2022 funded LiDAR survey of the Baltinglass Hills has been organised for 13th April @ 7.00pm in association with Coastal Uplands and Heritage Tourism (CUPHAT).

An Bord Pleanala has received an application for permission under section 37E of the Planning and Development Act, 2000 as amended -ABP-309991-21 - Development and operation of an inert landfill facility to backfill the existing quarry to original ground level; progressive restoration of the backfilled quarry to longterm grassland/scrub habitat: establishment and operation of a construction and demolition waste recovery facility; installation and operation of a soil washing plant and all associates site works at Ballinclare and Carrigmore townlands, Kilbride, Co. Wicklow

An Bord Pleanala has received an application for proposed development primarily comprising of the provision of a new 110 KV substation with Gas Insulator Switchgear (GIS) technology and two 110kV underground transmission cables (connecting to existing 220kV overhead lines to the northwest of the proposed substation) along with associated and ancillary works at Bogland, Kish, Cooladangan, Ballintombay, Ballyroonaun and Ballynattin, Co. Wicklow – ABP determined application without an oral hearing.

Substitute Consent

An Bord Pleanala has received an application for substitute consent for the remainder of the development on lands at Ashford, Co. Wicklow - ABP-312283-21 refers.

An Bord Pleanala has received an application for substitute consent for development that consists of a sand/gravel extraction pit including extraction areas, processing areas, stockpiling areas and ancillary works (circa 23.7 hectares). The development also includes a sand/gravel washing/screening plant & buildings comprising workshop/machinery shed, tools storage container, pump – house, 2 no. portable office buildings, 1 no. portable office/canteen/WC, Sand processing plant electrical control room, 3 no. storage containers, sand processing plant electrical control room, 3 no. storage containers, sand processing plant control cabin, bunded oil storage tanks, diesel generator container &



electrical substation (all totalling circa 376sqm) The application is accompanied by a remedial EIAR and remedial NIS. Lands at Ballinabarney North & Bolagh Lower, Redcorss, Co. Wicklow.

E-Planning Project

Work continued on the roll out of the ePlanning system which will go live on 17th April 2023.

The project will include the following elements:

- Standardised naming/structure of all documentation in Local Authorities and An Bord Pleanála.
- Web Portal through which all electronic planning applications and all correspondence regarding same would pass.
- All submissions can be made on-line for both planning application and part VIII applications.
- Fees will be paid online by means of card payment or EFT.
- Part VIII applications for all Local Authorities would be submitted and stored centrally.
- Referrals to all prescribed bodies and the receipt of their submissions would be electronic.
- Electronic transfer of planning files to An Bord Pleanála following an appeal.

The e-Planning system will provide a better service to the public. It will allow agents to build their applications before submission, and will reduce the printing, copying and scanning of documentation. It will also facilitate electronic interaction between Local Authorities, An Bord Pleanála and prescribed bodies. A training webinar issued to all agents in March.

Climate Action

Climate Action Plan

Ministerial Instruction, to enter the statutory plan making phase, was received on 24th February 2023. Wicklow County Council must have the LA CAP complete and adopted on or before the 23rd February 2024.

KPMG has delivered the draft Baseline Emissions Inventory and Climate Change Risk Assessment and will now develop the Summary Report on the Evidence Base. The Summary Report is a key output in these early stages of the process and is produced from the collation and analysis of the evidence base taking policy context into account. The Summary Report will for basis for the stakeholder engagement.

The Climate and Biodiversity Action SPC will meet with KPMG on 5th April for a Question and Answer session on the baseline evidence.



A tender was published to appoint a consultant to carry out SEA/AA through all steps of the process. Closing date for submissions is 12th April.

New posts for the Climate Action Team

The following posts have been advertised and the recruitment process is ongoing:

- Community Climate Action Officer (commencing April 2023)
- Climate Action Coordinator
- Regional Energy Manager appointed.
- Energy Officer

The Climate Action Officer, Biodiversity Officer and the Assistant Environmental Awareness Officer have been appointed.

Mid-East Energy Unit

The inaugural meeting of the Mid East Energy Unit Steering Group was held on 22nd February.

Wicklow County Council has signed up to the SEAI ISO 50001 Accelerator Programme, a year-long programme which will allow the Council to apply for ISO 50001 accreditation.

Wicklow will host the next meeting of the SEAI ISO 50001 Accelerator Programme in April.

Bicycle Parking

Work is underway to identify suitable locations to install bicycle parking at public buildings, car parks and amenities.

EV Charge Point (EVCP) Infrastructure

Wicklow County Council is collaborating with Easy Go to build on the existing EVCP infrastructure in the County. Municipal District Engineers will work with Easy Go to identify suitable locations for installations.

The Green Team is working on a number of initiatives:

- Promoting the SEAI Reduce your Use for energy saving measures.
- Looking into the use of Eco friendly cleaning products for our buildings.

•

Conservation Management Plans

The Bray Head and Clermont conservation plans are in draft format. A walk over tour of Bray Head to discuss management recommendations with key stakeholders is scheduled for 18th April.

Environmental Awareness

- National Tree Week was celebrated from the 20th to the 27th of March. 800 trees were distributed to communities and schools throughout the county.
- Thirteen schools are undertaking composting training funded by Wicklow County Council. The training provides five online sessions with two site visits to each school and will include provision of some tools.



- The 2023 National Spring Clean campaign has been launched with clean up kit provided to groups planning events in their communities.
- A dog fouling campaign was delivered in Greystones, Wicklow and Arklow. Sensor activate audio devices were
 used alongside a social media campaign and enforcement officer visiting popular walking routes to talk to dog
 owners.
- A series of three webinars to explore waste segregation, waste prevention and food waste called Green Hubs commenced, with funding from the Eastern Midlands regional waste management office. We partnered with Sustainable Travel Ireland based in Kilcoole for delivery of the webinars. One initiative incorporated into the second webinar is the promotion of a deposit return scheme for coffee shops. Training was provided on waste segregation and waste prevention.
- An event on Greener Gardening and Ponds for Biodiversity is planned with West Wicklow Environmental Network in Tearmann Garden, Baltinglass. The event was publicized through network contacts and social media.
- The county final was held for the Rubbish Film festival in Clermont with Createschools. The schools participation is funded by Wicklow County Council. Six schools have received training on making a short film from Createschool based in Clermont. Each school submitted their short films on the themes of waste and climate action and a poster. Colaiste Bhride in Carnew won best film with Templecarrig School, runner up and East Glendalough taking the award for best poster.
- The final for the Relove Fashion Competition was held at the Rediscovery Centre with a student from Loreto College picking up the prize for Sustainability, one of five prizes awarded.
- Green Flag assessments are underway in schools with 20 application submitted by the March deadline for applications.

Sustainable Energy Committees

A series of energy awareness days is being planned with Wicklow SECs. Events will show case local suppliers of energy efficiency, renewables and electric vehicles. Wicklow and Arklow are planning event and other towns are considering hosting one also.

Wicklow County Council is working with the Energy Team, Dunleer and several Wicklow SECs to identify householders looking to retrofit their homes and work with them guiding them through the process from start to finish. Six households have undertaken to have a energy audit undertaken of their home with a view to identifying works to be carried out. Greystones SEC is leading on a solar meitheal project which aims to group householders looking to install solar panels on their properties together as one project with the aim of getting a better price while also help to ensure all household get a quality installation. Several SECs are participating.

Work is near completion on the Energy Map Plans, EMPs for High Park. In Arklow survey work is being undertaken.

M11N11 Junction 4 to 14 Improvement Scheme

The Option Selection report was published along with Bulletin #11 on the project website www.n11m11.ie on 14 December 2021. The publication followed the review of submissions received during public display in 2021. Phase 3 Design and Environmental Evaluation was due to commence in Q1 2022. The scheme is currently suspended as no funding was provided to continue during 2022 or 2023. The Wicklow County Council project team are continuing to meet with the public and any interested parties.

M11N11 Bus Priority Interim Scheme

The BPIS seeks to achieve the early delivery of bus priority measures in advance of the main scheme between Loughlinstown Roundabout and Junction 9 (Glenview). The scheme is currently at the Options Selection phase (Phase 2 of TII's Project Management Guidelines).

A non-statutory public display on the emerging preferred option took place in November 2022.

The Option Assessment and appraisal process has identified that bus priority measures are preferred within the following sections of the corridor:

- Sub-Scheme A northbound and southbound Loughlinstown Roundabout to Junction 6 (Bray / Fassaroe)
- Sub-Scheme C northbound only Junction 8 (Kilmacanogue) to Junction 8 (Glenview)

The viability of delivering bus priority within Sub-Scheme B needs further examination to identify the optimum solution to meet the project objectives. This work is expected to build upon the analysis undertaken to date on the N11/M11 BPIS and J4 to J14 Schemes.

The Options Selection Report is being finalised following the completion of the public consultation and consideration of the submissions received. The final Options Selection Report is expected to be published in 2023

The public consultation information is available to view on the BPIS project website www.n11m11bpis.ie. This website will provide up to date information on the progress of the scheme.

N11 Parallel Service Road at Kilmacanogue

A noise assessment for the 7 no residential properties to the east of the new Parallel Service Road Scheme was carried out during April and May 2022. The options review and design commenced in March 2023 following confirmation of funding from TII

N81 Knockroe Bend Realignment

Tenders for a Per-Cent Art Feature are being procured by the Arts Office. The preferred feature has been selected pending the completion of the final assessment stage.

N81 Irishtown West, Whitestown Lower, Hangman's Bend and Tuckmill Lower "N81 Four Studies"



Following completion of Transport Infrastructure Ireland (TII) Phase 1 feasibility studies (N81 Four Studies – Feasibility Report), Wicklow County Council will now look to progress the following two projects:

- · N81 Whitestown Lower Project; and
- N81 Hangman's Bend and Tuckmill Project.

Technical Consultants have been appointed to undertake planning and design services under TII Project Management Guideline Phases 2 to 4 (inclusive).

N81 Pavement Capital Works

Resurfacing works of 1km of the N81 between Tuckmill and Saundersgrove is expected to be carried out in 2023.

N81 Rural Traffic Calming & Bus Stop at Hollywood

Option selection and design work is currently ongoing. TII have provided funding for this study.

N11 Pavement Resurfacing Works

N11 surfacing works between junctions 7 and 16 will be carried out by the N11 maintenance contractor over the period from May to September 2023. A traffic management plan will be in place and works will be carried out at night to minimise traffic disruption.

Arklow Public Realm

Parade Ground Public Realm works has substantially been completed and snagging of the project has also been completed. The project is now in the 12month defects period.

Arklow to Shillelagh Greenway

The route options continue to be revisited for a few sections of the proposed greenway route with updated ecological surveys just having been completed on those sections. Work continues is preparing documents and report to identify the emerging preferred route for the Greenway. It is currently planned to hold a public consultation on the emerging preferred routes in Q2 of 2023.

Baltinglass Town Centre Plan

Additional funding is required over and above the original allocation and reports have been prepared and submitted to aid those discussions. Consultants to proceed with preparation of documents for the delivery of a revised tender package for reduced scope town centre works, and undertake a value engineering exercise on this element of the project to bring the scheme within the current budget limit.

Blessington Inner Relief Road

Currently detailed design along with the preparation of associated documents including the preparation of the CPO documentation is ongoing to allow the scheme to proceed to statutory approval. As the project may impact on the Poulaphuca SPA, a Natura Impact Statement (NIS) is required to be prepared. Statutory approval will be sought from An Bord Pleanála.

Wicklow County Council Compulsory Purchase (Chapel Road Pedestrian and Cycle Infrastructure Improvement Scheme) No. 1 Order 2021

Consultants continue to proceed with the detailed design with the preparation of the tender documents.

Redford Junction

Work has commenced in the preparation of detailed design and the preparation of tender documents to allow the project to proceed to construction.

Winter Maintenance

The winter maintenance season commenced on the 15th October 2022 and will continue until the end of April 2023.It was cold on the first half of the month of March turning milder for the latter half of the month. Consequently salting of routes occurred on 10 nights in the last period with 98 individual routes salted. Salt stocks are being continuously replenished by our own WCC fleet.



No issues to report as season draws to a close.

Wicklow Greystones Greenway

Wicklow County Council has just recently appointed consultants to this project. The consultants have commenced work on the project which includes data gathering and are arranging for detailed environmental surveys to be done which will feed into the of development of the routes options study. Meeting with Irish Rail took place regarding the East Coast Railway Infrastructure Protection Programme (ECRIPP), data sharing between both projects agreed. Meeting with NPWS to be scheduled.

Blessington eGreenway

Planning documents under Section 177AE of the Planning and Development Act were lodged with An Bord Pleanála with the end date - 4th March 2022. On the 16th March 2023, An Bord Pleanála made a request for further information, response to be with ABP by the 8th June 2023. Work has commenced on the preparation of the response to the further information request.

Bridge Rehab Works:

The Bridge crew is currently completing parapet repairs the to a section of damaged parapet at Kippure Bridge. New foundations on some sections of parapets were also required. Rubbing strips to be installed as last phase of works at ground level. Further works on scour repairs to take place later in the summer

A VRS was installed at this St Kevin's Poole Bridge, Wicklow Gap to bring it up to standard.

Remedial works finished at Sally Gap Bridge to remove dangerous cladding.

Removal of vegetation to be carried out on a number of bridges around the County to ascertain their condition. Bat surveys continuing as required

Repairs to the parapet have been carried out to the Balamise and Kilbride Bridge. Re-building of part of the parapet and installation of rubbing strips were completed at Ballyderry Bridge. Some small scour works were completed as well

DDTAS approval for Bridge Rehab works were finalised by Fed 2023.

Machinery Yard:

Working with the WCC Climate team in relation to installing EV chargers across the County alongside a commercial operator. Proposed locations have been agreed with MD staff, but are subject to change depending on ESB Network supply at the proposed location.

A review of contract details to take place as soon as possible with all involved.

These additional EV chargers, alongside the EV chargers installed in 6 WCC depots across the County would leave the EV infrastructure in Wicklow in a really good place.

From this, WCC would hope to replace some of its existing fleet with Electric Vehicles in 2023. We have seen from EV trials that WCC daily operations would be affected if the EV charging infrastructure is not in place.

We will be looking at replacing some of the larger pick up fleet also in 2023 as part of a replacement plan. 2 large trucks have been added to the fleet to replace older vehicles. These trucks are ex Fingal County Council trucks will form an important part of the Winter Maintenance fleet.



These trucks are currently getting fitted with Romaquip gritters, which have been up graded to be brine capable machines which forms part of the plan to switch to a pre wet process in some Municipal Districts.

Working with TII and DTTAS on seeking funding for Brine station installations. Hopefully approval to be given very soon to proceed.

We are currently looking to trial HVO (Hydrated Vegetable Oil) in some vehicles, as a substitute to diesel. HVO has a much lower CO2 footprint than diesel but it is currently more expensive to buy. Trial to commence late April/ early May

Working with Pro-Works and a number of other LA's on a Fleet Maintenance system for the Machinery Yard, as part of compliance with RSA regulations. Progressing with the Pro Works system in order to reduce number of systems being used.

Surface Dressing-

Preparation for season ongoing. Season to start early June.

Tenders completed for Traffic management and Supply of Chippings for the County. Surface Dressing team being put in place at present.

Health and Safety Plans currently being signed off by each MD.

Calibration of sprayer to take place in late April in Colfix, with remainder of plant to be services as soon as possible.

Active Travel Updates - April

Recently Completed Projects

Footpath Improvements Valley Heights, Carnew (Baltinglass MD)

This scheme provides 161m of upgraded footpaths (including public lighting) along the L-72274 between Valley Heights Housing Estate and Carnew National School.

Projects Under Construction

Glenart pedestrian link (Arklow MD)

Pedestrian accessibility link improvements at the rear of the Woodlands housing development located between Lamberton and Glenart. The works will involve the construction of a pedestrian access ramp and the installation of public lighting along the scheme. Works are progressing with the lighting completed. Updated design required due to on site issue. Works should be completed by the end of May.

Arklow North Cycle and Pedestrian Scheme (Arklow MD)

The design of cycle and pedestrian facilities on the R-772 Dublin Road. The scheme involves construction of a footpath and segregated cycle facilities on the R-772 between the M11 Junction 11. Works are progressing well on site, with cycle track on southern side completed as far as Park & Ride entrance. Project is due to be completed by May.

Ashford to New Developments footpath (Wicklow MD)

Improve pedestrian facilities along the R-764 by widening the footpath and upgrading the public lighting. Progressing well, with retaining wall and stone facing complete. Accommodation works and footpath to be completed. The project will be completed by May.

Arklow South Cycle and Pedestrian Scheme (Arklow MD)

Provision of 2.8km of segregated cycle track along the R-772 Wexford Road, Arklow between Knockmore Roundabout and M11 Junction 21. The scheme will also construct 1.4km approx. of pedestrian footpath. Initial works began in



January 2023, with clearing of the verge. Lighting and drainage nearing completion on eastern side. Accommodation works to commence.

Bellevue Junction Improvement works in Delgany (Greystones MD)

Upgrading of the junction of the R-762 and Bellevue Hill. The project will improve pedestrian accessibility and safety and enhance village centre aesthetics by widening and landscaping the paved pedestrian areas, upgrading public transport facilities, undergrounding services, and upgrading public lighting. Works are ongoing.

Kilcoole Road Pedestrian and Cycle Improvements (Greystones MD)

Provision of 500m of new footpath and 500m of cycle track along the R-761. Works commenced on site this week by the in-NTA deliverables team will be completed in three sections/phases. Works are nearing completion in phase one, with footpath construction ongoing.

Consultations

Killincarrig Village Enhancement Scheme (Greystones MD)

Public consultations closed on Monday 30th January. Nine submissions were received, and a report is being prepared, with a meeting to be scheduled with the resident's association.

Arklow Transport Study (Arklow MD)

Public consultations on the transport study for the Arklow area closed on Monday 30th January. In total, 452 submissions were received. Reports are currently being prepared by consultants.

Greystones Local Transport Plan (Greystones MD)

Completion of a Transport Study for the Greystones area. Baseline assessment carried out, with options assessment ongoing. Presentation made to councillors on options being considered.

Project Updates

Bray Dart Interchange (Bray MD)

New plaza and public transport interchange in front of Bray DART station, with revised car parking, set down and taxi rank arrangements. Tender advertised for contractors on Friday 7th April, with a return date of 15th May.

Safe Routes to Schools: SS Michael and Peter Junior School and St. John's Senior National School, Arklow (Arklow MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. Preliminary designs which were presented to Elected Members at the April municipal district meeting were met with positive feedback. Next steps will involve proceeding to detailed design, with a view to move to construction in July.

Safe Routes to Schools: Kevin's National School, Greystones (Greystones MD)

Provide infrastructure for schools to increase walking and cycling as the preferred travel mode where possible and improve safety at front of schools. Preliminary designs will be presented to Elected Members at the April district meeting.

LAMA All Ireland Community and Council Awards 2023

The Saville's Cross Junction Scheme in Rathdrum – which involved the construction of a mini roundabout, traffic calming on entry, upgrading of the pedestrian facilities on all arms of the junction, 250m of footpath improvement with



public lighting along the R-752 and R-755 – was one of five projects shortlisted for the Best Community Transport Initiative award. While it didn't win, the nomination was testament to the benefits of the scheme.

There were **94 incidents** attended during the month of March 2023. Due to laid down procedures to mobilise two stations to potentially serious incident types, individual Fire Stations were mobilised on a total of **111 occasions** including 6 mobilisations in other counties. On no occasion did an incident commander request additional resources over what was prescribed in the Pre-Determined Attendance.

Operational activity for the month of March 2023 **decreased by 15% (19 mobilisations) on the preceding month** (February 2023: 130 mobilisations). While there was an increase in mobilisations to certain incident types: domestic fires (+5), RTCs (+4), Garda assists (+3) and alarm activations (+3); there were reductions in malicious urban fires (-14), mobilisations to other counties (-10), gorse fires (-5), vehicle fires (-5), commercial fires (-4), chimney fires (-4).

Operational activity for the month of March 2023 was the same as the equivalent month in 2022 (March 2022: 111 mobilisations). While there was an increased number of mobilisations to RTCs (+4), entrapments (+4) and false alarms (+3); there was a decrease in gorse fires (-12), commercial fires (-5) and domestic fires (-4). For the first 3 months of the year activity is up 5% on the average for the same period in the preceding 4 years.

General

- A campaign to highlight the dangers and numbers of maliciously started fires close to urban areas on radio, newspapers and social media contributed to a 50% reduction in this type of incident month on month, down from 28 to 14 across the county.
- A 3 Week QQI Firefighting Skills (recruit) course delivered in Bray Fire Training Centre finished on 10th March. The course included 4 students from Wicklow Fire Service. Bray (1), Blessington (2), Dunlavin (1).



- One Senior Officer attended MEM training during the month in conjunction with the two other Principle Response Agencies.
- One instructor from Wicklow instructed on a NDFEM Pump Instructors course (1-week) in March and Wicklow County Fire Service also had one Station Officer participate on the course and is now qualified as an instructor.
- Meetings took place with organisers of a number of large outdoor events scheduled during the summer including the Kaleidescope festival Russborough, Beyond the Pale Glendalough House.
- Preparation for forecast severe weather took place from 8th March which saw an increased response to RTCs due to poor road conditions.

Building Control continues to experience high construction activity & in particular completion of units since the beginning of 2023. 107 new residential units in were notified to LA for Commencement & 104 newly completed residential units plus 112 new completed apartment units were submitted, assessed and validated in March.

Building Control continued with site inspections in March to identify non-compliances with Building Regs onsite and 7 No. Section 11 Compliance Requests were issued.

Revised Information requests were high in March for both Commencement Notices and Certificates of Compliance on Completion, 74% of Commencement Notice submissions & 57% of Certificate of Compliance on Completion submissions required revised information. It should be further noted that some Opt Out Submissions are requiring 2 to 3 Revised information requests which results in submissions being assessed 2 to 3 times to ensure compliance prior to commencement.

Opt Out submissions are both extensions and single unit dwellings, generally from BCMS users who are unfamiliar with both BCMS and Building Regulations which leads to Building Control resources being directed to resolving both administration and technical issues with Opt-Out Submissions. NBC&MSO Quarterly Newsletter dated September 2022 has requested LA's to focus resources on compliance with Building Regulations in Opt Out Submissions, Wicklow

Building Control continue to perform rigorous assessment of submissions at commencement stage and onsite presence during constructions. These methods remain the best way to promote compliance with Building Regs.

Building Control staff attended the Annual IBCI Conference on the 29th & 30th March in Athlone. This conference included lectures from representatives from NBCO, Senior Building Standards Advisors from Dept. of Housing and industry professionals. Building Control staff also attended the 1st quarter Eastern Regional Building Control meeting in March.


